## TOWN WARRANT.

### THE STATE OF NEW HAMPSHIRE.

[L. s.]

To the inhabitants of the town of Salisbury, county of Merrimack, in said state, qualified to vote in town affairs:

You are hereby notified to meet at the town house, in said town, on Tuesday, the twelfth (12th) day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary town officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.

3. To see what sum of money the town will vote to raise and appropriate for the repairs of highways and bridges, and

4. To see what action the town will take with reference to payment for the new iron bridge erected across the Black-water river.

5. To see what sum of money the town will vote to raise and appropriate for permanent improvements of its highways under chapter 35, laws 1905.

6. To see if the town will vote to raise and appropriate money to procure a snow roller for the North Road District, agreeably to petition of Sidney F. Eastman and others.

7. To see if the town will vote to sell the standing lumber on the town land on the plains.

Given under our hands and seal the 21st day of February, in the year of our Lord nineteen hundred and seven.

STATEMENT RELATING TO STATE AID FOR HIGHWAYS IN TOWN OF SALISBURY.

Under chapter 29 of the Laws of 1899, towns are required to raise one fourth of one per cent of their valuation for maintenance of roads, provided, however, that no town is required to raise an amount exceeding \$50 per mile of road. The valuation of the towns for 1907 and the actual mileage of roads in each town cannot be definitely stated at this date, hence the amounts opposite "A" and "C" below are approximate only.

Subject to the above statement, the following amounts relate to the above-named town:

A. Amount required to be raised under the law of 1899, one fourth of one per cent	\$775.27
B. Additional amount if town applies for state aid .....	155.00

C. Total minimum amount required to be raised for highway purposes if town applies for state aid .....	\$930.27

If no application for state aid is made in 1907, the town is required, under section 3 of chapter 35, Laws of 1905, to set apart and expend for permanent improvement the sum of \$310.

If the town does apply for state aid under the above-mentioned law of 1905, a joint fund for the town is formed, the items of which are as follows:
