

## Town Warrant

### STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Seabrook,  
qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said town, on Tuesday, the tenth day of March, next, at ten of the clock in the forenoon, to act upon the following subjects:

Article 1. To elect a town clerk, one selectman for three years, town treasurer, collector of taxes, three constables, highway agent, three overseers of the poor and all other necessary town officials for the year ensuing.

Article 2. To see what sums of money the town will vote to raise for the expense of the general government, for the protection of persons and property, for health and sanitation, for highways and bridges, for the support of the town poor and all other necessary expenditures for the year ensuing.

Article 3. To see if the town will vote to authorize the selectmen to borrow money in anticipation of taxes, and renew and refund town notes and to fix the rate of discount on taxes.

Article 4. To see if the town will vote to raise the sum of seventy-five (\$75) dollars for the observance of Memorial Day.

Article 5. To see what sum of money the town will vote to raise for the observance of Old Home Day and to appoint committees for same.

Article 6. To see if the town will vote to raise the sum of three hundred and fifty (\$350) dollars to defray the expenses of collecting garbage from the residents of Seabrook Beach, the same being left in the hands of the health officer.

Article 7. To see what sum of money the town will raise and appropriate for the repair of that part of the U. S. Mail Route Road between the Hampton Falls town line and the Kensington town line.

Article 8. To see if the town will vote to raise the sum of two hundred and fifty (\$250) dollars to be paid the Tax Collector for his services.

Article 9. To see what sum of money the town will raise and appropriate for fire equipment.

Article 10. To see if the town will raise and appropriate the sum of \$500.00 for the repair of that part of the U. S. Mail Route road between Fogg's Corner so-called and the top of New Zealand Hill.

Article 11. To see if the town will vote to pay the First Selectman (\$250) two hundred and fifty, the Second Selectman (\$200) two hundred dollars the Third Selectman (\$200) two hundred dollars for their yearly services, and that this salary shall cover all their expenses and services for the town annually.

Article 12. To see what action the town will take in regard to oiling the town roads.

Article 13. To see what action the town will take in regards to resident property deeded to town for non-payment of taxes.

Article 14. To transact all other business that may come before said meeting.


