



Center on Rural Addiction

NH CHI in partnership with the University of Vermont (UVM) and the Center on Rural Addiction (CORA) strives to evaluate and improve the care of persons with substance use disorder (SUD) in rural areas of NH, ME, VT, and northern NY by:

- Collecting, analyzing, and publishing results from the <u>NH Baseline Needs Assessment</u>
- Delivering **personalized technical assistance** (education and physical supplies) to rural practices and community organizations in NH
- Planning SUD ECHO for 2022 launch







Trauma-Informed Care **Practice Guide** and **Handbook**



The NH Pediatric Improvement Partnership (NHPIP) released two new resources to support pediatric primary care practices in building family resilience and addressing adverse childhood experiences (ACE). Learnings captured in these reports were derived from a QI implementation project funded by The New Hampshire Children's Health Foundation. Five clinics from geographically diverse areas of NH were guided through a 15-month press to integrate ACEs screening into care delivery. Each clinic set up a project team that met monthly with a project coach, developed a screening workflow, received training and consultation, met with key community referral sources, and engaged in PDSA cycles to refine their process. Funding was renewed through 2024 to continue this important work.

<u>A Guide to Trauma-informed Pediatric</u> <u>Primary Care</u> provides a step-by-step process for clinics to develop and pilot a customized ACEs screening workflow, integrating principles of traumainformed care.



<u>Facilitating a Quality Improvement</u> <u>Approach to Childhood Adversity</u> <u>Screening in Primary Care: A Handbook</u> provides a guide to replicating work done in five New Hampshire practices to screen and respond to ACEs and strengthen family relationships.

Partnering with UNH Extension to Address the Challenges of Chronic Pain in Rural NH

The <u>Chronic Pain Self-Management Project ECHO</u> Series established a telehealth learning community to equip **rural** health care and community professionals with skills and strategies to assist individuals with selfmanagement of chronic pain to reduce the risks of opioid misuse.

The need for this series was established through a comprehensive <u>assessment</u> and planning study conducted by the New Hampshire Citizens Health Initiative at the University of New Hampshire (UNH) Institute for Health Policy and Practice.

The report speaks to the use of Project ECHO in working to assure a healthy NH making sure that all the state's residents can get the right care at the right place and right time.








UNH Franklin Pierce School of Law and the Institute for Health Policy and Practice hosted a session with three national experts to discuss:



The Institute for Health Policy and Practice continued to provide technical assistance to NH's State Opioid Response Team. Projects included, but were not limited to:



NH 988 Pre-Launch Planning to Post-Launch Implementation

IHPP partnered with NH DHHS to support the planning for the launch of 988, the new, national Suicide and Crisis Lifeline number. We convened a multi-disciplinary, cross-sector stakeholder group to develop goals and action to support the roll out. This work advanced NH's vision of an improved crisis system that supports the three pillars of crisis response: someone to call, someone to respond, and somewhere to go. This process focused on data-driven decision making and centering the voices of lived experience to improve crisis response in New Hampshire.

Since 2003, IHPP has contracted with the NH Division of Public Health Services to staff the role of the State Maternal and Child Health Epidemiologist.
