WARRANT FOR TOWN MEETING TOWN OF MADBURY, N. H.

March 2, 1976

To the inhabitants of the Town of Madbury, County of Strafford, and the State of New Hampshire, Qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Madbury on Tuesday, the 2nd of March, A.D. 1976 at 7:30 o'clock in the evening to act upon the following articles.

The polls will be open from 1:00 p.m. to 9:00 p.m. for voting by ballot on Article 1 and Article 2.

ARTICLE 1. To choose the following Town Officers:

- A town clerk for the ensuing year.
- A selectman for the ensuing three years.
- A treasurer for the ensuing year.
- A collector of taxes for the ensuing year.
- Two auditors for the ensuing year.
- A trustee of trust funds for the ensuing three years.

ARTICLE 2. To vote on amendments to the Zoning Ordinance as listed on the official ballot.

ARTICLE 3. To choose all other town officers.

ARTICLE 4. To see if the town will vote to authorize the selectmen to borrow up to the sum of \$40,000.00 in anticipation of taxes.

ARTICLE 5. To see if the town will vote to raise \$344.19 for Class IV and V highways to match the sum of \$2,294.60 to be contributed by the State.

ARTICLE 6. To see if the town will vote to authorize the transfer from the Capital Reserve Funds, Improvement of Class V Roads, the amount of \$3,000.00 to be used as necessary by the State of New Hampshire, to complete the surfacing of Freshet Road.

ARTICLE 7. To see if the town will vote to authorize withdrawal from Revenue Sharing Funds, established under the provision of the state and local Fiscal Assistance Act of 1972, the amount of \$3,000.00 to be used for town mapping purposes as follows:

- \$1,000.00 for preparation and purchase of necessary current supplies
- \$2,000.00 to be deposited in Capital Reserve Funds for town mapping purposes.

ARTICLE 8. To see if the town will vote to use \$2,300.00 from the current surplus to pay off the note of \$1,500.00 issued in 1975 for the purchase of a fire truck, and to pay for the bills incurred for equipment and supplies for the new truck.

ARTICLE 9. To see if the town will vote to authorize the withdrawal from the Revenue Sharing Fund, established under the provisions of the state and local Fiscal Assistance Act of 1972, for use as setoffs against budgeted appropriations for the following priority purposes:

Fire	\$1,000.00
Highway Maintenance	\$3,000.00

ARTICLE 10. To see if the town will vote to authorize withdrawal of \$3,000.00 from the Revenue Sharing Fund, established under the provisions of the state and local Fiscal Assistance Act of 1972, for the purpose of establishing a system of waste disposal.

ARTICLE 11. To see if the town will raise and appropriate the sum of \$612.00 as its share for the Strafford Regional Planning Commission.

ARTICLE 12. To see if the town will vote to authorize the Fire Department to go to the aid of another city, town, village or fire district within or without the state, for the purpose of extinguishing fires therein, as provided in RSA 154:24.

ARTICLE 13. To see if the town will vote to authorize the selectmen to sell the International fire truck chassis.

ARTICLE 14. To see if the town will vote to express sincere appreciation and thanks to the following children of the late John U. and Alice Boody; Mr. and Mrs. Cecil W. Boody, Mr. & Mrs. S. Pulsifer, Mr. & Mrs. Harry J. Bennett, Mr. & Mrs. Leon Boody, Mr. & Mrs. Daniel Hill, and Mr. & Mrs. Ralph J. Boody for the gift of the fence enclosing the site of Boody Rock and adjacent burial plots, located in the wooded area of DeMerritt Park.

ARTICLE 15. To see what action the town will take on the proposed budget for the current year.

ARTICLE 16. To hear the reports of committees chosen, and pass any vote relating thereto.

ARTICLE 17. To transact any other business that may legally come before the meeting.

March 4, 1975

To the inhabitants of the Town of Madbury, County of Strafford, and the State of New Hampshire, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Madbury on Tuesday, the 4th day of March, A.D. 1975 at 7:30 o'clock in the evening to act upon the following articles.

The polls will be open from 1:00 p.m. to 9:00 p.m. for voting by ballot on Article 1 and Article 2.

ARTICLE 1. To choose the following Town Officers:

Town Clerk for the ensuing year, Lucile D. Hutchins.

Selectman for the ensuing three years, Paul Raynes.

Treasurer for the ensuing year, John Printy.

Collector of Taxes for the ensuing year, Diane Hodgson.

Two Auditors for the ensuing year, Barbara Houston, Edna Twombly.

Trustee for Trust Funds for ensuing three years, Alfred Grimes.

ARTICLE 2. To amend Article IX. Board of Adjustment.

Section 1. Part B. Change to read: B. Grant a special exceptions in the General Residential and Agricultural District to accommodate commercial enterprise compatible with the existing neighborhood and following Non-residential Site Review approval by the Planning Board. Passed. Yes - 82 No - 30

*ARTICLE 3. Voted that the Selectmen choose and appoint all other Town Officers.

ARTICLE 4. Voted to authorize the Selectmen to borrow up to the sum of \$40,000.00 in anticipation of taxes.

ARTICLE 5. Voted to raise the sum of \$348.24 for Class IV and V highways to match the sum of \$2,321.60 to be contributed by the state.

ARTICLE 6. Voted to raise and appropriate the sum of \$400.00 as our proportionate share for the Oyster River Youth Association.
By ballot 71 Choice 36
Yes – 36 No – 9 Carried.

ARTICLE 7. Voted to authorize withdrawal from Revenue Sharing Funds, established under provision of the state and local Fiscal Assistance Act of 1972, in the amount of \$2,000.00 for the purchase of asphalt to be used for sealing town roads.

ARTICLE 8. Voted to authorize the withdrawal from Revenue Sharing Funds, established under provision of the state and local Fiscal Assistance Act of 1972, in the amount of \$4,000.00 to be used for repairing the Town Hall. Amended by motion of Eileen Corrow from the sum of \$2,000.00 to \$4,000.00.

ARTICLE 9. Voted to authorize the withdrawal from Revenue Sharing Funds, established under provision of the state and local Fiscal Assistance Act of 1972, in the amount of \$2,000.00 for the purpose of purchasing fire apparatus.

ARTICLE 10. Voted to raise and appropriate the sum of \$467.00 as our proportionate share to the Strafford Regional Planning Commission.
By ballot 70 Choice 36
Yes – 52 No – 18 Carried.

ARTICLE 11. Voted to accept \$2,000.00 plus any interest gained at the time of transfer, from the Madbury Bicentennial Committee to create a trust fund in the memory of Eloi A. Adams and Charles Jennison, the interest to be used as needed to help citizens maintain the memorial dedication area and adjacent wooded area of DeMerritt Park, and the principal to be used

only for capital improvements consistent with the terms of the gift to the town of DeMerritt Park made by deed Miss Jennie M. DeMerritt, August 1934, recorded in Strafford County Registry of Deeds, Book 460. Page 81.

ARTICLE 12. After Article 12 had been put on the floor for discussion the Moderator made a motion to amend. It was moved that the Town vote to rescind the vote passed under Article 7 in the 1974 Town Warrant authorizing the transfer of \$5,000.00 from Capital Reserve Fund and the issuance of the 2 notes of \$2,000.00 each. Approved.

ARTICLE 13. Approved as amended additional \$1,000.00 for fire truck bid.

\$31,673.24 amended to add \$3,867.00

Total budget for 1975, \$35,540.24.

*ARTICLE 14. Joan Schriber moved to have this Article taken up after Article 3, which was done. Resolution 2 was reported by William Morong. Report was accepted and it was voted to continue the Committee for the year 1975.

Resolution 3. reported by Lorraine Morong. It was moved to accept report and continue the Committee. Amended to increase Committee to 7 and include one Selectman. Added Jere Chase and Harry Cheney.

ARTICLE 15. Standing ovation to Kenneth S. Morrow for his 30 years service as Moderator, and to Joseph Cole for his 25 years as Selectman. Paul Raynes was hospitalized.

Mrs. Elizabeth Shames spoke on the use of the Town Hall as a Youth Center.

It was moved that the moderator appoint a committee to assist the Selectmen in determining what improvements may be needed and in developing policies and regulations for the usage and management of the Town Hall consistent with the findings of the Selectmen and Committee. Appointed to this Committee, Eileen Corrow, Mark Remick, Willard Sanders, Dorothy Wentworth.

Eileen Corrow made a motion on Town Hall policy. Voted in the affirmative.

Robin Hayes spoke on bicycle clinic by 4-H in April. Jesse James made a motion to have Selectmen appoint a Bicentennial Committee for 1976.

Madbury Extension Group will have a family day at the Park, July 4, 1975 from 9:00 a.m. to 3:00 p.m. Chairmanned by Mrs. Pamela Seaver.

David Olson spoke on restoring carriage sheds at the Town Hall.

Robert Houston spoke on work of Planning Board. Robert Sheeran and Mary Ellen Duffy appointed to Board.

Invocation was given by T. Willard Hunter.

Water Board to meet March 27, 1975 at the Town Hall, 7:30 p.m.

Adjourned at 10:20 p.m. for purpose of counting Articles 1 and 2.

Town Meeting adjourned at 11:10 p.m.

OYSTER RIVER HOME HEALTH ASSOCIATION

Since its inception in 1967, the Association has grown from one nurse serving three towns to the present staff serving four towns (Durham, Lee, Madbury and Newmarket): Linda Gill, RN, Administrative Nurse; Mary Ellen Norcross, RN, full time nurse; Suzann Griffith, RN and Brenda Jackson, RN, part time nurses; Gail Childs, Bookkeeper-Secretary and Lillian Charron, RPT, Physical Therapist. The Board of Directors consists of five representatives from each town and standing committees include representatives from related professional fields.

Widest growth this past year has been in the field of Maternal and Child Health. Our Child Health Clinic meets the third Monday of each month above the Newmarket fire station and attendance has been particularly large this year. We continue to have our Dental Screening Program at six month intervals, started last year. This seems to have a firm basis now and we offer the service to all children enrolled in the Child Health Conference who are between ages of three and six.

On the Current Executive Committee is William Prince, President; Mrs. Roy Kent, Vice President; Mrs. Russell Harmon, Secretary; Dr. Everett Sackett, Treasurer; and Mrs. Eleanor Evans, representing Madbury.

MADBURY FIRE DEPARTMENT

The Madbury Volunteer Fire Department completed its 28th year of service to Madbury.

The problem of providing 24 hour coverage, 365 days a year, remains very much the same over the years. It remains a problem of maintaining report among a nucleus of men who will keep a department alive and able to respond to emergencies. Madbury is fortunate in having such a group with the ability to build and maintain equipment. This was clearly demonstrated when a recent model chassis became available to us this past fall.

With the approval and encouragement of the selectmen, the chassis was purchased with a donation from John Elliott and a bank loan. The loan and expenses of remodeling to be withdrawn from the Current Surplus Fire Equipment Capital Reserve Fund.

The firemen spent over 300 hours transferring the pump and the fire truck body from the International chassis to the "New" 1972 Chevrolet chassis.

The job of transferring body and pump included undercoating the truck and body and remodeling all the piping, preparing and priming chassis and body, and painting.

Many new running lights, warning lights, and improvements to the body were made.

In addition to the Forestry radio, a used radio on the Dover and Durham frequencies was added.

The "New" truck has given us a "Mini Pumper", capable of 250 gallons per minute discharge. The truck is faster and much safer on the road as it is not over-loaded.

The surplus army vehicle which we equipped in 1973 gives us a tremendous advantage on a working building fire.

The department decided we should keep the 1942 Chevrolet, on the basis that it is more valuable to us than anyone else, and is handy for forest fires.

With the development of 35 lots on the Jabre Farm, and 18 lots on French Cross Road, and many more areas which are potential building developments, the next logical move in the future, would be the addition of a pamplet 19 truck which would get underwriters approval, and reduction in insurance rates within 2 miles of the station.

It may be possible in the future, to get underwriters recognition with a more formal tie-in with mutual aid from surrounding communities.

This spring we look forward to a vigorous recruiting and training program, which will emphasize the operation of our department as a separate unit, and also strengthen our operations with other communities in Mutual Aid.

STRAFFORD REGIONAL PLANNING COMMISSION

Organization

Previous reports of 1972 and 1974 have given details of how nine municipalities of the region and Strafford County have become organized to deal with the concerns and plans affecting us from outside our respective borders and to share the services of professional planners. This membership enables us to merge our \$619.00 dues into the larger federal fund source. Towns including Madbury pay \$29,000 only of the \$119,000 budget (See Ex. A, a and b later).

This budget provides us with a SRPC staff of five, which includes a director-planner, two regional planners, one of whom is our fellow townsman, Jack Mettee, and which has in addition a draftsman and other assistants whose salaries come from programs outside the budget. We are also tied in with two other regional planning commissions and their staffs in a larger region through our membership in the Strafford-Rockingham Council, which is the channel for the federal and state funds available to the Commission.

Work of the Commission

Review Function

Broadly, the Strafford Regional Planning Commission reviews and evaluates for the granting agencies, programs and proposals made within the region which involve federal and state funds.

Regional Studies

The Commission has completed and printed a land capability analysis of the Southern Strafford Region this year and is reviewing for release a coastal zone inventory and analysis. Both analyses include Madbury. The SRPC has consultants under way on a solid waste management study and has obtained federal funds to determine the feasibility of a bus system for the area including Madbury. A directory of the 144 agencies serving local human needs has been compiled and an inventory of historic places of Madbury et al prepared.

One of the most useful and timely studies (already used by the Planning Board) is a cost analysis formula, which is a tool or model to determine the practicability of developer proposals and also of zoning plans — from a short and long-range view. If only 200 new single family houses are built locally without offsetting taxes from other sources such as the Public Service installation, Madbury Metals, the tennis courts, or commercial and light industrial development, perhaps multiple housing and student dormitories, our local tax rate will double from school costs alone, exclusive of police, fire or administrative expenses.

Model Municipal Land Ordinances are in process to help planning boards: zoning for shorelands, erosion control, cluster houses.

Information for the Public

The SRPC Staff and office are available to private citizens or groups for information about the region and planning concerns. The Commission conducts programs and workshops for the public and brings in speakers on trends and developments which could affect the Region. This year some of the topics presented were: *Energy Considerations in City & Town Planning*,

N. H. Highway Department Planning Procedures for State & Federal Highway Systems, National Bicentennial Community Program, Advantages of Historic Preservation and Planning, Solid Waste Management & Economic Aspects of Recycling.

Assistance to Member Towns & Cities

The staff at Dover plus the know-how at regional offices at Exeter and Salem can be tapped for technical assistance by request of official boards or commissions. Such help was given to Madbury, Somersworth and Nottingham this year in preparation of land capability plans. Other kinds of assistance have been given: to Durham on a plan for bicycle paths; to Somersworth on a plan for an industrial park development; to Newmarket in applying for flood insurance and in determining the potential number of schoolchildren from two subdivisions. A course in planning board affairs has been offered and a planning board member manual is in process.

This year, as many of you know, Jack Mettee aided by Mark Morong of Madbury, a student intern with the Commission, conducted weekly and bi-weekly meetings with members of the Planning Board and the Madbury Community Club to draft natural resource inventory maps and an existing land use map as a basis for developing a comprehensive plan for Madbury. A booklet describing the characteristics and planning implications of each of the maps was also prepared and copies were distributed to the Madbury participants in the sessions.

These basic maps are a must for any later intelligent local plans of the Planning Board, Selectmen or other decision makers.

I know of no other way Madbury can obtain this timely information so reasonably.

The cost of SRPC membership to Madbury (\$619) is up and no one can say it won't increase, because of continuing federal deficits that destroy the value of U. S. currency. Nevertheless, the extraordinary pressures for development on this green belt of Madbury require that its growth be guided as intelligently as possible, not only to minimize overwhelming taxes to present residents, but to preserve long-range advantages of open space, parks, playgrounds, water, etc. and to provide jobs for this generation and the next.

Whether or not we are represented in the SRPC there will be regional plans and there must be regional plans, due to the enormous pressure for growth in the region. I believe Madbury should be in on the ground floor to participate positively and defensively as these plans unfold. Lay wisdom for decisions is welcome and needed.

MADBURY WATER DISTRICT

The 1975 Annual Meeting, held on March 21 at the Town Hall, saw Kenneth Morrow re-elected Moderator, Georgia Drew re-elected Treasurer, Elizabeth Shames elected Clerk, and Peggy Wolcott elected Commissioner. Appreciation was expressed to former Commissioner Roy Judd and former Clerk Enda Twombly for their faithful service. The annual report was reviewed, and the budget of \$35 was appropriated.

Following the business meeting, Dr. Francis Hall, UNH hydrologist, gave a preliminary report on the Barbadoes Pond survey. His complete report is expected at the 1976 Annual Meeting.

Brian Chernak of York, Maine gave a talk on the survey of water quality in private wells in York County. This project was undertaken by the York County Regional Planning Commission in 1970-1972. A surprising number of wells were found to have some degree of contamination.

This year's activity has consisted of continuing the mapping project, which is nearly done, and discussing ways in which the District can help Madbury residents to assure a safe water supply from their private wells.

The 1976 Annual Meeting is tentatively scheduled for March 24 at the Town Hall.

REPORT OF THE TAX MAPPING COMMITTEE

This committee was appointed after the 1974 Town Meeting to investigate tax mapping procedures suitable for Madbury. The members are:

At the 1975 Town Meeting we recommended (1) hiring a professional engineer/surveyor for technical work and for guidance, (2) enlisting volunteer help for clerical work, and (3) enlisting volunteer help and/or hiring students for field work. This approach was accepted and the committee was reappointed to continue and to offer a specific program at the 1976 Town Meeting.

We have therefore requested a budget item of \$1,000 for the operating year 1976. It is hoped that a reserve fund can also be started in anticipation of a greater expense next year.

For this year, we expect to set up a file of property owners and parcels, and collect the deeds, lot plans, and other documents necessary to describe the bounds of each parcel. We will need to buy a legal size file cabinet and folders, and an index file box and index cards. In some cases we will have to get copies of deeds from the Register, although we have many deeds already.

We will also be buying the aerial photos on which the mapping is to be done, and some blueprints of the photos for rough mapping.

When enough information is on hand, we will start drawing in the boundary lines on the maps. This part of the work will probably be only just begun by this time next year.

We will accept offers to help with clerical work, although it will not begin until the materials are in place.
