A. Amount required to be raised under the law of 1899, one-fourth of one per cent.	\$760 90
B. Additional amount if town applies for state aid,	152 00
C. Total minimum amount required to be raised for highway purposes if town applies for state aid	\$912 90

If no application for state aid is made in 1909, the town is required under Section 3 of Chapter 35, Laws of 1905, to set apart and expend for permanent improvement the sum of \$304.00.

If the town does apply for state aid under the above-mentioned law of 1905, a joint fund for the town is formed, the items of which are as follows:
