



THE STATE OF NEW HAMPSHIRE

TOWN WARRANT

To the inhabitants of the Town of Harrisville in the County of Cheshire in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Eagle hall in said Harrisville on Tuesday, the twelfth day of March next, at ninethirty of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.

3. To see what action the town will take in relation to PWA and Relief projects submitted to the State Engineer of Public Works by the selectmen for approval.

4. To see if the town will vote to have its selectmen oppose the permanent abandonment of the railroad should the occasion arise and raise money for the same.

5. To see what action, if any, the town will take regarding the purchase of a new truck for highway purposes and the using of the present truck remodeled for fire purposes or act in relation to the same.

6. To see if the town wishes to make any change in the salary of the road agent or other town officers, or act in any manner relating thereto.

7. To see if the town will vote to purchase a truck and equipment as recommended by the fire department, raise and appropriate money for the same, or pass any vote relating thereto.

8. To see if the town will vote to observe Old Home Day and make an appropriation of \$100.00 for the same.

9. To see if the town will vote to accept State aid for its highways in accordance with Bills now pending in the Legislature.

10. To see if the town will vote to install a street light near the barber shop.

11. To see if the town will vote to extend the street lights to the Aldworth Farm buildings.

12. Shall beverages be sold in this town under permits granted by the State Liquor Commission under the provisions of Chapter 99 of the Laws of 1933, and amendments thereto.

13. To see if the town will raise and appropriate the sum of \$50.00 for the purpose of advertising the resources and natural advantages of the town, said sum to be expended under the direction of the selectmen, or take any other action relating thereto.

14. To see if the town will appoint a zoning commission to consist of five members, to recommend boundaries for zoning districts in said town and to recommend approximate regulations therefor, in accordance with the provision of Chapter 42 of the Public Laws.

15. To see if the town will vote a sum for the expenses of the zoning commission if the town votes to appoint such commission under the preceding article.

16. To hear the reports of officers heretofore chosen and pass any vote relating thereto.

18. To see if the town will accept State aid for construction of Class II road known as Nelson Road and raise and appropriate and set aside for said purpose the sum of \$1,377.00; or will accept State aid for construction of Class V roads and raise and appropriate or set aside for said purpose the sum of \$497.02.

19. To transact any other business that may legally come before the meeting.

In accordance with the vote passed last September at a special meeting, a Model 364, Northern pumper and 1,000 feet of hose has been purchased. A room has been fitted up in the town barn where the pumper can be kept warm. The work has been done wholly by volunteer labor by a number of public spirited citizens to whom the town should be very grateful for the valuable service rendered.

A fire company has been organized with John N. Clark as chief. The need of the department is a truck for the transportation of the pumper, hose, and men fitted up with a booster tank.

Mrs. Arthur E. Childs has contributed the sum of \$25.00 towards the purchase of a truck, for which the town is very grateful. We feel that with this small beginning we can look forward with less uneasiness from forest fires as well as our homes.

With an apportionment of \$320 from the State Forestry Department five water holes have been constructed which will be of much assistance in the localities served both for forest fires and buildings.
