

TOWN MEETING WARRANT

To the inhabitants of the Town of Lisbon in the County of Grafton in the State of New Hampshire Qualified to vote in town affairs.

You are hereby notified and warned to meet at Lisbon Regional School in said Town of Lisbon, New Hampshire on Tuesday the Fourteenth day of March 2023 at twelve o' clock noon at which time the polis shall open and not close earlier than seven o' clock in the evening to act upon the following subjects. All Articles except Article 1 are to be considered at seven o' clock in the evening at the Annual Town Meeting.

Date: March 14, 2023

Time: 12 PM POLLS OPEN; 7:00 PM TOWN MEETING

Location: LISBON REGIONAL SCHOOL

John Northrop III introduced himself as Moderator. He asked everyone if they have cell phones to please mute them if they haven't already.

Pledge of Allegiance

The front table was introduced-

Scott Champagne, Selectboard Chair; Arthur Boutin, Selectman; Brian Higgins Selectman; Audrey Champagne, Town Clerk/Tax Collector.

John went over the rules of the meeting.

Article 01

Elect

To choose all necessary Town Officers for the ensuing year.

John Northrop stated that the polls are open until 7pm and that is exactly what is being done. He stated that the votes will be counted as soon as the Town Meeting is over and the

results will be available tomorrow.

Article 02 Hear Reports

To hear reports of agents and special committees heretofore chosen and pass any vote related thereto.

John Northrop stated that these reports are in the Annual report and folks may read at their own discretion.

Article 03 Water System Improvements

To see if the Town will vote to raise and appropriate the sum of \$5,086,000.00 for Water System Improvements, and to authorize the issuance of not more than \$3,268,000.00 of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA 33) and to authorize the municipal officials to issue and negotiate such bonds or notes and to determine the rate of interest thereon; the balance of \$1,818,000.00 to come from available grants identified for this purpose. All future principal and interest payments will be made from the Municipal Water Fund operating budget for the life of the loan, as well as a portion of the loan qualify for Principal forgiveness totaling \$1,053,000.00. The Board of Selectmen recommends this Article. (3/5 ballot vote required). Recommended by the Board of Selectmen 3-0. (3/5 ballot vote required).

Total Funding for the project would be as follows: USDA LOAN- 30 YRS 1.375 % \$2,215,000 USDA GRANT-\$1,121,000 TOWN-\$4,000 DWGTF GRANT-\$576,000 DWSRF LOAN-30% FORGIVENESS-\$468,000 DWSRF EC LOAN- 100% FORGIVENESS-\$585,000 ARPA GRANT-\$117,000

TOTAL PROJECT - \$5,086,000

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott Champagne stated that the project began back in 2017. Scott stated that this is not from taxation. He stated that this is strictly from water/sewer users. Scott stated that Horizons Engineering has been working with the town on this project since the very beginning. He stated that this is for a new filtration system and chem feed building. He stated again that passing this article will not cause a tax increase.

Barry Lucas asked if anyone could vote on this article or is it just the water/sewer users that vote. Scott Champagne and John Northrop stated that anyone that is a registered voter can vote on it. Sandra Butson asked if this was going to cover the costs of a new WELL. Scott Champagne stated that it will cover costs for exploring a new WELL. Scott also stated that this will cover the replacement costs of so many feet of water lines around town. Tom Day asked what the letters before the grants mean. Scott Champagne stated that they represent the names of the different grants. Dave Paige asked if the grant has already been approved/received. Scott Champagne stated that the grant has been approved but the town does not get any of the funds until the project gets complete. Barry Lucas asked if there was going to be a problem because one of the WELL'S is in a flood plain. Scott Champagne stated that the State will not let the town run WELL 1 unless there is someone on site to conduct hourly testing for each hour it is run. Scott stated that potentially there will be an

automated system installed in WELL 1. Charlie Hampson asked if the grant included Generators. Scott Champagne stated that the grant does include a generator because if there is no power then there is no water.

Debbie Vintinner asked why they can't have just one piece of paper to vote. John stated it is one piece of paper, you just rip it in half. John Northrop (Moderator) told folks how the voting is to be done.

Poles closed at 7:15PM

BALLOT VOTE YES-50 NO-1 Article PASSED.

Article 04 New Fire Department Engine

To see if the Town will vote to raise and appropriate the sum of \$850,000.00 (gross budget) for the purchase of a New Fire Department Engine, and to authorize the issuance of not more than \$850,000.00 of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA 33) and to authorize the municipal officials to issue and negotiate such bonds or notes and to determine the rate of interest thereon; And further to raise and appropriate \$90,000.00 such sum to represent the first years payment of principal and interest on said borrowing. The Board of Selectmen recommend this warrant article. (3/5 ballot vote required).

John stated that they will discuss article 4 but will wait for the results of article 4 before discussing article 5 and if article 4 passes the Selectboard will bypass article 5.

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott Champagne stated that this article should have read \$800,000 as the payment was based off \$800,000. Scott stated that the truck and equipment was estimated to be \$800,000 but due to costs and interest could be up to \$850,000. Scott stated that such a large piece of equipment can't be ordered and gotten in the same year. He stated that there is an 18-24 month waiting period. Scott stated that these larger purchases are harder to replace at the proper time and he doesn't know what the answer is.

Chief Hartwell stated that they are requesting a new Engine this year. They began looking for a new one about two years ago. Chief Hartwell stated that two years ago the price of a truck was \$545,000 and as of today it is \$712,000. The Chief stated that a truck outfitted with the equipment that they use places the cost at \$800,000. He stated the current primary truck they have is 25 years old. He stated they had a pump failure on it last year and it cost them \$24,000 to have it fixed and it was fixed with used parts, so they are on borrowed time with it. Chief Hartwell stated that they are currently doing a two percent increase on cabs and chassis every quarter.

Barry Lucas asked what the life expectancy of a truck is. Greg Hartwell stated a truck will last about twenty to twenty-five years.

Tom Day stated that he knows nothing about Fire Trucks but for good equipment that's a lot of money. Chief Hartwell stated that this is a basic model, and it doesn't have a lot of bells and whistles. Kevin Stratton asked how hard it is to find a used truck. Chief Hartwell stated that they are hard to find and usually when they do find one it is anywhere from eight to ten years old and there is no warrantee with them.

Deb Desantos stated that it would cost more for a used truck and Chief Hartwell said the interest rate is higher for a used truck. Deb then asked what would happen to property values if they did nothing. Matthew Champagne and Greg Hartwell explained the grant and the grant process. Dave Paige asked what the Board would do with the non-matching funds if the Fire Department is awarded the grant? Scott Champagne stated the Board would only use what is required for the grant. Dave Paige stated

from what he knows they have 17 people in the Fire Department and 10 of them are in Lisbon. He stated that poor equipment shouldn't be a hindrance.

Willard Lucas asked if they begin paying for the truck when they get it. Scott Champagne stated a lot of times they ask for a down payment, and he is hoping that as it gets closer to the payment the interest rate may be a little better/lower. Barry Lucas asked if they would keep the price of the truck until it's delivered? Chief Hartwell stated that once the contract is signed the price stays the same. John Northrop Senior stated that he was in the department for 17 years and he thinks they should provide the department with what they need as volunteers are hard to come by. Willard Lucas stated he was on the Bethlehem Fire Department for a very long time, and he feels as though it's important to have good equipment. Matthew Champagne stated what they had for current equipment. Matthew stated that Littleton loaned Lisbon a truck when the Engine was down. Barry Lucas stated that he doesn't think anyone gets rid of used Engines.

Steve Morrison made a motion to amend the article to say that it be contingent upon grant funding meaning if the grant isn't received then no truck. Craig Myers seconded the motion. Sandra Roberts asked if the grant must be used for all of what is asked for or can it be for a lesser amount. Chief Hartwell stated the grant is usually what is asked for. Chief Hartwell stated that he understands where Steve Morrison comes from as a taxpayer. He himself is a taxpayer, however if they decline the grant they can't apply for 10 more years, and it could put them further behind.

Rosalind Page asked if a vote was needed to accept the grant? Chief Hartwell stated they must have approval.

Voted on Amendment Amendment FAILED

Barry Lucas asked if taxes would be increased over 15 years.

Scott Champagne stated that they will go with the lowest interest rate possible. It will roughly be .76 cents per thousand on the tax rate for the year. Owen Clark asked what would be done with the old truck? Chief Hartwell stated that the old truck would go out to bid. Owen then asked what the assurance from the Selectboard is that the money will go back if the grant is received. Scott Champagne stated the town isn't like the school and they will give the funds back. Sharon Clark made a motion to move the question.

BALLOT VOTE YES-46 NO-6 Article PASSED.

Article 05

Used Fire Department Engine

To see if the Town will vote to raise and appropriate the sum of \$500,000.00 for the purchase of a used Fire Department Engine, and to authorize the issuance of not more than \$500,000.00 of bonds or notes in accordance with the provisions of the Municipal Finance A 33) and to authorize the municipal officials to issue and negotiate such bonds or notes and to determine the rate of interest thereon; Further to raise and appropriate \$50,000.00 for the first years payment of principal and interest in said bond. The Board of Selectmen recommend this warrant article. (3/5 ballot vote required).

Article 5 was passed over by the Selectboard.

Article 06

Operating Budget

To see if the town will vote to raise and appropriate the sum of \$2,365,512.00 for general municipal operations. This article does not include appropriations contained in special or individual articles addressed separately. The Board of Selectmen recommend this Article. (Majority vote required)

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott Champagne stated that this is a \$41,000.00 increase from last year. He stated that each Town employee got a five percent raise. He stated that there were two budget hearings and maybe one or two people participated. Debbie Vintinner stated that she attended and asked questions and she wanted to know why the Selectman line item is \$26,000.00. She stated she understood that each Selectman got a stipend of \$5,000.00 and she's aware that Scott gets \$12,000.00 to look for grants and bonds. She stated that her previous husband was an ex-Selectman in the town where she came from, and he didn't get paid for something they do as a Selectman. Debbie made a motion to decrease that line item by \$12,000.00. John Northrop stated that typically you don't decrease specific line items it comes from the bottom line.

Sandra Butson asked if paving was included in road improvements and what was on the radar to be paved. Charlie Hampson (Highway Supervisor) stated that Atwood Street and Forrest Hill are on the radar.

Debbie Vintinner stated that she would like to decrease the bottom line of \$2,365,512 by \$90,000.00. She stated there is another issue that she talked to Krystle (Administrative Assistant) about, and she

does not understand why we are paying for two family insurance plans for employees of the town. Debbie stated that no town pays for a family plan for someone that works for the town. She stated you only pay for that person that is in that position. Debbie made a motion to decrease the bottom line by \$90,000.00 and it was seconded by John Vintinner. Charlie Hampson stated that as far as \$12,000 goes for Scott Champagne, it's not just for grants as Scott assists the department heads daily and is in his office daily. Charlie stated as far as family plans go many towns cover family plans. Scott Champagne stated that he is opposed to changing insurance as it is hard to find employees and the Town values their employees. Scott stated that's how you get employees to stay. Scott stated that they have had a full-time Town Manager and a Part Time administrator, and it has cost the town more money than now and it has not worked out. Scott stated he is considered a working Selectman. Owen Clark moved the question and Dave Paige seconded the motion.

Voted on Amendment-Amendment FAILED

YES -Ayes have it, Article PASSED.

Article 07 Wastewater Budget

To see if the town will vote to raise and appropriate the sum of \$289,100.00 for the operation and maintenance of the Lisbon Wastewater Department operations. Funds to be raised from user fees and no amount to come from taxation. The Board of Selectmen recommends this Article. (Majority vote required)

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott Champagne stated that the board is very happy with the services from H2O Innovations. Scott stated that many improvements have been made such as the pumps being replaced at the Bath Road pump station. Scott stated that ARPA funds were used to assist in the project. Dave Paige asked if the budget was up. Scott stated that it is up slightly. Dave also asked if the previous article is included in this budget and Scott stated that it is.

YES -Ayes have it, Article PASSED.

Article 08 Water Department Budget

To see if the town will vote to raise and appropriate the sum of \$199,775.00 for the operation of the Lisbon Water Department. Funds are to be raised from user fees, no funds from taxation. The Board of Selectmen recommends this Article. (Majority vote required)

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott stated that the user fees have gone up slightly. He stated that there has been an increase in the price of chemicals just like everything else. Barry Lucas asked if the fees would go down with the new system and using less chemicals. Scott stated that they don't really know. He stated that they may be able to use one less chemical.

YES -Ayes have it, Article PASSED.

Article 09 Fund Capital Reserve Accounts

To see if the town will vote to raise and appropriate the sum of \$62,000 to be added to the following Capital Reserve Funds previously established:

The Board of Selectmen recommends this Article. (Majority vote required)

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott stated that we are keeping with what we have done in the past.

Scott stated that the library portion has gone towards handicap accessibility.

Dave Paige stated that these accounts are interest bearing is that correct? Scott Champagne stated that, that is correct. Dave Paige stated that he would like to make an amendment. He stated given that the interest rates are high now is the time to invest in these accounts. Dave made a motion that he would like to amend the article to \$100,000.00 be added to the capital reserve funds and Matt Hubbard seconded the motion. Scott Champagne stated that it was a good idea, but he doesn't recommend it.

Sandra Butson asked if Capital Reserve funds need to be allocated for each fund. Scott Champagne stated that the Board would discuss where the money would go.

Tucker Clark asked if it is not on the Capital Reserve list could money go to it? Scott stated that it needs to be on the list.

Matt Hubbard agrees with Dave Paige as the interest rates are high and it would make sense to add more.

Sandra Butson stated that the Master Plan was updated and finalized last year.

Amendment FAILED

YES -Ayes have it, Article Passed.

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott Champagne stated that the Board reviews the requests each year. He stated that each participant/charity is asked to submit a letter requesting the funds. They go over this each year and

see who collected their funds and who didn't and that is how they make their decisions on who to provide funds to.

Tom Day asked what Pathways was. Marlene Higgins explained what pathways was and what they do.

YES -Ayes have it, Article PASSED.

Article 11 Transfer to Bridge Maintenance CRF

To see if the town will vote to raise and appropriate the sum of \$141,580.60 to be added to the Bridge Maintenance Capital Reserve Fund previously established. This sum to come from unassigned fund balance. No amount to be raised from taxation. Recommended by the Board of Selectmen 3-0. (Majority vote required)

Moved by Scott Champagne, seconded by Arthur Boutin.

Scott stated that the Town has already received the funds from the State for Bridge Maintenance, but the Board needs approval.

YES -Ayes have it, Article PASSED.

Article 12 Land Swap

To see if the Town will vote to conduct a land swap with the Lisbon Area Historical Society using Town of Lisbon U-04-007 being .410 acres minus roadway between Depot Street and Whitcher Street in exchange for U04-014 .350 acres for a municipal parking and trails parking lot at the intersection of Central Street and Atwood Street. No amount to be raised by taxpayers. Any monies for recording purposes will be taken from Selectboard's unanticipated expenditures. The Board of Selectmen recommend this warrant article.

Moved by Arthur Boutin, seconded by Brian Higgins.

Scott Champagne stated that this swap makes sense. He was able to show the public the map and he also noted that a sidewalk would be added.

Sandra Butson asked if it would make sense to connect the two roads and require a right of way? Scott Champagne stated that yes it would, and it has been agreed to be done if the article is approved.

YES -Ayes have it, Article PASSED.

Article 13 Regional Police Agreement

To see if the Town of Lisbon should conduct, with surrounding towns, a feasibility study with interested towns for a Regional Police Department. Each Town will provide a Board member or their designee and other members by Board appointment to conduct monthly meeting(s). No monies to be expended and results of study to be available by March 2024. The Board of Selectmen recommend this article.

Moved by Scott Champagne, seconded by Arthur Boutin.

Chief Bailey spoke regarding this article. Chief Bailey stated that he was approached by Chief Eck in Bath. Chief Bailey stated that the concept of the regionalization study is to look at cost, equipment, grants, and personnel. He stated that if all five towns participated the costs would go down and there would be more coverage along with more people for less money. The potential towns involved in this would be Monroe, Bath, Lisbon, Landaff and Lyman. Chief Bailey stated that it would potentially be eight full-time officers and one part-time Chief, which will be determined by the committee.

Tom Day stated that some hours here in Lisbon aren't covered. Chief Bailey stated that there is no coverage after midnight by the Town or State Police. He also stated that on the weekends there is a shift that is covered until 2am. Chief Bailey stated that Littleton and Hanover are two towns that have 24-hour coverage. Selectmen's Annual Report 2023

In 2023 the Lisbon Board of Selectmen prepared for our biggest project to date, the implementation of a new water filtration system. Because of the taxpayer's support and various grant monies the board worked closely with Horizon's Engineering from Littleton, NH and Water Surplus, a mid-west company to best determine what filtration system is right for Lisbon, NH. Bids for construction should go out this spring 2024. Water Surplus installed a Temporary small sample filter system to determine the best "green sand" or media available.

During the 2023 year 3 Invest NH Demo grants were applied for in conjunction with a local property owner. To date, of this writing, there is no official word on those grants. The Following grant was obtained:

Grafton County ARPA Funds \$40,000

These funds were applied for Bridge Maintenance on the Streeter Pond Road bridge. The required maintenance will be performed during the summer of 2024 and that Bridge will be closed for approx. one month.

The Town of Lisbon had several Employee changes over 2023. In June Fred Garofalo Transfer Station Supervisor resigned and was replaced by Lyman resident Lee Veilleux. (see Dedication of this Annual report) Chief Bailey of the Lisbon Police Department resigned/retired in December 2023. We wish Chief Bailey well in his new endeavors. He was replaced by Sgt. Sullivan who became the new Police Chief on January 6th, 2024. The Police department will be down a person until a replacement is found and hired.

Twelve residents applied for and were approved for assistance from the New Hampshire Homeowners Assistance Program. The Town received just under \$75,000.00 from this program to pay past due utility/property tax invoices for these residents.

For your convenience, I can register vehicles, license your dogs, accept vital records applications, and receive property tax/sewer payments, on-line (lisbonnh.org). The town does not incur/receive any fees for this service (fees apply, charged by the payment provider). Credit/Debit cards, checks and cash are accepted forms of payment at the counter.

Supporting documents such as rabies certificates and scans of your photo ID may be scanned and e-mailed, mailed, or faxed. Once I receive notification of your payment, I will process your request and mail you the document.

I extend the courtesy of e-mail renewal notices for vehicle registrations and dog licenses and the option of paperless notification of property tax and water/sewer invoices. If you choose to receive paperless invoices you will receive up to three emails alerting you that your bills are available online.

As more people choose to receive their news and information digitally, I have made keeping the information on our website current a priority. I encourage everyone to subscribe to the website and notices.

The Town Clerk/Tax Collectors regular office hours are Monday 3:30-7:00, T/W/Th 7:30-12:00 & 12:30-4:00, Friday 7:30-10:00. Any changes to the regular office hours will be posted on the web site.

We would like to encourage residents to apply for assistance from the Buffington Fund. Many residents are not aware but the Buffington Fund will cover for ambulance transportation. As a brief review, this fund was established to provide medical assistance to needy residents who qualify for assistance and was last modified by the court in 2001 as follows:

- 1. Care of Town's residents who are deserving patients at any other general care hospital, wherever located, who have been transferred from Woodsville Cottage Hospital
- 2. Care of Town's residents who are deserving patients at any other general care hospital wherever located.
- 3. For other medical/dental care of deserving Town residents including care by physicians, dentists, and nurses and medical and/or dental prescriptions.
- 4. For the care of the Town's deserving needy for needs other than medical expenses including housing, food, etc. commonly paid for by Town Welfare or for purposes such as eye care, examinations, and glasses.

If a needy resident qualifies for assistance all that is necessary is to file an application with the select-board, if approved the board will send a request to the trustees for payment and we will pay the medical facility directly – the recipient/beneficiary's names are kept strictly confidential.

The Common Investment Fund provides money that is distributed annually to the town, library and cemeteries and the Grove Hill Cemetery Perpetual Care Trust provides funds for the repair of memorial stones and other maintenance.

The board keeps a very close watch for fluctuations in the market and, along with the advice of the Passumpsic Advisors, makes changes when necessary to ensure that funds entrusted to our care produce the greatest return with the lowest downside risk.

To the residents of Lisbon:

As the seasons change, some things stay the same, but other things change as do the seasons. This year, the Police Department experienced change, while many things stayed the same.

During a majority of the 2023 calendar year the Lisbon Police Department was at a full staffing level. As many of you may know, Chief Benjamin Bailey resigned his position at the end of 2023 to pursue another endeavor. Chief Bailey was an asset to the community and he will be greatly missed. Through his tireless efforts he brought a sense of pride and dedication to the Police Department that will be here for years to come. Through his efforts, we applied for and received a federally funded grant that paid for the four speed enforcement signs that are located on West Street, South Main Street, and North Main Street. This year we will be working with the New Hampshire Highway and Safety Commission to attempt to receive a grant for more speed signs that can be attached to poles....

As stated above, Chief Bailey left the Lisbon Police Department to pursue another opportunity. With Chief Bailey's departure, I was promoted from the position of Sergeant to Chief of Police. For those of you that do not know me, I have been a police officer for over 11 years. I started with the Haverhill (NH) Police Department as a patrol officer. I was then promoted to Corporal, and then held the position of Detective where I investigated the majority of felony level cases that the department took in. I also held the position as Interim Chief of Police while there. In April 2020 I took a position at the Lisbon Police Department, while staying on part-time at the Haverhill Police Department. I was promoted the Sergeant in 2021. I look forward to continuing the vision and plan that Chief Bailey set forth during his time here to best serve the citizens of the Town of Lisbon. We are currently working diligently to fill the vacant full time police officer position.

As in previous years, the Lisbon Police Department continues to provide directed patrol coverage to the Town of Landaff at 5 hours a week. The majority of the money generated from these patrols continues to go into the general fund to pay down the town of Lisbon residents taxes.

We were able to use monies that had previously been obtained through the Patrick Leahy Bulletproof Vest Partnership Program which allowed us to provide new body armor for two officers as the expiration for their present armor had been met. The Police Department was donated a patrol bicycle through *Bike the North Country*, which is a 501(c)3 organization. The patrol bicycle will be seen out on the Rail Trail and at events such as the Lilac Festival, which will allow an

officer to be able to respond to an incident quickly within town during events that generate more traffic in the area. The Police Department also applied for and received Grant monies through the Highway Safety Grant, which allows officers to exclusively be on the roadways enforcing motor vehicle violations. As in previous years, we will continue to apply for grants!

This year the Lisbon Police Department handled forty-eight (48) more investigations than were handled in 2022. We look forward to getting back up to full staff while providing quality service to the Town of Lisbon in 2024.

We replaced approximately 150 feet of 6-inch sewer main in a wooded section near Barrett St. We did sewer main repairs on Pearl Lake rd. along with sewer jetting there and other sections of mains in town. (please don't flush baby wipes)

Ditching was done on River Road, Walker Hill, and Atwood St. Culverts were replaced on Breezy Hill, Cathy Rae Drive and Mt Eustis. Storm drain repair on School St. We also did some site work at the Recycle center. Painting crosswalks prior to Lilac festival was performed.

Water meter reading, repairs, and replacement. Water main repairs on Woolson rd. and a hydrant replaced on Water St.

Grading, spreading gravel, side arm mowing, filling potholes, digging graves also was done through the course of the summer. Oh, and let's not forget what winter brings us and what that takes to maintain.

LISBON FIRE DEPARTMENT

2023 Found us not to be as busy as past years. Our call volume was 80 for the year.

We respond to quite a variety of calls throughout the year that include building fires, motor vehicle accidents, forest/brush fires (legal or illegal), broken water pipes, boiler malfunctions, power lines down, lock outs, smoke or CO detector activations, propane leaks, oil spills and unfounded calls.

Since we are a member of the Twin State Fire Mutual Aid system, we received help for 11 calls, gave help for 17 calls.

We also provide coverage for Lyman and have had 6 calls. Calls in Lyman were for MVA's, propane leak, power lines down and an electrical issue with a generator.

Thanks to the voters of Lisbon, we will be receiving a new Engine this year. The new truck should be here sometime around May or June. It will take us some time after it arrives to get the equipment installed and for us to get accustomed to using a new vehicle.

We have been advertising for new members and have had some interest. We will still be trying to recruit new members as the need is still there.

Our current membership is 18. Of that number 13 are Level 1 or better certified. We currently have 1 member that needs to finish one module for his level 1, and we have 1 member in a level 1 online class that is self-paced and another that is also going to try the online process.

2023 Lisbon EMS

The members of Lisbon EMS would like to thank the community for their continued support. We would also like to thank the area businesses for allowing our members to leave their regular jobs to respond to emergencies. We would not be able to do what we do without their support.

This year we had a total of 303 calls. 188 Lisbon, 35 Landaff, 42 Lyman, 7 Bath, 11 Haverhill/Woodsville, 2 Sugar Hill, 5 Newbury, 13 Littleton.

We are very fortunate to have 22 members on our roster:

- 8 Emergency Medical Responders (EMR)
- 4 Emergency Medical Technicians (EMT)
- 7 Advanced Emergency Medical Technicians (AEMT)
- 3 Paramedics

Every person on our roster is a valued member of our team. The dedication and time that they and their families give to our service is very much appreciated!

State law requires at least two NH Licensed EMS providers, one of which must be a least an EMT, to transport a Patient. Each Patient transported to a hospital takes about 90 minutes round trip from the pager going off to when the Ambulance returns to the Station. For each Patient contact we are required to file a report with the State of NH within 24 hours.

We provide first response and transport for our community as well as Lyman. Landaff has contracted us to provide first response only. Woodsville is their transporting agency.

Having a house number that is visible is extremely important. There is nothing more tragic than trying to respond to your medical emergency, and not getting there in time because of an old address number or no number displayed at all.

If you think you may want to work in healthcare but are not sure which direction you want to go, becoming an EMT is a great start. If you are interested in participating in EMS or have any questions about EMS please reach out to us.

- Lisbon had a massive flood event and luckily no major damage to the wastewater plant or pump stations.
- NHDES dam inspection around the lagoons with no issues.
- Chlorine tank replaced because the old tank leaked.

Wastewater Pump Stations:

- The VFD fan motor at the Landaff Pump Station had to be replaced.
- A large Vactor truck cleaned out the grease at the Hydro Pump Station.
- New transfer switch installed for the generator at Bath Road Pump Station.

Water Department:

- Horizons working on upgrades to the water system including digging test wells, sampling, and running a pilot system.
- Lead and Copper sampling all samples came back fine.

The Conservation Commission had a productive year. I would like to thank all the members of the Commission for their hard work, time, and effort to attend meetings; and members of the community who helped forward Conservation initiatives.

Hi-lights:

- In February the Conservation Commission welcomed Gary Ghioto to the Conservation Commission. Volunteers help us to achieve our mission; many hands make light work.
- In May, the Conservation Commission joined forces with the Lisbon Library to host Amanda Jobin from the Wildlife Encounters Ecology and Wellness Center who presented the Junior Wildlife Encounter program to Lisbon elementary students and students from the Blue School in Landaff at the Lisbon Regional School. The program included seven animals from around the world. In addition to the children thoroughly enjoying the program, it was wonderful to collaborate with the Library and the Lisbon Regional School. Thank you to Karla Houston, Librarian, for suggesting and coordinating Wildlife Encounters, and to Principal Natti for managing logistics at the school.
- Sponsored the 4th month-long annual town clean up in May, providing free "blue bags" for clean-up. Thank you to all who participated.
- In June, two members of the Conservation Commission made a brief presentation to the faculty and staff at Lisbon School to illustrate areas in conservation that could be collaborated on in the future, and to open opportunities for future collaboration.
- Conservation Commission member, Robert Cook continued to represent Lisbon Conservation Commission by attending the Ammonoosuc River Local Advisory Committee as it is one of the seven river corridor towns (Haverhill, Bath, Landaff, Lisbon, Littleton, Bethlehem, and Carroll). - In September the Conservation Commission partnered with Landaff and Lyman Conservation Commissions, ACT, and the Lisbon Area Historical Society to bring a presentation about Loons from the Loon Preservation Committee's Caroline Hughes to the new Lisbon Area Historical Society Museum. The event was well attended by thirtyone residents from Franconia, Lisbon, Landaff, Lyman, Littleton, and Berkely, CA. It was informative and another great initiative that involved collaboration to bring an educational opportunity to our town.
- The Conservation Commission published newsletter, Fall 2023, which covered the
 events that were held by the Conservation Commission, articles on bald eagles in the

- **Applications**: The Board reviewed and approved two applications for lot line mergers, three lot line adjustments, a 7-lot residential subdivision, a 2-lot residential subdivision, and two site plan applications.
- **Site Plan regulations-revisions.** The Board approved amending the regulations to allow for a greater flexibility in site plan reviews with some activities being exempt from application requirements, some being eligible for minor site plan review, and other projects needing full site plan review. Other revisions are needed to keep our regulations in accordance with state regulations were also approved.
- Letter of Support. The board wrote a letter of support recommending that the Lison Area Historical Society be awarded a scenic byway award from North Countr Council.
- Downtown renovation plans. A grant application to Northern Borders Regional Commission was successful in procuring a small grant for plans to be designed for some downtown parking improvements on town owned land for use by local businesses and residents. This is conditional upon matching funds being raised by September 2024. The board will be looking for local businesses and downtown owners to give input and help raise the matching funds.
- **Fees**: Remained unchanged this year.
- Other Business. A member of the Board is serving as a representative for the Town at the North Country Council Regional Planning Committee quarterly meetings.
- A member of the Board is serving as representative for the Town on the North Country Council Transportation Committee.
