TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Andover in the County of Merrimack, in said State, qualified to vote in Town Affairs:

(L. S.)

You are hereby notified to meet at the Town Hall in said Andover on Tuesday, the eleventh day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
3. To choose Delegates to the Constitutional Convention.
4. To see what sum of money the town will vote to raise and appropriate for highways and bridges.
5. To see what sum of money the town will vote to raise and appropriate for the use of the town library in addition to law.
6. To see what sum of money the town will vote to raise and appropriate for the care of cemeteries.
7. To see what sum of money the town will vote to raise and appropriate for memorial purposes.
8. To see what sum of money the town will vote to raise and appropriate for observing old home day.
9. To see what sum of money the town will vote to raise and appropriate for the purpose of securing the services of a district nurse.
10. To see what sum of money the town will vote to raise and appropriate for lighting the streets.
11. To see what sum of money the town will vote to raise and appropriate towards buying ten dozen more seats for the town hall.

12. To see if the town will vote to raise and appropriate \$2,700.00 for black top on our state and federal roads. If the town raises said amount the State will appropriate \$5,400.00 making a joint fund of \$8,100.00.

13. To see if the town will bond its officers, and pay for the same.

14. To see if the town will vote to raise and appropriate the sum of \$4,378.17 to pay the balance due on the state road built in 1928.

15. To see what action the town will take in regard to buying the F. W. D. truck and plow.

16. To see what sum of money the town will vote to raise and appropriate towards pine blister rust.

17. To see what action the town will take in regard towards discontinuing the section of road from Henry Emery's road to where the old road joins the new road at Hog Back. Also the section of the old road from Hog Back to the new road by the cold spring so-called.

18. To transact any business that may legally come before this meeting.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board of the Town of Andover:

I submit, herewith, my first report as superintendent of schools.

The report is largely of a statistical nature due to the fact that I did not begin my duties until July 1st and that I have only the attendance and financial records of the year 1928-29.

I have changed somewhat the form of arrangement in the printing of the financial report. This change is not revolutionary and need cause no alarm.

The four columns of figures give the voters a chance to compare the expenditures, item by item, of last year's business with the current year, and also shows how much has been expended to January 1st, 1930. The fourth column is the amount of money the school board would like to spend during 1930-31, not necessarily the sum to be raised. The statement of the financial standing of the school district on January 1, 1930 gives an idea of the solvency of the district on that date. I have added a column of figures to show how the Andover school dollar was spent in 1928-29.
