### THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Andover, in the County of Merrimack, in said State, qualified to vote in Town Affairs:

(L. S.)

You are hereby notified to meet at the Town Hall in said Andover, on Tuesday, the tenth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same.
3. To see what sum of money the Town will vote to raise and appropriate for Highways and Bridges.
4. To see what sum of money the town will vote to raise and appropriate for the use of the town library.
5. To see what sum of money the town will vote to raise and appropriate for the care of cemeteries.
6. To see what sum of money the town will vote to raise and appropriate for Memorial Day.
7. To see what sum of money the town will vote to raise and appropriate for the purpose of securing the services of a district nurse.
8. To see what sum of money the town will vote to raise and appropriate for lighting the streets.
9. To see what sum of money the town will vote to raise and appropriate for Trunk Line Maintenance. The State asks the Town to raise \$3,425.00. The State will give \$6,850.00, making a joint fund of \$10,275.00.
10. To see if the town will vote to bond its officers, and pay for the same.
11. To see what sum of money the town will vote to raise and appropriate towards paying for the cement road at the East end of the town.

12. To see what action the town will take in regard to buying the F. W. D. truck and plow.

13. To see what action the town will take in regard to the Brousa land.

14. To see if the town will vote to have another volume of the Town Reports bound.

15. To see what action the town will take, if any, to prevent accidents to the children using the State highway going to and from school.

16. To see if the town will vote to make the old road at Dyer's Crossing a private way.

17. To see what sums of money the town will vote to raise and appropriate for taking care of the town poor.

18. To see what sum of money the town will vote to raise and appropriate for the Police department.

19. To transact any business that may legally come before this meeting.

### Recommendations

Serious consideration should be given the Flaghole school house. This is the smallest building in use at the present time. There are nineteen pupils in attendance and there is every indication that within a year or two this number will be increased. The building should be made larger by lengthening it ten or twelve feet and making changes as to lighting so as to make it modern in every respect. It is badly overcrowded just now.

I think the time has arrived when a regular teacher should replace the cadet teachers at Boston Hill. I would recommend that such a change be made at the opening of the school year 1931-32.

The amount of money being paid for transportation and high school tuition for the current year is more than was raised at the last school meeting. These are items that are hard to anticipate and yet these increased costs must be met. I suggest that \$600.00 be raised at the coming meeting, the use of which be made immediately available to meet the increased costs of these two items.

The year has been a very pleasant one, the teachers, parents and the school board have been real factors in the success of the Andover schools.
