REPORT OF SCHOOL BOARD.

The following report of schools of Swanzey for the official year ending Feb. 15, 1907, and a table of statistics for the school year ending July, 1906, are here respectfully submitted.

Several changes in the list of teachers have occurred during the year. For the fall term Mr. Cyril F. Randall was elected at No. 11, Miss Daisy Sumner at No. 1, Miss Luna Tarbox at No. 2, Miss Elgie Adams at No. 9, and Miss Flora Applin at No. 10. The winter term at No. 10 was taught by Miss Florence Perham. On account of a large decrease in the number of scholars at No. 7 the assistant teacher there was not retained after the spring term. A spring term was taught in the second room at No. 1 by Miss Zoella Phelps. This school was discontinued in the fall. The employment of an assistant has proved satisfactory at No. 7. It is probably the most economical method of providing for schools where the number of scholars is so large that proper attention cannot be given by one teacher.

Schools have been maintained in ten different rooms for the entire year and the keeping of a spring term at No. 1 and fall and winter terms at No. 10 gives the equivalent of another full year's work.

The whole number of different pupils enrolled in the school registers since the first of September is 361. The number of school children reported by the enumeration officer in October was 337—157 boys and 180 girls. As children begin their attendance at school at different ages and many leave permanently at the age of fourteen, there is necessarily some difference in the two reports.

Attendance has been somewhat broken in several schools during the term just closed. Much of it has been caused by illness as

is not uncommon at this season of the year. The school board has endeavored to have the attendance kept up as well as possible and is pleased to note that many parents realize the value of constant attendance and are ready to cooperate with the school board in its efforts to make the school privilege of practical value to their children. The length of schools for the year has been made thirty-three weeks wherever practicable. One school at No. 11 was closed one week earlier than was planned on account of injury to the room by a fire, which caught from one of the furnaces and which but for its timely discovery would have soon destroyed the building.

The problem of furnishing equal and satisfactory school privileges for all scholars, as is called for by the state school law, is made difficult in our town by the manner in which residences are distributed. Aside from the village of West Swanzey, they are spread out over a large area, giving several small settlements and many scattering homes with long distances between. The school board has endeavored to so use the funds, placed at their disposal by the district, as to secure the best privilege for all.

The general quality of the work accomplished in our schools during the past year will compare favorably with that of other years. The work of our teachers is in most cases hard, requiring a good amount of energy and application on their part and they are deserving of much credit for faithful service.

To the inhabitants of the school district in the town of Swanzey qualified to vote in district affairs: You are hereby notified to meet at the town house in said district on the twelfth day of March, 1907, at two o'clock in the afternoon, to act upon the following subjects:

1—To choose a moderator for the coming year.

2—To choose a clerk for the ensuing year.

3—To choose a member of the school board for the ensuing three years.

4—To choose a treasurer for the ensuing year.

5—To hear the reports of agents, auditors, committees, or officers chosen, and pass any vote relating thereto.

6—To choose agents, auditors and committees in relation to any subject embraced in this warrant.

7—to see how much money the district will raise and appropriate for the support of schools.

8—To see how much money the district will raise for the support and repair of school property.

9—To see if the district will vote to furnish single desks in the No. 5 schoolhouse, so called, in place of the double desks there in use, and raise money for that purpose.

10—To see if the district will vote to authorize the school board to unite with one or more town districts, or special districts, to form a supervisory district for the purpose of employing a super-

THE STATE OF NEW HAMPSHIRE.

To the inhabitants of the town of Swanzey, in the county of Cheshire, in said state, qualified to vote in town affairs :

You are hereby notified to meet at town house in said Swanzey on Tuesday, the twelfth day of March next, at nine of the clock in the forenoon, to act upon the following subjects :

1—To choose all necessary town officers for the year ensuing.

2—To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same. For town charges, support of poor, support of schools, repairs of highways and bridges and supplies for schools.

3—To see if the town will accept state aid for state road and raise money for the same.

4—To see if the town will vote to raise money to pay any part of the town debt.

5—To see if the town will vote to raise money for decorating soldiers' graves.

6—To see if the town will vote to observe Old Home Week and raise money for the same.

7—To see if the town will vote to raise a sum of money to improve Richardson Park.

8—To see if the town will vote to raise one hundred dollars for the support of the Stratton Library for the year ensuing.

9—To see how much money the town will vote to raise for care of cemetery.

10—To see if the town will vote to build a town hall in West Swanzey and raise money for the same, and dispose of the town hall at Swanzey Centre.

11—To see if the town will vote to raise five hundred dollars a year for five years to light the streets of East Swanzey and Swanzey Centre, and instruct the selectmen to contract for same.

12—To see if the town will vote to have one or more electric lights near the hotel at Swanzey Factory and raise money for the same.

13—To see if the town will vote to run the electric light wire to the village of Westport, light the streets and raise money for the same.

14—To see if the town will vote to have a police court situated in the village of West Swanzey.

16—To see if the town will vote to discontinue the highway from the Lyman Stone place to the road which passes Chester Lane's house.

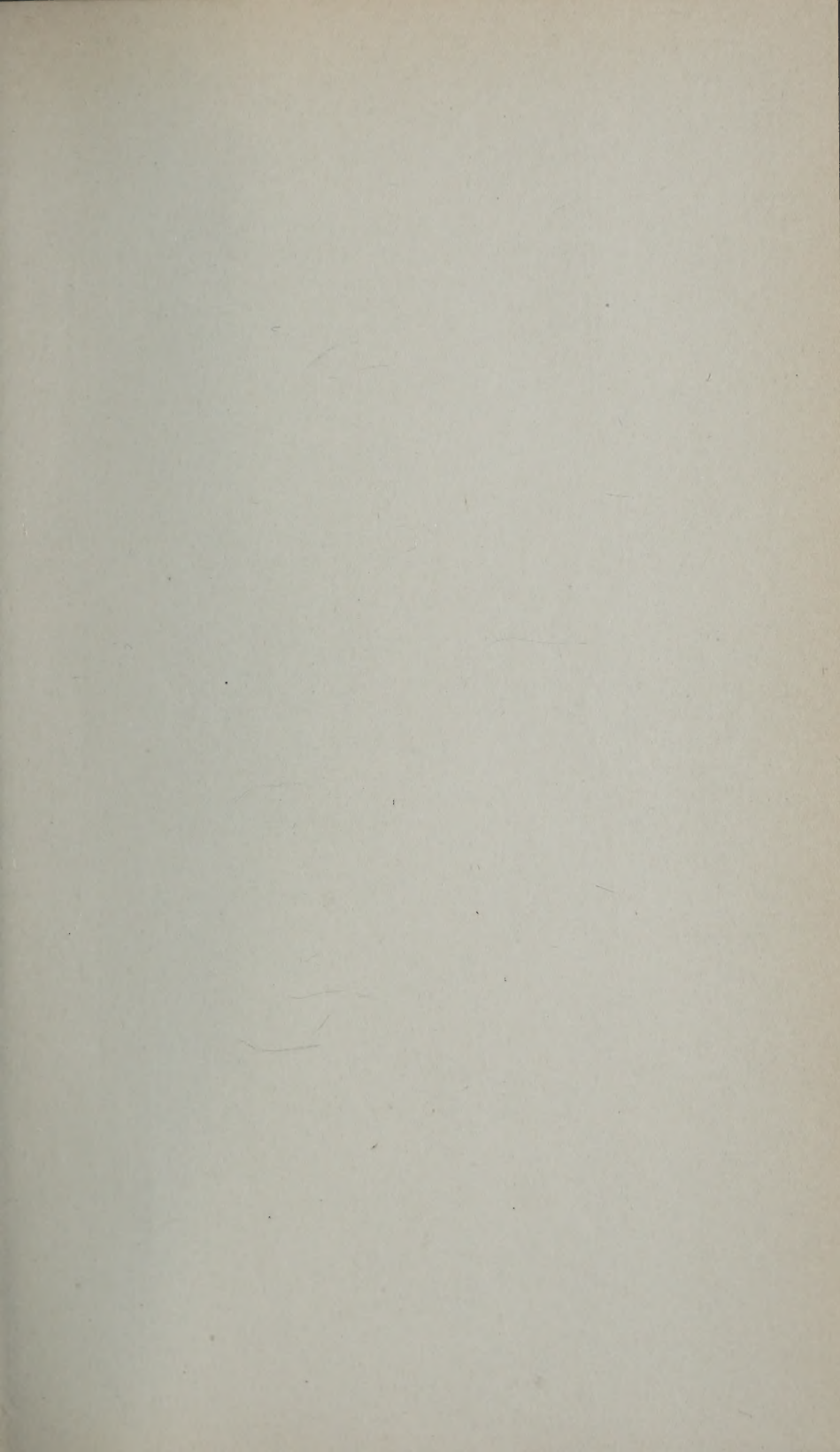
