

SELECTMEN'S REPORT

The year 1991 was a difficult economic one for the Town of Conway. Your Selectmen have recognized the problems we all have making ends meet, especially when times are hard. The Town has responded by making every effort to spend your dollars wisely and to economize where possible. We have reduced staff by not filling some positions when vacated by retirement, and transferring employees when appropriate. However, the year of 1991 is only one year in the 226 of the Town's existence, and things will get better.

In 1991 several projects begun earlier were completed. We are now using the new secure lined solid waste landfill. This will help us to control our costs for rubbish disposal. Over the years there were many hours of planning put into the project and it has been satisfying to see the construction completed. We also had the pleasure of participating in the refurbishing of the Swift River Covered Bridge. It was opened in late spring for foot traffic and represents the townspeople's resolve to remember its historic roots.

In addition to the day to day problems with which the Selectmen deal, there have been special projects which we have worked on such as the Citizens Advisory Task Force, formed to help solve our valley traffic problems; the Mount Washington Valley Economic Council which has been addressing the current business needs and the valley's need to diversify its employment base; and the North Conway Sewer Project, the completion of which is necessary to the entire Town. Because fire protection in the Town is by statute the responsibility of the Selectmen, we have been working toward townwide fire. While we believe that the precincts and districts are doing a fine job, we know that as Conway grows it will need the supervision which a townwide chief will give.

We are disappointed that the "Zodiac Way" connector road was not constructed in 1991, but hope it will be this spring. And finally, the Superfund clean up process for the Kearsarge Metallurgical site will begin early in 1992. The Town will continue work on these and other projects in 1992.

We hope that we have been responsive to you and your needs. We are **your** Selectmen.

CONWAY TOWN WARRANT STATE OF NEW HAMPSHIRE

TO THE INHABITANTS OF THE TOWN OF CONWAY, County of Carroll, in the State of New Hampshire, qualified to vote in Town Affairs:

You are hereby notified to meet at the Karl Seidenstuecker Auditorium at Kennett High School, Conway, New Hampshire, on Tuesday, the tenth day of March, 1992, at eight o'clock in the forenoon to act upon the following subjects hereinafter set forth. Voting on Articles 1 through 17 will be by official ballot, and the polls shall open for balloting at eight o'clock in the forenoon or as soon thereafter as the Moderator calls the meeting to order and declares a quorum present. The remaining articles of the Warrant shall be acted upon at seven o'clock in the evening or at the closing of the polls if the meeting shall vote to keep the polls open to a later hour.

ARTICLE 1. To choose all necessary officers.

ARTICLE 2. To see whether or not the Town will vote to adopt Amendment No. 1 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-6, 147-11, 147-11.1, 147-11.2, 147-12, 147-13, 147-14, and 147-14.1 by defining commercial excavation and specifying in which zoning districts it is permitted and in which it is prohibited.

ARTICLE 3. To see whether or not the Town will vote to adopt Amendment No. 2 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provision of Conway Code 147-11.A to permit hospitals in the Residential/Agricultural District.

ARTICLE 4. To see whether or not the Town will vote to adopt Amendment No. 3 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provision of Conway Code 147-6 by deleting existing definitions for "residential structure or unit" and "structure" and adding new definitions for "unit," "residential unit," and "structure."

ARTICLE 5. To see whether or not the Town will vote to adopt Amendment No. 4 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-6 and 147-14 by adding new definitions and clarifying restrictions in the Foodplain Conservation District as required to continue compliance with the National Flood Insurance Program.

ARTICLE 6. To see whether or not the Town will vote to adopt Amendment No. 5 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-12.A and 147-12.B to eliminate the special exception process and creating a simplified process for establishing Home Occupations in the Business Districts.

ARTICLE 7. To see whether or not the Town will vote to adopt Amendment No. 6 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-6 and 147-19 by clarifying the language and definitions of the sign regulations.

ARTICLE 8. To see whether or not the Town will vote to adopt Amendment No. 7 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-19 to increase permitted wall sign message area for small businesses, to permit certain additional wall signage for businesses with multiple entrances, to prohibit A-frame signs, to permit larger sign support structures and bases if natural materials are used, to permit the use of "open" flags, and to require a state sign permit where applicable.

ARTICLE 9. To see whether or not the Town will vote to adopt Amendment No. 8 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-6 and 147-19 to create incentive bonuses for conforming signs to utilize up to 20% of the message area for changeable copy, to permit increased freestanding sign message area on a lot with a conforming freestanding sign and large road frontage, to permit increased wall sign message area on a site with a conforming freestanding sign, and to permit increased wall sign message area on a site which has a conforming freestanding sign and which provides extra front buffers.

ARTICLE 10. To see whether or not the Town will vote to adopt Amendment No. 9 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-11, 147-12, 147-20 and 147-21 to expand the Center Conway Village Commercial Zone and to modify the permitted uses therein, and to establish and create regulations for a Center Conway Village Residential Zone.

ARTICLE 11. To see whether or not the Town will vote to adopt Amendment No. 10 as proposed and recommended by the Planning Board for the Town Zoning Ordinance deleting provision section of Conway Code 147-20.1 which is a duplicate definition of the Shoreline Protection District boundaries.

ARTICLE 12. To see whether or not the Town will vote to adopt Amendment No. 11 as proposed and recommended by the Planning Board for the Town Zoning Ordinance creating a new provision of Conway Code 147-13.1 to establish a Groundwater Protection Overlay District which restricts land use activities within 400 feet of municipal water system wells.

ARTICLE 13. To see whether or not the Town will vote to adopt Amendment No. 12 as proposed and recommended by the Planning Board for the Town Zoning Ordinance amending provisions of Conway Code 147-6 and 147-11 to permit a non-municipal educational facility by Special Exception in the Residential/Agricultural District.

ARTICLE 14. To see whether or not the Town will vote to adopt Amendment No. 13 as proposed and recommended by the Planning Board for the Town Fire Suppression Sprinkler System amending provision of Conway Code 91-3.B (8) to exempt certain low risk use group structures from the requirement to install sprinkler systems.

ARTICLE 15. To see if the Town will vote to increase the Board of Selectmen to five (5) members. To be acted on by official ballot of the Town. Agreeable to a petition by Wanda Snow & others.

ARTICLE 16. To see if the Town will vote to conduct election of Town Officers and other action required to be on the official ballot on the second Tuesday in March and authorize the Board of Selectmen to set a date for a second session for transaction of other business. To be acted on by official ballot of the Town.

ARTICLE 17. To see if the Town will vote to approve a New Hampshire Legislative Amendment to an act establishing a Police Commission for the Town of Conway, Chapter 570:2, authorizing the Commission to appoint civilian or nonsworn staff as well as sworn police officers. To be acted on by official ballot of the Town.

ARTICLE 18. To see if the Town will vote to raise and appropriate the sum of Seventy Five Hundred Dollars (\$7,500) to conduct an ARCHITECTURAL STUDY OF THE TOWN HALL to determine the cost and feasibility of renovations. Not Recommended by the Budget Committee (2-8-0).

ARTICLE 19. To see if the Town will vote to assume responsibility for STREET LIGHTS WITHIN CONWAY VILLAGE FIRE DISTRICT (effective April 1, 1992) and raise and appropriate the sum of Twenty Four Thousand Dollars (\$24,000) for maintenance of the 200 existing lights, upon approval of the District. Recommended by the Budget Committee (9-3-0).

ARTICLE 20. To see if the Town will vote to raise and appropriate the sum of Twenty Six Hundred Dollars (\$2,600) and to assume responsibility for maintenance of 41 STREET LIGHTS WITHIN CENTER CONWAY LIGHTING PRECINCT, effective July 1, 1992, upon approval of the Precinct. Recommended by the Budget Committee (9-3-0).

ARTICLE 21. To see if the Town will vote to assume responsibility for STREET LIGHTS OF THE KEARSARGE LIGHTING PRECINCT, within the Town of Conway, effective April 1, 1992, and to raise and appropriate the sum of Three Thousand Four Hundred Dollars (\$3,400) for the maintenance of the 43 existing street lights, upon approval of the Precinct. Recommended by the Budget Committee (9-3-0).

ARTICLE 22. To see if the Town will vote to assume responsibility for STREET LIGHTS WITHIN NORTH CONWAY LIGHTING PRECINCT, effective April 1, 1992, and to raise and appropriate the sum of Nineteen Thousand Dollars (\$19,000) for the maintenance of the 169 existing street lights, upon approval of the Precinct. Recommended by the Budget Committee (9-3-0).

ARTICLE 23. To see if the Town will vote to assume responsibility for STREET LIGHTS OF THE INTERVALE LIGHTING PRECINCT, within the Town of Conway, effective April 1, 1992, and to raise and appropriate the sum of One Thousand Three Hundred Fifty Dollars (\$1,350) for the maintenance of the 19 existing street lights, upon approval of the Precinct. Recommended by the Budget Committee (9-3-0).

ARTICLE 24. To see if the Town will vote to raise and appropriate a sum up to Sixty Five Thousand Dollars (\$65,000) to hire an independent engineering consultant to assist a task force in evaluating viable cost effective wastewater treatment alternatives for the NORTH CONWAY SEWER TREATMENT FACILITY PROJECT AND TOWN SEPTAGE TREATMENT. Recommended by the Budget Committee (9-1-0).

ARTICLE 25. To see what sums of money the Town will vote to raise and appropriate for the following purposes:

ARTICLE 26. To see if the Town will vote to authorize the Selectmen to allocate the One Hundred Fifty Nine Thousand Four Hundred Ninety Five Dollars (\$159,495) proceeds from the sale of the OLD POLICE STATION to the general fund of the Town to become surplus and applied in reduction of taxes in 1992 as recommended by the Selectmen.

ARTICLE 27. To see if the Town will vote to raise and appropriate the sum of Twenty Thousand Dollars (\$20,000) for the purpose of erecting and placing the ROLL OF HONOR at the site approved by the School Board and others on the Kennett High

School lawn. Agreeable to a petition signed by Arthur E. Hale and others. Not Recommended by the Budget Committee (5-7-1).

ARTICLE 28. To see what action the Town will take with regard to the MOVING OF THE ROLL OF HONOR located at the intersections of Routes 16 and 302 to the site approved by the School Board and others, on the southwest side of the Kennett High School lawn. Agreeable to a petition signed by Arthur E. Hale and others.

ARTICLE 29. To see if the Town will vote to raise and appropriate the sum of Four Thousand Dollars (\$4,000) to assist the MT. WASHINGTON VALLEY ECONOMIC DEVELOPMENT COUNCIL in developing economic policies and action designed to provide balanced long range economic planning and development for the valley towns. Not Recommended by the Budget Committee (1-5-4).

ARTICLE 30. To see if the Town will vote to raise and appropriate the sum of Twenty Three Thousand Five Hundred Dollars (\$23,500) to establish a CAPITAL RESERVE ACCOUNT FOR FUTURE CLOSURE OF THE NEW LINED SOLID WASTE LANDFILL. Recommended by the Budget Committee (10-0-0).

ARTICLE 31. To see if the Town will vote to raise and appropriate the sum of Ninety Six Thousand Dollars (\$96,000) to establish a CAPITAL RESERVE ACCOUNT FOR THE EXPANSION OF THE NEW LINED SOLID WASTE LANDFILL. Recommended by the Budget Committee (10-0-0).

ARTICLE 32. To see if the Town will vote to raise and appropriate the sum of Twenty Thousand Dollars (\$20,000) for TESTING OF MONITORING WELLS and engineering design of a CLOSEOUT PLAN FOR THE OLD LANDFILL AND SEPTAGE LAGOONS, this sum to be placed in the Long Term Solid Waste Solution Capital Reserve Fund. Recommended by the Budget Committee (10-0-0).

ARTICLE 33. To see if the Town will vote to authorize the Selectmen to ACCEPT SOLID WASTE FROM THE TOWNS OF FRYEBURG, STOW AND CHATHAM at the Town's Solid Waste Facilities in accordance with the Lower Mt. Washington Valley Solid Waste District by-laws and other conditions acceptable to the Board of Selectmen.

ARTICLE 34. To see if the Town will adopt the following Town Ordinance pursuant to its general powers under RSA Chapter 31:

HOUSE NUMBERING

The owner of every lot of land within the Town with a building thereon which has been assigned a number for

identification pursuant to a policy adopted by the Board of Selectmen, shall conspicuously display the identification number permanently affixed on the outside of the building facing the street, and if an entrance is located on the building facing the street the identification number shall be permanently affixed on or near the entrance. The location and size of the identification number shall be sufficient to enable the public and operators of its safety equipment to identify by number each lot with a building. Owners who violate this ordinance and regulations promulgated hereunder by failing to affix or fail to conspicuously affix identification numbers to one's building after notice by the Town shall be guilty of a violation and punished by a fine up to \$50.00 for each offense.

ARTICLE 35. To see if the Town will vote to REALIGN WEST SIDE ROAD AT THE CROSS FARM to provide a safer curve alignment, with funds to be expended from the West Side Road Capital Reserve Account and the work would be performed by Town forces. A portion of the Cross Farm, Map 11, Parcel 20, would be utilized in this project.

ARTICLE 36. To see if the Town will vote to authorize the Board of Selectmen to borrow up to One Hundred Thousand Dollars (\$100,000), to be repaid over a period of three years, to RE—CONSTRUCT 3,200 FEET OF TASKER HILL ROAD from Quint Street to the Madison town line, on terms and conditions to be determined by the Board of Selectmen. Recommended by the Budget Committee (9-0-1).

ARTICLE 37. To see if the Town will vote to authorize the Board of Selectmen to expend funds from the Traffic & Road Improvement Capital Reserve Account to compensate landowners for eminent domain takings for highway purpose at ZODIAC WAY/COMMON COURT approved by the voters in special session October 8, 1991, and to declare Zodiac Way from Route 16 to the connector road, a portion of Common Court and all The Fairway, and a portion of Mountain Valley Mall Blvd., to Route 302 to become public roads pursuant to RSA 231:51 on final acceptance and recording of dedication by the Selectmen.

ARTICLE 38. To see if the Town will vote to accept a gift of a deed from the Conway School District for the OLD PINE TREE SCHOOL property in Center Conway.

ARTICLE 39. To see if the Town will vote to REOPEN OLD RT. 16 between Rt. 16 and Rt. 302 north of Pine Hill as a Class V Town highway, a distance of approximately 1500 ft., with funds to be expended from the Traffic & Roads Improvement Capital Reserve Account and the work to be performed by the Town forces.

ARTICLE 40. To see if the Town will vote to authorize the Selectmen to accept a GIFT OF LAND LOCATED ADJACENT TO KENNETT HIGH SCHOOL bordering Route 16 to the south and the Swift River to the north, consisting of 38+/- acres (a portion of Map 7, Parcel 48) to be used for recreation and conservation purposes, and further authorize the Selectmen to accept and expend a Twenty Five Thousand Dollar (\$25,000) matching Federal Grant as consideration for a partial interest in the land.

ARTICLE 41. To see if the Town will vote to designate GREELEY ROAD and LEAVITT ROAD in South Conway, and LITTLE CHATHAM ROAD in East Conway, as highways to summer cottages under RSA 231:79-81, allowing seasonal closing and posting of the road by the Selectmen from December 10 to April 10.

ARTICLE 42. To see if the Town will vote to RELOCATE A PORTION OF BAIRD HILL ROAD subject to the following procedure:

(a) To initially remove the scenic road designation from that portion of Baird Hill Road as it runs from its junction with the northerly boundary of land of Highfields Farm, Inc. to its junction with the southerly boundary of land of Highfields, Inc.

(b) To then relocate that portion of the roadway as described in subparagraph (a) above onto other land of Highfields Farm, Inc., on such terms and conditions as may be established by the Board of Selectmen, so long as the same is at no expense to the Town, with all such costs to be borne by Highfields Farm, Inc.

(c) Upon completion of construction of the relocated roadway to the full satisfaction of the Board of Selectmen, to authorize the Selectmen to accept an Easement Deed for the relocated roadway and correspondingly to convey to Highfields Farm, Inc. a Quitclaim Deed from the Town for its interest in the old roadway, subject to an easement of passage from its southerly end to the entrance to Labrador Pond Road, a Class VI highway of the Town.

(d) Upon acceptance of the Easement Deed, to thereafter designate the then relocated portion of Baird Hill Road as a scenic road, pursuant to the provisions of RSA 231:157, without further Town Meeting vote.

ARTICLE 43. To see if the Town will accept the HENRY COTTON ROAD to the intersection of Hiram Philbrook Road in

the Davis Hill subdivision as a Town road. Said right of way being 66 feet in width and approximately 1,027 feet long. Agreeable to a petition signed by John Walter Macdonald and others.

ARTICLE 44. To see if the Town will accept HIRAM PHIL—BROOK ROAD in the Davis Hill Subdivision as a Town road. Said right of way being 66 feet in width and approximately 2,212 feet long. Agreeable to a petition signed by John Walter Macdonald and others.

ARTICLE 45. To see if the Town will authorize the Selectmen to enter into a lease agreement with the Edith Whitaker Bancroft Heirs for that portion of Map 19, Parcel 13, zoned residential, meaning the WHITAKER BANCROFT HOMESTEAD LOT, under the following conditions:

1. Lease term of five (5) years, subject to cancellation by the Lessor. Said cancellation cannot be disruptive to that year's ski season, or any other scheduled event, if in progress. Lease payment to be refundable on a pro rata basis.
2. Allowed use will be for passive recreation only.
3. Lessor to allow current uses (sleigh rides and hay rides) to continue provided there is a minimum of conflict of overlapping use.

And further, to see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars (\$5,000) for the first annual payment with the subsequent year's payments to be increased by Five Hundred Dollars (\$500) each year. Agreeable to a petition signed by Chester B. Lucy and others. Not Recommended by the Budget Committee (0-12-0).

ARTICLE 46. To see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars (\$5,000) to defray the operating expenses of the services and programs as carried out by the MT. WASHINGTON VALLEY CHAPTER OF THE AMERICAN RED CROSS. Agreeable to a petition signed by Donald M. Ekberg and others. Recommended by the Budget Committee (10-2-1).

ARTICLE 47. To see if the Town will vote to raise and appropriate the sum of Seventeen Thousand Six Hundred Dollars (\$17,600) for the support of the CHILDREN AND YOUTH PROJECT OF MT. WASHINGTON VALLEY. Agreeable to a petition signed by Evelyn B. Dole and others. Recommended by the Budget Committee (12-0-1).

ARTICLE 48. To see if the Town will vote to raise and appropriate the sum of Three Thousand Nine Hundred Seventy Dollars (\$3,970) for the Early Intervention Program (birth to 3 years) of CHILDREN UNLIMITED, INC., said sum being equal to \$.50 per person in the Town of Conway. Agreeable to a petition signed by Maryellen LaRoche and others. Recommended by the Budget Committee (7-4-1).

ARTICLE 49. To see if the Town will vote to raise and appropriate the sum of Two Thousand Four Hundred Thirty Eight Dollars (\$2,438) in support of CARROLL COUNTY AGAINST DOMESTIC VIOLENCE AND RAPE'S SHELTER FOR BATTERED WOMEN AND CHILDREN. Agreeable to a petition signed by Susan K. Proctor and others. Recommended by the Budget Committee (12-0-1).

ARTICLE 50. To see if the Town will vote to raise and appropriate the sum of Seven Thousand Thirty Five Dollars (\$7,035) to assist CARROLL COUNTY MENTAL HEALTH SERVICES. Agreeable to a petition signed by Lisa Chandler and others. Not Recommended by the Budget Committee (4-9-0).

ARTICLE 51. To see if the Town will vote to raise and appropriate the sum of One Thousand Three Hundred Dollars (\$1,300) to be used for insurance for the EASTMAN-LORD MUSEUM. Agreeable to a petition signed by Marion L. Putnam and others. Recommended by the Budget Committee (13-0-0).

ARTICLE 52. To see if the Town will vote to raise and appropriate the sum of Three Thousand Dollars (\$3,000) for CONWAY VILLAGE CHAMBER OF COMMERCE to operate and administer the Information Booth, as well as organize the Christmas Parade, the Conway Village Festival, and other activities which benefit the Conway Community. Agreeable to a petition signed by Steven R. Cote and others. Recommended by the Budget Committee (10-3-0).

ARTICLE 53. To see if the Town will vote to raise and appropriate the sum of Three Thousand Dollars (\$3,000) for the MT WASHINGTON VALLEY CHAMBER OF COMMERCE, said funds to be dedicated to the Chamber's Visitor Information Services. Agreeable to a petition signed by Bayard Kennett and others. Recommended by the Budget Committee (9-2-1).

ARTICLE 54. To see if the Town will vote to raise and appropriate the sum of Seven Thousand Five Hundred Dollars (\$7,500) for the support of the EASTERN SLOPE AIRPORT AUTHORITY. Agreeable to a petition signed by Denise Leighton and others. Not Recommended by the Budget Committee (2-11-0).

ARTICLE 55. To see if the Town will vote to raise and appropriate the sum of Seven Thousand Two Hundred Twenty Three Dollars (\$7,223) to assist the FAMILY HEALTH CENTRE. Agreeable to a petition signed by Richard S. Chandler and others. Not Recommended by the Budget Committee (5-6-0).

ARTICLE 56. To see if the Town will vote to raise and appropriate the sum of Twenty Three Thousand Seven Hundred Nineteen Dollars (\$23,719) for support of the GIBSON CENTER FOR SENIOR SERVICES. Agreeable to a petition signed by Helen H. Nute and others. Recommended by the Budget Committee (12-0-1).

ARTICLE 57. To see if the Town will vote to raise and appropriate the sum of Seventy Seven Thousand Five Hundred Four Dollars (\$77,504), said sum to be allocated to the NORTH CONWAY COMMUNITY CENTER Board of Directors. Agreeable to a petition signed by John P. Roberts, Jr. and others. Recommended by the Budget Committee (13-0-0).

ARTICLE 58. To see if the Town will vote to raise and appropriate the sum of Three Thousand Dollars (\$3,000) to the NORTH CONWAY DAY CARE CENTER. Agreeable to a petition signed by Sister Marjorie Moon, S.A. and others. Not Recommended by the Budget Committee (5-8-0).

ARTICLE 59. To see if the Town will vote to raise and appropriate the sum of Twenty Eight Hundred Dollars (\$2,800) for the support of the COMMUNITY ACTION OUTREACH PROGRAM. (Recommended by the Budget Committee - 12-0-1.) Also to see if the Town will vote to raise and appropriate the sum of Two Hundred Dollars (\$200) for the support of the BIG BROTHER/BIG SISTER ORGANIZATION administered also by the Tri-County Community Action Program. Agreeable to a petition signed by Carolyn Brown and others. (Not Recommended by the Budget Committee.)

ARTICLE 60. To see if the Town will vote to raise and appropriate the sum of Ten Thousand Four Hundred Forty Dollars (\$10,440) for the VISITING NURSE SERVICES OF NORTHERN CARROLL COUNTY, INC. Agreeable to a petition signed by Carol A. Benson and others. Recommended by the Budget Committee (12-0-1).

ARTICLE 61. To see if the Town will vote to authorize the Selectmen to hire upon the credit of the Town such sums of money as may be needed, such sums not to exceed the combined town, school and county tax budgets, in anticipation of town, school and county purposes.

ARTICLE 62. To see if the Town will vote to authorize the

Selectmen, in behalf of the Town of Conway, NH to accept gifts and/or Federal or State aid in the name of the Town of Conway, NH applied for, and to receive and expend them in accordance with the purposes thereof.

ARTICLE 63. To see if the Town will vote to authorize the Selectmen to withdraw Capital Reserve Funds established by the Town from time to time, and disburse the same in accordance with the purposes for which such funds were created respectively.

ARTICLE 64. To see if the Town will vote to authorize the Selectmen to sell, at their discretion, at public auction, any real estate in the Town to which the Town has title by Collector's Deed; except when it is being sold back to the former owner, or to a party who has succeeded to the title of the former owner, in which case private sale may be utilized; any such real estate to be sold and conveyed on or before the next annual Town Meeting.

ARTICLE 65. To act upon any other business that may legally come before said meeting.

These financial statements are the responsibility of the Town's management. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

As described in Note 1 B, the general purpose financial statements referred to above do not include the General Fixed Asset Account Group, which should be included to conform with generally accepted accounting principles. The amount that should be recorded in the General Fixed Asset Account Group is not known.

In our opinion, except that omission of the General Fixed Asset Account Group results in an incomplete presentation, as explained in the above paragraph, the general purpose financial statements referred to above present fairly, in all material respects, the financial position of the Town of Conway as of December 31, 1990, and the results of its operations (and cash flows of nonexpendable trust funds) for the year then ended in conformity with generally accepted accounting principles. Also, in our opinion, the combining and individual fund financial statements referred to above present fairly, in all material respects, the financial position of each of the individual funds of the Town as of December 31, 1990, and the results of operations of such funds for the year then ended in conformity with generally accepted accounting principles.

In lieu of a personal report, your Assessor has chosen to use the following excerpt from the NH Association of Assessing Officials' Newsletter - Jan./Feb. 1992, which may help explain the situation which is currently existing throughout the State.

ASSESSMENT IN A DECLINING MARKET


From 1983 through 1989 not one person asked the Assessors to increase assessed values to accurately reflect market value. The reason is obvious: people think that higher assessments mean higher taxes. In 1990, on the other hand, the Assessors are under siege by people seeking to have their assessments lowered. Once again, the reason is obvious: people think that lowered assessments mean lower taxes.

The fact of the matter is taxes are the direct result of Town Meeting votes. If the Town Meeting vote results in a budget that requires \$20,000,000, and the total assessed town value is \$2,000,000,000 then the tax rate will be \$10.00 per thousand ($\$20,000,000/\$2,000,000,000 = .01$, or \$10 per thousand). If the assessed value were lowered by 10% to \$1,800,000,000 the tax rate would be \$11.11 per thousand ($\$20,000,000/\$1,800,000,000 = .01111$, or \$11.11 per thousand). In both cases the tax levy remains the same. As the town's assessed value decreases there is a direct increase in the tax rate.

The problem, to a certain extent, is psychological. First of all, people do not enjoy paying taxes and they like it even less if they know that their house is assessed for more than they could sell it. From the assessor's point of view, townspeople should consider the accuracy of their assessments by comparing them to the assessments, and not the market values, of comparable properties throughout town. It is no more likely that assessments during the interim years (between revaluations) 1991 and 1992 will reflect market value than it was during the interim years 1985 and 1986. Unfortunately, the number of abatement applications indicates that people are looking at market values rather than assessments when deciding whether or not to file for an abatement.



TOWN MANAGER'S REPORT

Even in a period of economic difficulty we must carry on with our responsibilities to provide quality municipal services. We must further provide leadership which includes planning for the future through such methods as capital planning and reorganization, while examining our priorities and spending habits to reduce and control costs.

The municipal tax rate has been reduced each of the last two years and the 1992 budget does not require an increase in the tax rate either. Restraining new spending is difficult but critical, as we are not likely to soon acquire new sources of revenue, and further tax increases are damaging to taxpayers with declining incomes and property values.

A period of economic recession such as we are in does allow us time to examine our priorities and plot a future course for our community. While we have made mistakes and missed opportunities in the past, we do not have to accept living with them or adopt a defeatist attitude. For example, we can work to assure that the current bypass studies result in solutions and value to the community. We can cooperate to build a sewer treatment plant in North Conway to protect our precious investment. In short, we can and must look beyond our current financial limits to solve problems. As President Lincoln said in 1862, "We must think anew." The next few years will not be without pain, but we can prevail.

We can be thankful for the many blessings we do have, and seek to cooperate to save money and learn from the many lessons offered by the fast growth 80's and hard times 90's. Above all, we are fortunate to live in a place where honesty, thrift, ingenuity and hard work are common descriptions of our public employees and residents alike.

I would like to thank the wonderful people of Conway for the opportunity and pleasure of serving you for the past nine years. May God bless you.

1991 ADMINISTRATIVE ASSISTANT'S REPORT

GENERAL ASSISTANCE

1991 has been an incredible year with respect to general assistance expenditures. Historically, as the economy declines, the general assistance needs of a community rises; and the year 1991 has shown no exception to this tradition. 1991 actual expenditures exceeded the appropriated \$45,000 by 22% in the amount of \$64,866.

Several factors contributed to this increase: employment layoffs and cutbacks; the delays of the extended unemployment benefits program; and the most severe impact on the town's taxpayers was the cutbacks and delays of the Federal Fuel Assistance Program monies being released to the community. Requests for fuel assistance monies in the months of November and December created an extra burden on the town funds.

On the bright side, the Department of Human Service's (State Welfare) unemployment parent program and the close interaction of my office with the community's social service agencies kept the budget override down to 22%. Without these efforts, the increase would have been greater.

ZONING

Applications have not been at such a feverish pace as in previous years with the economic drain on business slowing expansion and change; but the sign violations remain even with previous years because merchants are attempting to justifiably attract the consumer dollar.

I'd like to take this opportunity to share with the community my gratitude to the Town Manager, Curt Lunt, for taking me "under his wing" and showing me his patience and understanding in my growth process. It has been a professional pleasure to work with him on "all those special projects" and I will miss his support.

PLANNING BOARD REPORT

The recession was clearly reflected in the number and type of development applications before the board in 1991. With a few exceptions, applications related mostly to minor site changes of commercial property. The reduction in the number of applications gave us more time to do planning, however.

The Master Plan, Conway's main growth and development strategy, is being updated. This year, five chapters were adopted. Perhaps the most significant chapter is the Center Conway Village Report. It is unique because it is the first time that the Planning Board has created a plan for the unique needs of one village. Conway, North Conway and Redstone will also receive village plans in the upcoming years. In addition to writing the Master Plan reports, much time is dedicated to implementation. There is no need for another "shelf document." Where possible, policies or actions recommended in the plan are made the responsibility of a specific person or organization, and time deadlines are given. Results are important.

The big regulation change worked on during 1991 is the sign ordinance. Working with a group of the Town's business leaders, we were able to re-write the existing sign ordinance in a manner which makes it much easier to read and understand while keeping the existing policies. Several policy changes are also being presented for consideration--changes which are responsive to the needs of the business community but which still strive for the quality environment so vital to the long term prosperity of our tourist economy.

The Capital Improvements Program (CIP) was updated again. The CIP is offered to the Selectmen, the Budget Committee, and the citizens of Conway as advice for the Town's biggest expenditures of tax money. Over time, the Town needs to acquire new facilities, property, and equipment--sometimes because of economic or population growth, and sometimes because of the need for replacement or upgrading. The CIP helps guide current spending by allowing budgeters to look six years into the future to foresee major expenses on the horizon. It is very similar to a family's budget, except on a bigger scale. By knowing what expenses will be arising in the near future, the Town can better set fiscal priorities today, and can help stabilize tax expenditures (which helps stabilize taxes). This year, for example, four different requests for bond issues totaling 3.57 million dollars were requested for 1993. The Planning Board recommended alternative funding for one measure and recommended pushing another back two years, thereby reducing 1993 funding recommendations to 2.12 million dollars.

Because their capital projects affect the Town's financial capabilities (our bond rating) and the future growth and development of the Town, it is essential for the Planning Board to work more closely with the precincts. The CIP recommendations are not binding on the precincts, but it is our hope that we can help each other in a spirit of cooperation.

Another Planning Board initiative is the new Streamlining Committee which will begin work in March. Together with the Board of Selectmen and local development professionals, the Board will investigate means of streamlining all its application processes to save applicants time and money.

In closing, we say goodbye to Kathy Szympruch, the Planning Board's recording secretary for 12 years, and hello to Stephanie Franz, our new recording secretary.

TOWN BUILDING, HEALTH, AND SEPTIC SYSTEMS INSPECTOR'S REPORT

Although the economy was in a downward trend in 1991, Building Permits and fees collected were up over the previous year.

Total permits issued by this office numbered 332. Included in these permits were 32 single family units, 180 residential permits and 120 commercial permits.

Total building inspections performed in 1991 were 1105. There were 161 complaints received and acted upon, 142 code violations were found, 13 stop work orders issued, 4 field correction notices were issued, and 11 fines levied and collected.

As Health Officer I received 109 health related complaints for a total of 180 man hours. Most complaints are received at night time and on weekends when the general public is at home. I am glad to say that all complaints received were acted upon and resolved to the satisfaction of all parties involved.

As Septic Inspector I received 45 septic design plans, which were mostly single family homes. These plans have to be reviewed and approved before being sent to Concord for State approval.

It has been my pleasure to serve the Town of Conway for the past 4 1/2 years and I hope to continue in the future to make the Town a safer and better place to live, for both the residents and the people visiting our great town.

This year we have been busy as we have been in the past, even with a temporary slow down of new buildings. Over 1,000 inspections were performed in 1991 and over 2,500 code violations found, some of them minor. On the major violations we are working with the owners of the buildings to bring them into compliance.

This year we have also been working with the Elementary Schools on fire prevention. Wayne Derouin and I have worked with the three schools from Kindergarten through Grade 6 and we have seen the positive results of this effort.

The house numbering project for the Town roads is almost complete and should be in place this year. This should help all of the emergency services to serve the townspeople more efficiently.

REPORT OF THE CHIEF OF POLICE

The 1991 Automatic Traffic Recorder Report, sent out by the New Hampshire Department of Transportation, shows that the recorder, located by the Mall lights on the Strip, registered an increase in traffic during the months of April, May, and December. The recorder was not working from June to October and the remaining months showed a decrease in traffic. I believe that some of the decrease in traffic on the Strip, for those months, was due to the use of the West Side Road during the sewer construction. The West Side Road had a tremendous increase in traffic during 1990 and 1991. In June we hired a traffic control unit. The unit consisted of three people. They were as follows: Erin Gasper, Harold Stevens, and Special Officer Mark Waltz. Mark had to leave in August to go back to college in Virginia and was replaced by Mary Thompson. I would like to express my sincere thanks to these four people for a job well done.

The Conway Police Department Prosecutor, Christopher Perley, reports that the department had a very successful year in the Courts. There were 1,189 Court appearances generated by the Conway Police Department and we convicted 1,088 or 97.9% of the cases. The above does not include minor motor vehicle violations where the offenders are allowed to enter a plea by mail. The police department also generated the following monies for the State of New Hampshire and victims, through fines and penalty assessments, and victim restitutions. The total amount through contested offenses, appearance pleas and restitutions amounted to \$132,470.80. The plea by mail offenses amounted to \$100,000.00, for a total of \$232,470.80. The police department also collected, and returned to local merchants, approximately \$15,000.00 in restitutions for bad checks.

Kennett High School received a grant through the Governor's Drug Free School Program that will allow off duty police officers and other community members to go into our schools to assist in programs. There are eight valley police officers involved in this police prevention team and six are from the Conway Police Department. Sergeant Jeff Dicey has become certified as a Drug Recognition Technician. Jeff is one of eleven in this pioneer group, the first group to become certified in the State of New Hampshire. This is a national program sponsored by the International Association of Chiefs of Police and the National Highway Traffic Safety Administration.

REPORT OF THE CONWAY POLICE COMMISSION

Although the Northeast is in the depths of a long recession, our police activity continues to increase. In fact, calls for service and UCR's (Uniform Crime Reporting) are running near record levels for this department. It is interesting to note that, although Conway ranks 25th in department size for New Hampshire, we are 12th in activity as measured by UCR's.

It is the goal of this Commission to hold the line on spending. By citizen mandate, at last year's Town Meeting, the pay scale was rolled back to 1990 levels for the entire staff of our department. Our proposed 1992 budget continues this order. There are some areas beyond our control that continue to increase. Mostly they fall in the "benefit" area of the budget and include professional liability insurance and health insurance. We are currently negotiating with the police union to establish a new contract and, hopefully, some compromise can be reached on sharing the costs of health insurance, as has been requested by our Governor for all workers at State, County and Municipal levels.

While we normally replace two cruisers one year and three the next, we are proposing to purchase only one vehicle in 1992. This necessitates an increase in the maintenance account, but we expect the overall effect will be beneficial in holding down taxes.

Except for adding three 911 Dispatchers in 1988 and temporary traffic control people, our staff has remained at 1986 levels and in this year's budget, we have eliminated one patrolman position.

The Commission meets regularly every other Monday to go over the officers' daily reports, to review and approve all payables for the two week period, and to discuss administrative problems and plans.

We hope you, the citizens of Conway, are satisfied with the performance of our department. We have state of the art equipment, work out of a modern facility, and are staffed with well trained officers who are dedicated to providing a truly professional response to law enforcement demands. With ongoing training and continuous upgrading of procedures, we strive to make this the best department in the State.

PUBLIC WORKS DEPARTMENT REPORT

1991 was a year of many emotions in the public works department as we balanced some accomplishments with the continued realization of the economic times and the retirement of Bud French.

Among the accomplishments were the opening of the new landfill and the continued success of the recycling program. Coupled together, these programs provide the area with something very few places have, long term solid waste stability. Other accomplishments included the beautification project on West Main Street, the drainage project on Duprey Road, the sidewalk installation on Pine Street and Mill Street, and the progress made on Zodiac Way. Many are discouraged by the latter of these, but the fact that it got designed, approved by the voters twice and came in at a reasonable budget is encouraging. Much time and effort was spent and with one more vote you will be able to use this new road by this summer.

Other good news this year was the Town Meeting's decision to add John Eastman to the Parks and Recreation staff, and the addition of Jack Sandberg as Chief Landfill Operator. Both are excellent at what they do and should be considered an asset to the Town.

During 1991 many projects were eliminated as a result of the times. This coupled with less trash generation due to the economy, resulted in the Public Works Budget ending with a significant surplus. The 1992 budget request follows suit and goes further with the elimination of three positions by the end of the year as well as conservative spending habits. The Selectmen and Town Manager have responsibly cut the budget and leave us with a challenging but livable budget. What will be required of the voters is some understanding that certain programs have been pared back and thus, while it may take us a while to solve your problem, we will get to it.

Lastly, 1991 saw the retirement of Bud French from his position as Highway Foreman. His retirement leaves a large void in this department that will never be fully filled due to Bud's experience and devotion to this Town. Happy Retirement Bud!

CONWAY PUBLIC LIBRARY

Helen Bumstead, long-time friend of the Library, died in September of this year. She served as a Library Trustee for 17 years, and as Chairman for 15 of those years. Her contributions have been immeasurable; she was an inspiration to many. Donations which were made to the Library in her memory totaled over \$2,000.00.

Your public Library is used by one hundred people daily; answers 7,700 reference questions yearly, and circulated 62,330 items (books, magazines, videos, audio cassettes, and cameras) in 1991.

The Library is open 57 hours weekly, including 4 evenings, all day Saturday, and 3 hours on Sunday. It is staffed by three full time and 5 part time employees, and has an automated circulation and on-line card catalog.

Conway Library added over 1,000 new books in 1991, bringing the number of volumes owned to over 24,300; in addition, your library can access nearly 1 million additional volumes in libraries throughout New Hampshire, using an on-line database. The Library issued over 841 new library cards in 1991, and conducted over 100 children's programs, and other activities and performances, to over 1,000 children.

Our History Room Librarian aided over 500 people in researching families, houses, and town events.

The Literacy Center, with the help of many wonderful volunteers, provided adults with the opportunity to improve their basic reading and math skills.

The Library itself is a beautiful building that is a focus in the Town, but it does not provide adequate space for children's activities or for young adult activities. The size of the meeting room is inadequate for many of the programs offered, and there is inadequate work space for the staff. Also, the Henney History room is inadequate to hold all of the records and documents which are currently part of the collection.

Due to a lack of space in the building, there are books being stored in the attic. This practice should not continue for structural and fire safety reasons. In general, the building is filled to capacity and is still falling short of the space required for its present needs.

In an effort to address the issues of lack of space and crowding, the Trustees of the Library have been meeting with Tom Wallace of the architectural firm of Tenant/Wallace, to develop plans for an addition to our Library. It has been determined that the Town would receive more for less money by adding to the present building rather than building a new structure.

We have received donations from many Community organizations to fund the Literacy Program, including a \$4,000.00 grant from the Anna B. Stearns Fund of the Northern N.H. Foundation. An additional \$1,875.00 was received from various other local organizations. We bought large print books and closed captioned videos with a donation given in memory of Harry S. Penberthy.

Our Librarian, Mrs. Margaret Marschner, was elected Vice-President, (President-elect) of the New Hampshire Library Association in May, 1991. We are proud of her, and of the Conway Public Library.

CONWAY CONSERVATION COMMISSION ANNUAL REPORT 1991

Reading over the past twenty years of commission annual reports, one can follow the ever growing complexity of environmental issues facing the town coupled with the expanding responsibilities of the Commission. This past year was no exception, as the seven members of the present Commission worked on a diversity of natural resource projects. The development of a Natural Resource Inventory was this past year's big activity. Other projects included recycling, the highway upgrade and bypass project, town land management and the resurveying of conservation properties.

Town Engineer and Public Works Director, Scott Johnstone, and Town Planner, Steve Burns, continue to be very helpful in assisting the Commission with its many efforts. We are also grateful to the many other town officials and staff, in addition to the many townspeople, who helped us with the following projects:

NATURAL RESOURCE INVENTORY: For the past year the commission has been working with a consultant to develop a natural resource inventory section for Conway's new Master Plan. The Commission reviewed the present Master Plan and made changes and additions to better detail and update the natural resources information for the town including a series of maps with overlays to correspond to the inventory text. This part of the project is close to completion and will be followed by establishing the goals and objectives for the inventory.

RECYCLING: The Commission continues to work closely with the Lower Mt. Washington Valley Solid Waste District to promote and expand the recycling program in Conway. This past spring a backyard composting program was inaugurated with a successful workshop at the solid waste facility. Locally made compost bins and an excellent "how to" manual are available for sale at the facility. This coming spring, community composting for leaves and grass clippings will start at the new landfill. Also coming this spring will be office paper recycling. Conway's recycling program continues to grow thanks to the efforts and support of the community.

TOWN PROPERTIES: The following is a list of projects and activities that have taken place on town properties:

Whitaker Woods, A greatly improved Kearsarge entrance parking area was established and a stone marker noting the town's acquisition of the property was installed by the Pequawket Founda-

tion. A local horse logger was scheduled to begin a small 5 acre selective cut in accordance with the Forest Management Plan for Whitaker Woods, but this was rescheduled for this coming fall due to early snow this year. The Mt. Washington Valley Ski Touring Association continues to do an outstanding job grooming the cross-country ski trails.

Shedd Woods: A new survey of this property has been completed.

Puddin Pond: This underused property is being upgraded with new signs and trail clearing thanks to the efforts of a dedicated group of KHS students

Walker Pond: Damaged signs have been repaired and there has been an increased use by Pine Tree School students and teachers.

Abenaki Property: Thanks to the efforts of Lee Schuh, the Abenaki Property has been entered in the National Register of Historical Places. The Pequawket Foundation installed a plaque to commemorate the donation of this property to the town.

Common Lands: The resurveying of common lands is in progress.

DREDGE AND FILL PERMITS: Due to this year's economic slowdown, the Commission reviewed fewer Wetland Board applications. Several sites were visited to aid in making determinations of impact.

OTHER PROJECTS:

The Commission continued its involvement with the Citizens Advisory Task Force on finding a solution to the local traffic problems.

The Commission sponsored a Greenways Program to involve local groups in the prospects of a local greenway.

The Commission continues its participation in the planning and development of the Nature Conservancy's Green Hills Property.

In the coming year the Conservation Commission will continue to work on projects promoting the conservation, protection and enjoyment of our town's natural resources. We welcome your ideas and participation at our meetings held on the second Tuesday of the month at the Town Hall. Contact any of the following commissioners for more information.

REPORT OF PARKS & RECREATION DIRECTOR

RECREATION HOME TO MOVE:

There is a special article in this year's Town Warrant to move the Parks & Recreation office from the Conway Recreation Center building in Conway Village, which belongs to the Conway Village Fire District, to the old Pine Tree School in Center Conway. This transfer will help the Town of Conway meet the growing recreation needs of the community.

The old Pine Tree School has a multi-purpose gymnasium which will give us more flexibility for programs throughout the day and evenings. Recreation programs will continue to take place, when possible, at both Conway Elementary and Pine Tree Schools.

RECREATION STAFF:

The number of recreation program participants has more than doubled in the last year and a half due to the redistricting of children to the new Pine Tree School in Center Conway and Conway Elementary School. John Eastman was hired in 1991 as a full time Recreation Assistant to help meet the growing needs of our changing community.

PARKS & CEMETERIES:

The parks, town properties and cemeteries were well taken care of in 1991 because of the dedicated park crew of Gene Gray and Chuck O'Brien. They mowed, planted flowers, watered both flowers and trees daily, and took care of rubbish removal in our parks, town buildings and in North Conway Village, along with the general maintenance of these areas. They did a great job.

Some of the other projects completed were: Replacement of all the benches in Schouler Park; Smith Eastman Recreation Area was cleared of brush which opened up this scenic area for a better view of the Saco River; and at the Nasby King Field a new baseball infield was put in at limited cost to the taxpayers because of materials donated by Maurice Frechette and Bernie Quint.

A number of cemeteries have been cleared of brush and mowed on a regular basis. The Sparhawk Cemetery off West Side Road in Conway has been restored by the parks crew, with the assistance of the Union Granite and Marble Co. Eleven stones were replaced and this cemetery was cleared of brush and reseeded.

I would like to thank the people of the Town of Conway for their continued support of the Conway Parks & Recreation Department.

CONWAY PARKS AND RECREATION COMMITTEE REPORT

The nine member committee is appointed for three year terms by the Board of Selectmen. The committee is to be advisory to the Board of Selectmen, shall hold monthly meetings and shall provide both short and long range advice on the following subjects:

- 1) Coordination of existing programs and facilities.
- 2) Acquisition of property for parks and recreation.
- 3) Recreational use of Conservation land.
- 4) Operation and development, including budgets, for existing town facilities and programs.
- 5) Planning for future development of facilities or programs for recreational needs.
- 6) Provide advice to the Board of Selectmen as to federal or state funds available for recreation.

In 1991 the committee completed a recreation inventory of all recreational facilities and activities (public and private) available in the Town of Conway. This information has been given to the Town Planner and will be incorporated into the Master Plan for Conway.

In August of 1990 a preliminary proposal was presented to the Selectmen to investigate a bicycle path system throughout the town. A brochure was developed providing information for land-owners about the uses of the system, liability and easements on their land.

The purpose of the trail system would be for multiple non-motorized recreational uses (walking, jogging, bicycling and cross-country skiing). Trail ways would be developed away from current highways which would provide safe, easily maintained routes for alternate means of transportation for young and old at all levels of ability.

Phase I of the trail system (Redstone area) will be completed and ready for use in early 1992.

Phase II (West Side Road and National Forest) will be given priority in 1992.

A third project involves obtaining a parcel of land (38+/- acres) from the Kennett Company adjacent to Kennett High School, to be used for recreation by Conway School District and the general

community. An article to accept this land as a gift is on the Town Warrant. A \$25,000.00 Federal Land Grant has been approved for developing Little League Baseball fields, soccer field and expansion of the Conway ice rink on this property, only if the voters approve of the land gift at Town Meeting. As funds become available over the next 5 to 10 years, additional opportunities for a track, tennis courts, basketball, playground and picnic shelter may be developed. The Recreation Committee will be looking to civic organizations and others to help provide funding for such opportunities. This project will be a community effort to meet the area's expanding recreational needs.

The committee welcomes ideas and suggestions from Conway residents regarding town wide recreational opportunities. We meet the 1st Tuesday of the month in Conway.
