REPORT OF SCHOOL BOARD.

The attention of the voters is called to an amendment made to the Public Statutes at the General Court. "The fiscal year of town and special school districts beginning Feb. 16, 1917, shall end Aug. 31, 1918, and thereafter the fiscal and scholastic year shall end Aug. 31 annually."

Our 1918 report covered the fiscal and scholastic year to Feb. 1, 1918. The following report covers the expenditures from that date up to Sept. 1, 1918, and furnishes a statement of certain school conditions and problems.

Ten schools were maintained until the spring term when Tory Hill was closed owing to the absence from town of all but two scholars. These two were conveyed to the village. In the whole district 172 different pupils were registered during the year, 96 girls and 76 boys. The average attendance in all the schools together was 135.9.

As speaker for the June teachers' meeting the board was able to secure Miss Marion Butters of the Keene normal school, who delivered an address full of interest and inspiration. It is a pleasure to report that five of our teachers, impelled by a desire to improve the quality of their work, attended the summer sessions offered by the Keene and Plymouth normal schools.

One meeting of the children, held in April, in the interest of the war savings stamp campaign deserves special mention. The high and elementary school pupils met at the town hall and furnished a program of patriotic songs and original four minute speeches. Hon. Allen Hollis, state director, was also present and gave a short address. As a result of the enthusiasm aroused war savings societies were organized in the various schools and over a thousand dollars worth of stamps were purchased by the elementary schools alone before the end of June.

In planning for the 1918-1919 schools your board found that the teacher shortage presented a serious problem. Salaries had to be increased from ten to twenty-five per cent over the budget allowance. In addition to salary increase teachers are also

coming more and more to feel that they wish the benefit of supervision and many are refusing to accept positions in towns where no superintendent is employed. This situation demands the thoughtful consideration of all who are interested in the strengthening of our school system.

Any suggestion will be welcomed, and teachers will be glad to receive visitors who are interested in improving conditions, and the school board wishes that all parents would come more often and get better acquainted with the teachers and their work. We expect criticisms, but those who do not visit the schools are certainly not acquainted and can not from hearsay make an honest complaint. As stated in a former report, the state department instructs the school board as follows: "There should be but one answer made by the school board member to a complaining citizen, 'Put your complaint in writing, sign your name to it; our board will give you a hearing, and if you substantiate your charges appropriate action will be taken.'"

Our last year's report called attention to the increasing value of the work of the medical and dental examiners. In order to reduce expenses the appropriation to carry on this work was not voted in the 1919 budget. We earnestly urge that an allowance be made for this work at the March meeting.

President Eliot, in a recent report, asks us to note that the sporadic inspection of school children and the medical examinations of young men drafted for the national army have revealed a percentage of defective bodies in the youth of the country very mortifying to thinking Americans. "Both the national and state governments should at once plan and carry into execution a great expansion of the functions of the medical examiner and the school nurse, and these officials should work all through the year on the detection and treatment of defects and diseases in children, and the instruction of parents and children as to remedial and preventive action in their homes."

That we provide suitable, sanitary schoolhouses and the best teachers procurable is of vital importance to our children. Let us also guard carefully this other side which is of equally vital importance, their physical development and well-being.

The attention of parents is also directed to these suggestions pertaining to schoolroom diseases sent out by the state board of health:

Whenever large numbers of children come together there is always an increase in the number of cases of contagious diseases, such as measles, whooping cough, scarlet fever, diph-

theria and pneumonia. This is especially true when school opens after vacation. Mothers can to a great extent prevent such illnesses.

If your child shows any signs of illness, such as fever, rash, coughing, vomiting or sore throat, sneezing and watering of the eyes, do not send him to school. Keep him home that morning. Send for the doctor to make sure that he is not suffering from any one of these contagious diseases. Who knows but that the persistent coughing, sneezing, and watering of the eyes may be the first signs of an attack of measles? The croup, cough and sore throat may be the beginning of diphtheria, or the vomiting and rash may be the signs of scarlet fever.

Take no chances. By sending your child to school when he shows such signs of illness you not only place your own child's life in danger but you also endanger the life and health of other children. What would you think of the mother who sent her child, sick with scarlet fever, to the very classroom which your child attends? What should you think of that mother if your child should get the disease and die of it? Do not send your child to school if he shows any signs of illness. Consult the doctor first.

DRAWING.

During the past year several new features have been carried out, among them some of the new methods of drawings as taught in the Industrial Art text books by Bonnie E. Snow and Hugo Froehlich. These text books being recommended by the State Normal schools.

A number of lessons were given in booklet making and very attractive booklets were made by the children for the Red Cross.

Last spring out of door lessons were given for the study of nature subjects. During the summer vacation over half of the school children made drawings of their own accord which shows their interest in this line of study.

Christmas time the scholars designed attractive Christmas cards and decorated baskets and boxes as gifts.

Not only has an improvement been shown in the actual drawing, but the practical result of this study is shown in other lines of school work, composition papers, attractiveness of mounted work, maps and arrangements of decorations and pictures in the school room, which shows the continued study of drawing and arrangement is having beneficial results in all the school work.

This report begins with February 15, 1918. The school faculty was composed of Chauncey W. L. Chapman, B. S., head master and instructor in the agricultural course; Florence T. Davis, instructor in the commercial course; Margaret C. Lawlor, B. A., graduate of Mt. Holyoke college, instructor in the academic course; Nettie V. Eastman, B. S., graduate of Simonds college, instructor in domestic arts course.

Each teacher was well educated and efficient in their work, and the remainder of the term was carried on with good results to the end of the school year in June.

Graduating exercises were held in the town hall on Friday afternoon, June 14, 1918. The graduating class consisted of fourteen members, as follows: Randolph Chandler Blodgett, in academic course; Earle Horace Bailey, Wesley Scott Davis and Walter Preston Miner, in agricultural course; Dorothy Lillian Davis, Sylvia Marcia Fairbanks, Clarissa Morgan, Lula Reubena Sawyer and Margaret Foster Smith, in the domestic arts course; Bertha Ida Colburn, Gertrude May Farnum, Royal Bartlett Flanders, Elsie Raelene Perkins and Ota Elizabeth Sargent, in the commercial course; salutatory, "Democracy vs. Autocracy," Clarissa Morgan; valedictory, "The Value of Sacrifice to a Nation," Lula R. Sawyer; music by Nevers's orchestra of Concord. The annual reunion of the alumni association, held in the evening of graduation day, was largely attended and closed with music and dancing.

The following members of the senior class are in line for graduating next June: Hiram A. Simpson, George R. Burbank, Stillman B. Clark, Jr., Beatrice A. Small, Winifred D. Joll, Vera A. Craig and Claramay Hemphill.

The lyceum and entertainments have been conducted with interest. The programs have been well made up and the participants have performed their parts with credit. Many of the arguments have been presented in a logical manner.

Athletic sports should be encouraged with the purpose of establishing a reasonable amount of muscular activity in youth

which will give the inclination and the strength to indulge in activities throughout life. Symmetrical development of mind and body should go along together to make the individual efficient.

The school is well organized and is running without friction under the direction of Florence T. Davis, principal. The other three teachers who began their school work at the commencement of the school year, which will end in August, 1919, are Marie P. Blackman, a resident of Peak's Island, Maine, a graduate of the University of Maine, B. S. degree, Marjorie B. Phelps, a resident of Vergennes, Vermont, Middlebury College, A. B. degree, and Marguerite T. Bradbury of Newburyport, Mass., Colby College, Maine, A. B. degree.

To the Trustees of the Pillsbury Free Library:

Friends: The last year has not been very eventful. We have had no large gifts, as has often been the case, neither have we had any expensive improvements like the new furnace and the much needed book stacks.

We have purchased 172 books and had 10 volumes given and the usual number of pamphlets. Among those bought are the Life and Letters of Edward Everett Hale, Joel Chandler Harris, Cape Cod New and Old, History of the War, and many books relating to the war, there being a great call for the latter.

Looking backward, much of the time seems to have been spent in helping along the various "drives" and distributing the vast amount of posters, circulars and other war material with which the mail has been flooded. When several posters of a kind were received, in addition to supplying the reading room, the post office, town house and the schools got a share. So many recipes for meatless, wheatless and sugarless days came that one would think every housekeeper in town must have been supplied. We know, from personal experience, that some of the best cooks had great success in using them.

We sent several boxes of books to the soldiers, and fine books they were too. No clearance of attics or anything of that kind, but books in good shape taken from one's own library and bought for their own use, and we wondered how some of them could be parted with, Roosevelt's, for instance; certainly there

was "much given away that were sweet to keep." Those selected from the public library were of the kind that the boys and men have liked, as we have found from the experience of years. The remark has so often been made, "Now pick me out one; you know just what I like," so it has been a pleasure to do it for those so far away.
