GUBERNATORIAL RACE STAYS TIGHT IN NEW HAMPSHIRE

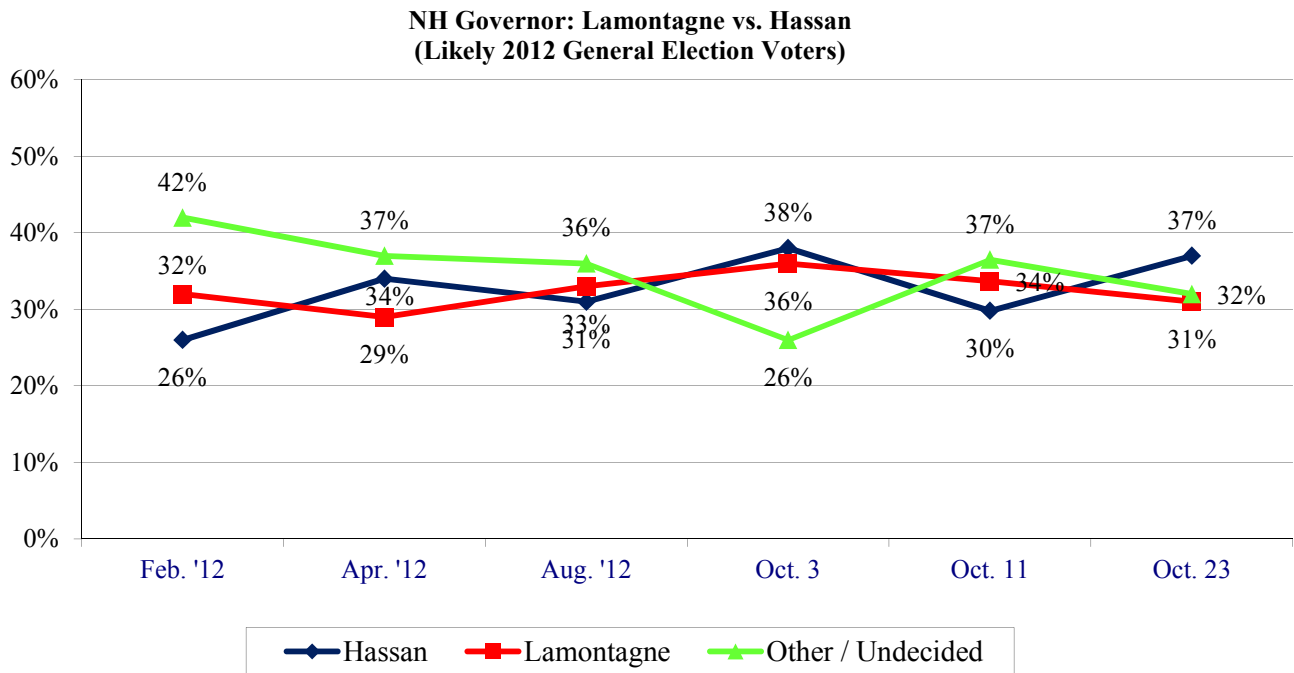

DURHAM, NH – Democrat Maggie Hassan and Republican Ovide Lamontagne are in a tight race for Governor of New Hampshire, but the race remains up for grabs as nearly one-quarter of voters are undecided.

These findings are based on the latest **Granite State Poll*** conducted by the University of New Hampshire Survey Center. Seven hundred and seventy-three (773) randomly selected New Hampshire likely voters were interviewed by landline and cellular telephone between October 17 and October 21, 2012. The margin of sampling error for the survey is +/- 3.5 percent.

NH 2012 Gubernatorial Candidates

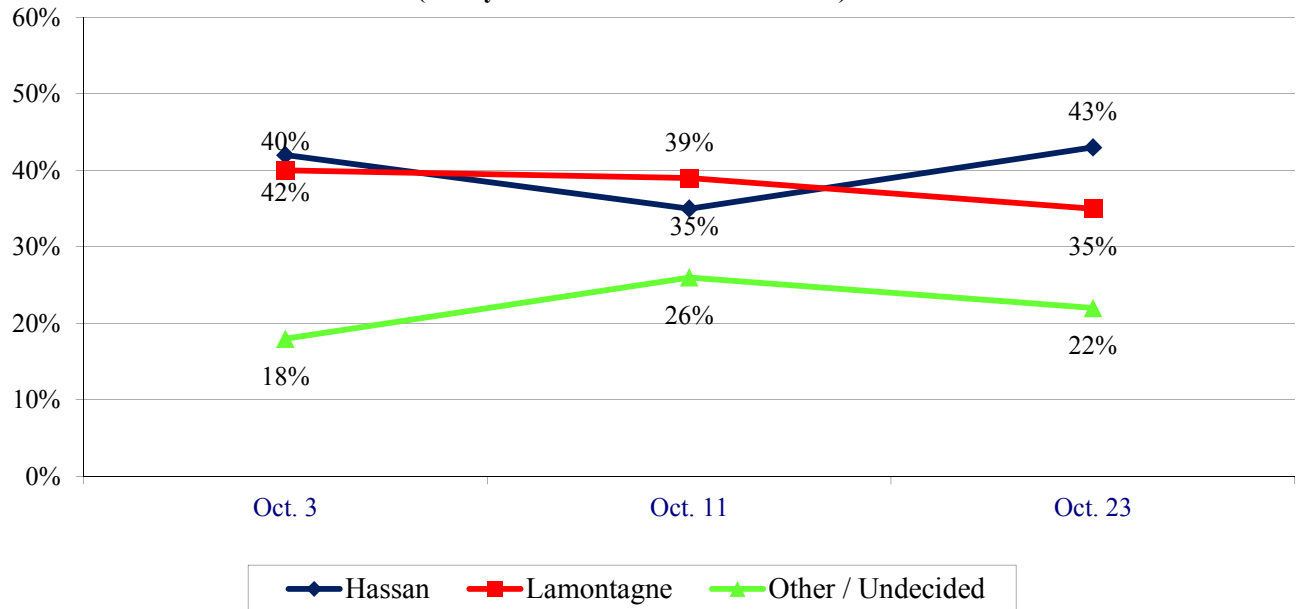
Republican Ovide Lamontagne and Democrat Maggie Hassan remain in a tight race for New Hampshire governor, but a high percentage of voters remain undecided. In the most recent Granite State Poll, 37% of likely general election voters say they would currently vote for Hassan, 31% prefer Lamontagne, 2% favor Libertarian candidate John Babiarez, 1% favor some other candidate, and 29% are undecided. Independent voters remain tied with 25% favoring Hassan and 24% favoring Lamontagne.

Even when undecided voters are asked which candidate they lean toward supporting there remains a very high percentage of likely voters who have not yet decided who they will support – 43% say they will vote for Hassan, 35% for Lamontagne, 3% favor Babiarz and 18% remain undecided.

(Likely 2012 General Election Voters)**

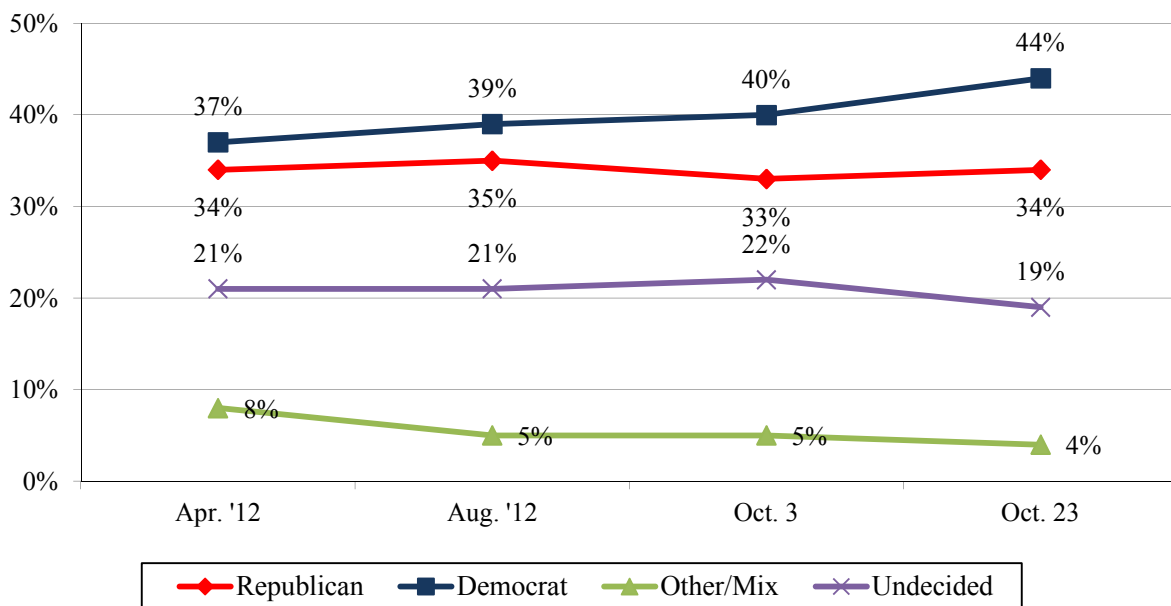


New Hampshire House of Representatives

Likely 2012 New Hampshire voters were asked which party's candidate they planned to vote for in the upcoming election for state representative. Currently, 44% of New Hampshire likely voters with say they will vote for Democratic candidates, 34% for Republican candidates, 4% supporting another party or a mix of Republicans and Democrats, and 19% undecided. When undecided voters are asked which candidate they are leaning toward, 45% of all voters say they will vote for Democratic candidates, 37% for Republican candidates, 4% will vote for candidates of a third party or a mix of Republicans and Democrats, and 13% remain undecided.

Based on an evaluation of past "generic ballot" polling in New Hampshire and actual election results, these results would translate into 185 seats for Republicans and 215 seats for Democrats. But this estimate, and the estimate for Senate seats, is highly dependent on actual turnout in November.

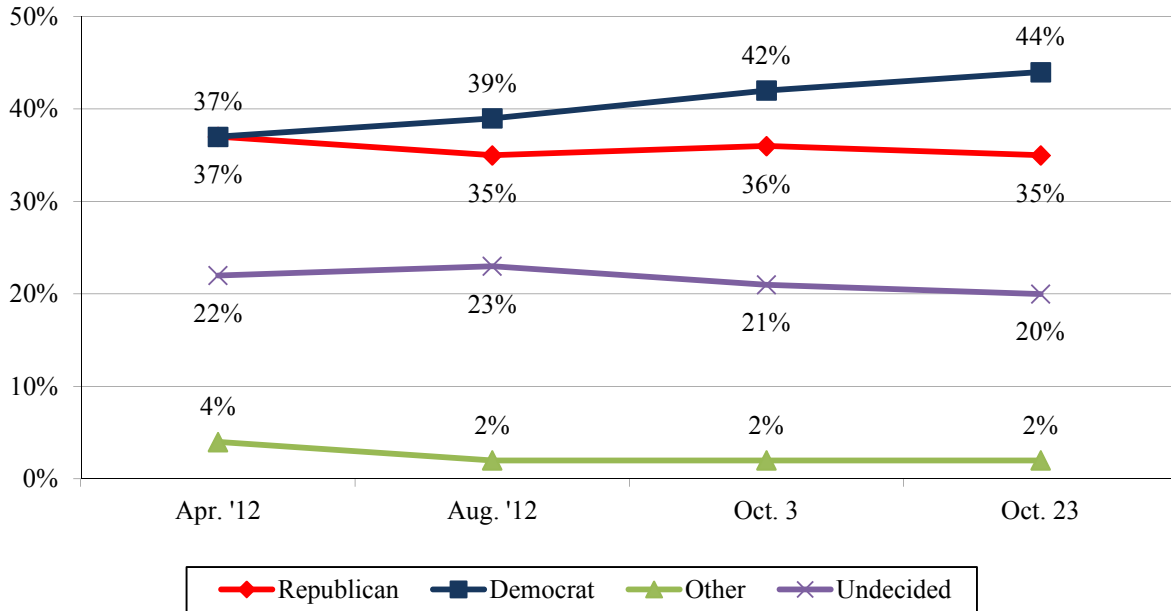
New Hampshire House of Representatives Generic Ballot



New Hampshire State Senate

New Hampshire voters are also more likely to say they will vote for Democratic candidates for New Hampshire Senate than Republican candidates. Currently, 44% of likely voters say they will vote for the Democratic candidate from their district, 35% support the Republican candidate, 2% favor some other candidate, and 20% are undecided. When undecided voters were probed about which party they were leaning toward supporting, 46% say they will vote for the Democratic candidate in their district, 37% favor the Republican candidate, 3% prefer some other candidate, and 15% remain undecided. Based on an evaluation of past “generic ballot” polling in New Hampshire and actual election results, these results would translate into 10 seats for Republicans and 14 seats for Democrats.

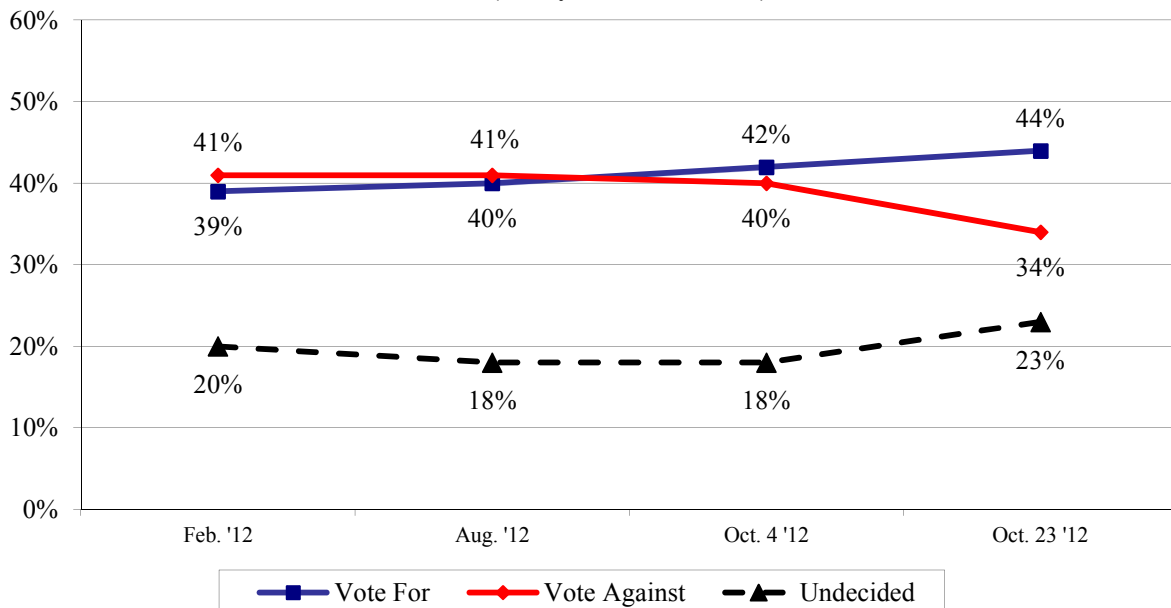
New Hampshire State Senate Generic Ballot



Income Tax Amendment

An amendment to the New Hampshire Constitution will be on the ballot this November that will prohibit a state income tax. When asked whether or not they would vote for this amendment, Granite State voters remain divided. In the most recent Granite State Poll, 44% said they would vote for the amendment, 34% would vote against it, and 23% are unsure. When undecided voters were probed about which way they were leaning, 50% said they would vote for it, 37% would vote against it, and 13% remained undecided. But since this amendment requires a two-thirds majority, passage is doubtful. The proposed amendment gets majority support from Republicans (66%) and Independents (59%), while most Democrats (51%) oppose it.

Granite State Poll Methodology

These findings are based on the latest Granite State Poll conducted by the University of New Hampshire Survey Center. Seven hundred and seventy-three (773) randomly selected New Hampshire likely voters were interviewed by landline and cellular telephone between October 17 and October 21, 2012. The margin of sampling error for the survey is +/- 3.5 percent.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.

A historical analysis was done looking at the results of the “generic ballot” question and the actual number of seats won by Republicans in the New Hampshire House and Senate in the 2000 through 2010 elections was presented at the annual meeting of the American Association for Public Opinion Research Annual (AAPOR), and is available from the UNH Survey Center.

The model developed in this paper used for estimating House seats from the generic ballot question (with undecideds probed) is:

$$\text{HOUSE SEATS} = -245.842 + (2.383 * 2\text{-party GOP estimate})$$

In this Granite State Poll, the two party estimate of House seats for Republicans is 45.1% of 400 seats, or 180.4 (37% GOP / (37% GOP + 45% DEM = 45.3%)) is calculated and inserted into the formula above. This results in an estimate of 196 Republican House seats and 204 Democratic House seats.

The model developed for estimating Senate seats from the generic ballot question (with undecideds probed) is:

$$\text{SENATE SEATS} = -40.0 + (4.5 * 2\text{-party GOP estimate})$$

In this Granite State Poll, the two party estimate of Senate seats for Republicans is 44.6% of 24 seats, or 11 (37% GOP / (37% GOP + 46% DEM = 45.8%)) is calculated and inserted into the formula above. This results in an estimate of 10 Republican Senate seats and 14 Democratic Senate seats.
