WARRANT

For the Annual Meeting March 9, 1926

To the inhabitants of the Town of Wakefield in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in Sanbornville in said Wakefield on Tuesday the ninth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation for the same.
3. To see what sum of money the Town will vote to raise and appropriate for the repairs of highways and bridges.
- ✓ 4. To see what sum of money the Town will vote to raises and appropriate for the maintenance of trunk-line and State aid roads.
- ✓ 5. To see what sum of money the Town will vote to raise and appropriate for the suppression of White Pine Blister Rust and Gypsy moths.
- ✓ 6. To see what sum of money the Town will vote to raise and appropriate toward the support of a public

health nurse to be employed by the Red Cross organization.

7. To see if the Town will fix the salary of the Health Officer, and raise and appropriate money therefor.

8. To see if the Town will vote to render support to a resident physician who shall locate in town, and what sum of money they will raise and appropriate therefor.

9. To see if the Town will vote to discontinue and abolish the Town Library, and what disposition shall be made of the property and effects of said Library.

10. To see what sums of money the Town will vote to raise and appropriate for the support of libraries and where it shall be expended.

11. To see what sum of money the Town will vote to raise and appropriate for the proper celebration of Old Home Week.

12. To hear report of Committee on Forests, determine what action the Town will take thereon, and what money will be raised and appropriated for the same.

13. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars, to be expended on the Lovell Lake Road; the State having appropriated a like amount.

14. To see if the Town will vote to relocate a portion of the Lovell Lake Road near Spinney Meeting House, as shown on Plan in State Highway Department; and raise and appropriate money for land damages for same.

15. To hear the report of the Committee on purchase of Tractor and other machinery, and to see what action the Town will take in regard to purchasing a tractor-snow plow, stone crusher, and other machinery necessary to building and keeping clear the highways in town.

16. To see if the Town will vote to confirm the leases recently made by the selectmen, of the Post Office rooms and the Drug Store rooms.

17. To see if the Town will vote to lease the old Town Hall at Wakefield Corner, to the Parish Helpers of Wakefield, for the term of Fifteen Years.

18. To see if the Town will vote to light the streets of Union, Sanbornville and Wakefield Corner, and raise and appropriate a sum of money sufficient to pay the same; and pass any vote or votes relative thereto.

19. To transact any other business that may legally come before said meeting.

REPORT OF THE TOWN FOREST COMMITTEE

To the Citizens of Wakefield,

At our Town Meeting a year ago the sum of four hundred dollars (\$400.00) was appropriated for the use of your committee to purchase land and to set out white pine.

A tract of approximately seventy-five acres on the east side of the trunk line highway about one mile south of Sanbornville, has been purchased at an extremely low price from Mrs. L. S. Edwards, also a small field between this lot and the highway, giving a frontage on the highway of eighteen hundred feet (1800 ft.).

The lot has been very carefully surveyed and plotted and is to be permanently marked. A sign has been made which will be placed on the lot so all passing by may see it and know that the Town of Wakefield has a forest reserve.

Two thousand (2000) white pine, three year old transplants, were set last spring, in the clear beside the highway. Some brush has been burned.

Dear Sir:—

In accordance with the terms of an agreement executed between the town of Wakefield, and the New Hampshire Forestry Commission, we are submitting a report of White Pine Blister Rust Control work performed in your town during 1925.

As we believe you and your townspeople will be interested in knowing more of blister rust, there is enclosed herewith two circulars recently issued by the U. S. Department of Agriculture and the State Forestry Department. The State publication contains a statement of all control work performed from 1917 to 1924 inclusive. The addition of the 1925 eradication work indicates that a total of 1,587,158 acres have been examined, and that 19,537,775 currant and gooseberry bushes destroyed therefrom.

Since our last report to your town much has been discovered, not only throughout this state, but in other, as well, in connection with the extent of infection on white pines and the damage it is capable of causing. In view of these facts, which are too numerous to set forth

herewith, the Department feels it would be neglecting its duty if it failed to urge a continuance of this work until all the pine areas of your town have received equal protection.

There is attached to this letter a financial report indicating the expenditures made in your town during 1925 in the eradication of currant and gooseberry bushes. Should there be any information of special interest to you which is not contained in this report, we shall be pleased to further advise you upon request.

We would also suggest that this report be read at town meeting, and such sections as seem advisable included in the annual report of the town.

A Tuberculosis Clinic was held July 17th. Twenty-five people received a thorough chest examination by Dr. Kerr, T. B. Specialist. A number of these patients were children.

The number of bedside calls were less owing to the fact of there being less sickness in the community.

Two pre-school children were operated upon for

tonsils and adenoids. One patient accompanied to the Pembroke Sanitarium. Assisted with Red Cross Membership Campaign. Conducted Sale of Christmas seals for N. H. T. B. Association in Wakefield and Brookfield. Fifty-seven dollars and seventy-nine cents was the amount of money received from this sale.

REPORT OF WAKEFIELD FREE LIBRARY

February 1925—February 1, 1926

The library has been open on Thursdays and Saturdays throughout the year, with the exception of Thanksgiving Day and one other Thursday. Since the first of October the library has also been open Tuesdays, afternoons and evenings, and Sunday afternoons.

The circulation for the year was 5,137. This shows quite an increase over last year's records, particularly in the non-fiction class.

Since the attendance record was begun in March last, 4,168 people have visited the library. About one-fourth of this number were recorded on Old Home Day.

There are 293 names on our borrowers' list, many of them from out of town.

The number of books added during the year was 445. This makes the number of bound volumes 3,015.

Of these new books 370 were gifts to the library. The individuals giving a large number of books are Mrs. Elizabeth Chase, Mr. Frank Hanson, and Mr. George Tibbetts.

Our reading table has been supplied regularly with thirteen current magazines. Six of these were gifts to the library. We have also two local weekly papers and the Congressional Record.

Our regular assistant, Miss Marjorie Hatch, is still with us, and we have had help from Miss Leigh Kendall, a summer resident, and Miss Eleanor Kenney.

In October the library was visited by Miss Frances Hobart, of the State library commission. Miss Hobart spent a week arranging the books according to the Dewey system used generally in this state. It will be necessary to paint the outside of the Grammar School building at Sanbornville next summer.

When this work has been done, all our school build-

ings will be in good condition. By adopting the policy of completely renovating one building each year thereafter, no heavy expense will be required during any one year for a long time to come.
