Executive Summary

In 2006, a Warrant Article for \$500,000 for the extinguishment of Development rights (protecting land through conservation easements) passed at town meeting by only 14 votes, (0.01%). The Wakefield Land Conservation Group felt that it was important to understand the reasons for such a close vote. This was accomplished by distributing a professionally crafted town-wide survey. The survey was sent to 3,100 registered voters. 279 voters responded, a 9% response rate.

The town is starting to work on implementing the survey results. As a result of the survey, five landowners were identified who are interested in finding out more about land conservation options. The Wakefield Land Conservation Group is working on follow up discussions with these landowners.

Other outreach activities to educate the public about and build support for land conservation in Wakefield included putting together a brochure describing the Wakefield Land Conservation Committee and their mission. 2,500 copies of the brochure were distributed to town residents.

Introduction

The Town of Wakefield has experienced an unprecedented growth explosion in the past seven years. Pressures to use heretofore undeveloped land for the construction of residential housing has threatened the natural resources of this community. The projected growth rate has the potential to severely impact Wakefield's natural resources. While the town has undertaken a comprehensive revision of zoning, site plan and subdivision regulations, it is important that voluntary land protection measures are advanced to secure permanent protection of valuable resources.

In 2006, a Warrant Article for \$500,000 for the extinguishment of Development rights passed at town meeting by only 14 votes, (0.01%). The Wakefield Land Conservation Group felt that it was important to understand the reasons for such a close vote. Through the distribution of a professionally crafted town-wide survey, the WLCG hoped to ascertain the nature of the resistance. Prior to the vote, the WLCG disseminated through mailing and hand distribution two newsletters documenting the economic impact of residential development and the Dollars and Sense of Protecting open space. While many voters understood and applauded this analysis, there are others who were not receptive to the message. The WLCG wanted to ascertain the effect of the previous newsletter and education campaign so they can better target future outreach efforts, and build stronger local support for land conservation in Wakefield.

Project Goal and Objectives

Project Goal

To understand reasons for voter resistance to Land Conservation and to fashion reasoned, truthful and persuasive arguments and educational tools to advance Land Conservation.

Project Objectives

- Through the Voter Survey, the WLCG and other town groups will better understand voter attitudes toward and knowledge of Land Conservation initiatives in Wakefield.
- Citizens will increase their knowledge and understanding of the economic benefits and importance of Land Conservation in Wakefield, and will become more supportive of these initiatives.

- Voters will endorse monied warrant articles or bonds for Land Conservation in Wakefield.
- More landowners will become involved with protecting their land through conservation easements.

Project Leadership

Other project leaders included: Anne Bartley and Denny Miller (Camera in the Woods), Cindy Barstow, Peter Brown (WLCG Brochure), Daryl Remick (WLCG traveling exhibit), Nancy-Spencer Smith (Voter Survey), and Howie Knight (Town Celebration of Conservation Efforts – Barbour property).

This project was also supported by members of the Wakefield Conservation Commission and Land Conservation Group.

Project Activities and Work Products

1. Voter Survey

As part of this project, Wakefield contracted with the University of New Hampshire Survey Center to assist the Land Conservation Group with crafting a professional survey for voters to elicit voter attitudes toward Land Conservation. The survey was mailed to 3,100 voters. 279 surveys were returned, a 9% response rate.

The town is starting to work on implementing the survey results. As a result of the survey, five landowners were identified who are interested in finding out more about land conservation options. The Wakefield Land Conservation Group is working on follow up discussions with these landowners.

A copy of the survey is attached to this report.

2. Wakefield Land Conservation Group Brochure

A brochure was designed and written to describe the WLCG, its composition, criteria for Land Conservation and Goals. The brochure described Land Conservation in Wakefield and listed the group members.

The flyer was mailed out to the voter mailing list (approx 2,000), and 250 copies were distributed via post office, town hall, and public outreach events. The remaining 250 copies will be distributed at future events.

A copy of the brochure is attached to this report.

3. Organize, advertise and host a town-wide celebration of conservation efforts using the Barbour Property in October, 2006.

Approximately 25 people attended this event that was co-hosted by Wakefield Land Conservation Group, Conservation Commission, Moose Mountain Regional Greenways and UNH Cooperative Extension. The participants did a tour of the property, which included info about trees, plants, wildlife and wetlands, an informative nature walk, and finished up with a barbeque.

Conclusions and Recommendations (for future work or management strategies)

The education and outreach efforts conducted as part of this project have been successful in achieving our objectives:

- We identified five additional landowners who are interested in land conservation.
- We got valuable feedback from the voters that is helping us inform and focus our land conservation efforts.
- The Land Conservation Brochure has helped to inform public about the value of land conservation in Wakefield.

In the future, we plan to:

- Continue to work proactively on land conservation in Wakefield (Land Conservation Group, in conjunction with the Conservation Commission)
- Communicate actively with landowners about voluntary land conservation options (Land Conservation Group)
- Continue to educate and inform the public about the importance of open space protection (Land Conservation Group and Conservation Commission)

Executive Summary

The University of New Hampshire Survey Center conducted a survey for the Town of Wakefield. The specific topics of interest were the attitudes about the town of Wakefield, and land conservation. Thirty-one hundred (3100) surveys were mailed to all Wakefield registered voters on July 17, 2006. Two hundred seventy-nine (279) Wakefield registered voters responded to the survey between July 17 and August 25, 2006; the response rate was 9 percent.

The following figures display the summary survey results. Detailed tabular results can be found in Appendix A; Appendix B contains the open ended responses; and Appendix C contains the survey instrument.

This report summarizes the findings.

Attitudes about Wakefield

- When asked about their reasons for living in or moving to Wakefield, 64 percent of respondents cited its rural character, 56 percent said the quality of life, 37 percent said the lakes, 34 percent said location, 32 percent said tax structure, 30 percent said affordable housing, 8 percent said for a job or employment, 8 percent said they were born there, 5 percent said the schools, and 10 percent gave some other reason. *Figure 1*
 - Voters who have lived in Wakefield for 5 to 9 years and those between the ages of 40 to 49 are most likely to say they moved there because of the <u>rural character</u>.
 - Voters between the ages of 40 and 49 are most likely to say they moved there because of the quality of life.
 - Voters between the ages of 60 and 69, those who have lived in Wakefield for 9 years or less, and those who are seasonal residents are most likely to say they moved there for the <u>lakes</u>.
 - Voters between the ages of 40 and 49 and those who have lived in Wakefield for 5 to 9 years are most likely to say they moved there because of the tax structure.
 - Voters between the ages of 40 and 59, those who have lived in Wakefield for 9 years or less, and those voters who usually vote or vote occasionally/never are most likely to say they moved there because of <u>affordable housing</u>.
 - Young adults (18 to 39) are most likely to say they moved there because of the schools.
 - Voters who have lived in Wakefield for 30 or more years are most likely to say they were born there.
- The majority of Wakefield voters (59%) rated protecting lakes, rivers and wetlands as a very high priority, followed by controlling property taxes (53%), preserving wildlife habitat (43%), preserving open spaces (40%), maintaining Wakefield's rural character (38%), protecting endangered animals and plants (37%), slowing the town's population growth (36%), expanding recreational activities (8%), and encouraging residential development (3%). *Figure 2*
 - Young adults (18 to 39), those between the ages of 50 and 59, and voters who have lived in Wakefield for 5 to 9 years are most likely to rate <u>protecting lakes</u>, <u>rivers and wetlands</u> as a very high priority.
 - Voters who have lived in Wakefield for 10 to 19 years, or 30 or more years, are most likely to rate <u>controlling</u> <u>property taxes</u> as a very high priority.
 - Voters between the ages of 18 and 49 and those who have lived in Wakefield for 5 to 9 years are most likely to rate preserving wildlife habitat as a very high priority.
 - Young adults (18 to 39), those who never/occasionally vote, seasonal residents, and those who have lived in Wakefield for less than 5 years are most likely to rate <u>preserving open spaces</u> as a very high priority.
 - Voters between the ages of 18 and 49 are most likely to rate <u>maintaining Wakefield's rural character</u> as a very high priority.
 - Voters between the ages of 40 and 49 and voters who have lived in Wakefield for 5 to 9 years are most likely to rate <u>protecting endangered animals and plants</u> as a very high priority.
 - Voters between the ages of 18 and 49 are most likely to rate <u>slowing the town's population growth</u> as a very high priority.
 - Young adults (18 to 39) are most likely to rate expanding recreational opportunities as a very high priority.
- When asked where they get most of their information about news and events in Wakefield, the plurality of voters (29%) said the *Granite State News*, 18 percent said *Foster's Daily Democrat*, 12 percent said from the *Carroll County Independent*, 8 percent said the town website, 8 percent said from town meetings, 7 percent said newsletters, 5 percent said word of mouth, 3 percent said the *Union Leader*, 2 percent said channel 3, 1 percent said the *Conway Daily Sun*, 1 percent said the *Wakefield Junction*, 1 percent said the post office, 1 percent said the transfer station, and 2 percent listed some other source. *Figure 3*
 - Older adults (70 or older), longtime residents (30 or more years), and residents who own more than 5 acres are most likely to get their information from *Granite State News*.
 - Voters between the ages of 50 and 59 are most likely to get their information from *Foster's*.

- Voters between the ages of 18 and 49, those who usually vote, and new residents (less than 5 years) are most likely to get their information from the <u>town website</u>.
- Young adults (18 to 39) are most likely to get their information from town meetings.
- Voters who have lived in Wakefield for 20 to 29 years are most likely to get their information by word of mouth.
- According to Wakefield adults, the best way for the Wakefield Land Conservation Group to provide information is through direct mail (41%), followed by newspapers (22%), e-mail (15%), the town website (10%), meetings or workshops (6%), Channel 3 (2%), and handouts (2%). *Figure 4*
 - Young adults (18 to 39) and those who never/occasionally vote are most likely to say the best way is direct mailing.
 - Older adults (70 or older) and voters who have lived in Wakefield for 10 to 19 years are most likely to say the best way is the <u>newspaper</u>.
 - Seasonal residents say the best way is by e-mail.
 - New residents (less than 5 years) and those between the ages of 40 and 49 are most likely to say the best way is the town website.
- The majority of Wakefield voters (70%) report having waterfront property; one-quarter (24%) report having property with current use status; and one-fifth (21%) report property with wetlands. *Figure 5*

Attitudes About Conservation

- One third of Wakefield voters (30%) say they completely understand what a conservation easement is, and nearly half (46%) say they understand it somewhat; 15 percent are only familiar with the term, but don't really know what it is, and 9 percent are not familiar at all. *Figure 6*
 - Voters who never/occasionally vote and those who own more than 5 acres are most likely to say they understand the term somewhat.
 - Voters between the ages of 40 and 49 are most likely to say they are familiar with the term, but don't really know
 what it is.
 - Voters who have lived in Wakefield for 5 to 9 years are most likely to say they are not familiar at all with what a conservation easement is.
- Interest in learning more about conservation easements is equally split. Two-fifths (42%) say they are interested in learning more; two-fifths (41%) are not interested; and 16 percent say they don't know.
 - Voters between the ages of 40 and 49 and those who have lived in Wakefield for 5 to 9 years are most likely to say they are interested in learning more.
 - Long time residents (30 or more years) are most likely to say they are not interested in learning more.
- Those voters who are interested in learning more about conservation easements say the best way to provide them with more information is through direct mail (57%) or e-mail (24%). Other ways to provide more information include newspapers (7%), meetings or workshops (7%), or the town website (4%). *Figure 7*
- While voters are interested in learning more about conservation easements, a great majority (80%) are not interested in donating or selling the development rights to their property. Seven percent say they would be willing to donate or sell the rights to their property, and 13 percent say they might be interested. *Figure 8*
 - Young adults (18 to 49) and those who own more than 5 acres are most likely to say yes or maybe when asked if they would be interested in donating or selling the development rights to their property.
- Nearly three-quarters of Wakefield voters (72%) say they voted in the March 2006 town elections.
 - Older adults (70 or older) and those who say they always vote are most likely to have voted in the March 2006 elections.
 - Young adults (18 to 49), those who say they vote either usually or occasionally/never, and seasonal residents are most likely to <u>not</u> have voted in the March 2006 elections.
- Of the registered voters who voted, a majority (76%) voted for Article #21; 22 percent voted against Article #21; and 3 percent did not vote on that Article. *Figure 9*
 - Voters between the ages of 40 and 49, those who usually vote, and new residents (less than 5 years) were most likely to have voted against Article #21.

- The most important reasons registered voters gave for voting for Article #21 was to slow down over-development (31%), conservation in general is good (19%), to keep the rural character of Wakefield (17%), to protect wildlife and waterways (17%), to have more open space or public use land (15%), and 2 percent said some other reason. *Figure 10*
- The most important reasons registered voters gave for voting against Article #21 were that the taxes are already too high or shouldn't be used for conservation (50%), they don't agree with the concept (26%), or they consider it a low priority and money should be used elsewhere (24%). *Figure 11*
- The majority of Wakefield voters (58%) agree that using public funds for conservation will slow population growth in Wakefield (26% "strongly agree" and 32% "agree somewhat"), 44 percent agree that they distrust elected officials to wisely use the money earmarked for conservation (21% "strongly agree" and 23% "agree somewhat"), 40 percent agree that \$500,000 is not enough money for conservation (21% "strongly agree" and 19% "agree somewhat"), 40 percent agree that using public funds for conservation will significantly increase their taxes (14% "strongly agree" and 26% "agree somewhat"), 30 percent agree that it will keep their property taxes down (11% "strongly agree" and 19% "agree somewhat"), and 23 percent say that they don't believe in using public funds for conservation (13% "strongly agree" and 10% "agree somewhat"). *Figure 12*
 - Voters between the ages of 40 and 49 and those who have lived in Wakefield for 5 to 19 years are most likely to agree that using public funds for conservation will slow population growth in Wakefield.
 - Voters who say they occasionally or never vote are most likely to agree that they <u>distrust elected officials to wisely</u> use money earmarked for conservation.
 - Voters between the ages of 40 and 49 are most likely to agree that \$500,000 is not enough money for conservation.
 - Voters who have lived in Wakefield for 30 or more years are most likely to agree that using public funds for conservation will significantly increase their taxes.
 - Voters who always vote are most likely to agree that using public funds for conservation will <u>keep their property</u> taxes down.
 - Voters who say they usually vote and those who have lived in Wakefield for less than 5 years are most likely to agree that they don't believe in using public funds for conservation.
- The majority of Wakefield voters (58%) feel that \$50 or more in additional annual property tax is fair and acceptable in order to protect land in Wakefield from development (20% say \$50, 23% say \$100, 15% say greater than \$100). However, nearly one-quarter (22%) feel that there should be no additional property tax, 13 percent say \$10, and 7 percent say \$25 is fair and acceptable. *Figure 13*
 - Females, seasonal residents and those who have lived in Wakefield for 5 to 9 years are most likely to say \$50 or more is fair and acceptable.
 - Long time residents (30 or more years) are most likely to say there is no amount that is fair and acceptable.
- The vast majority of Wakefield voters (80%) believe that an increase in the population will lead to an increase in property taxes, while 15 percent believe it will have no impact, and 4 percent say it will lead to a decrease in property taxes. *Figure 14*
- Wakefield voters are almost evenly split regarding placing land in conservation as an effective way to control property taxes. Nearly one-third (30%) say it is an effective way to control property taxes, nearly one-third (30%) say it is not effective, and the remainder (40%) said they are not sure. *Figure 15*
 - Young adults (18 to 39) and those who have lived in Wakefield for 5 to 9 years are most likely to believe it is an effective way to control property taxes.
 - Long time residents (30 or more years) are most likely to believe it is not an effective way to control property taxes.
 - Voters between the ages of 40 and 49, those who never/occasionally vote, and seasonal residents are most likely to be unsure.
- Nearly one-third of Wakefield voters (31%) say they would consider moving to another community if Wakefield continues to grow and develop, 44 percent say they would not consider moving, and 24 percent say they are not sure. *Figure 16*
 - Young adults (18 to 39) are most likely to say they would consider moving.
 - Older adults (70 or older), those who own more than 5 acres, and new residents (less than 5 years) are most likely to say they would not consider moving.

Figure 1: "I moved or live in Wakefield because ..." (Multiple responses possible. Percentages may add to more than 100 percent.) (Section 4, Qa)




Figure 2: "Please indicate how high a priority you place on each of these possible goals for Wakefield?" (Section 1, Qa)




Figure 3: "What 3 ways do you get your information about news and events in Wakefield? Please write a "1" where you get MOST of your information, a "2" where you get the next most, and a "3" where you get the third most." (Section 3, Qa)




Figure 4: "What are the best ways the Wakefield Land Conservation Group (WLCG) can inform you about what it is doing? Please write a "1" next to the best method, a "2" next to the second best method, and a "3" next to the third best method." (Section 3, Qb)




Figure 5: "Does your property have any of the following? (Circle all that apply)" (Section 4, Qd)




Figure 6: "How well do you think you understand what a conservation easement is?" (Section 1, Qb)




Figure 7: "Are you interested in learning more about conservation easements?" IF YES: "What is the best way to get you more information?" 42% answered "yes," 41% answered "no," and 16% said they "don't know." (N=83). (Section 1, Qc)




Figure 8: "Would you be interested in donating or selling the development rights on your property (i.e., having a conservation easement)?" (Section 1, Qd)




Figure 9: "How did you vote on Article #21 – to raise \$500,000 for land conservation?" *Of the 72% who voted in the March 2006 elections.* (*N*=160). (Section 2, Qa & b)




Figure 10: "IF FOR: What is the most important reason you voted FOR or would have voted for Article #21?" (N=108) (Section 2, Qc)




Figure 11: "IF AGAINST: What is the most important reason you voted AGAINST or would have voted against Article #21?" (N=34) (Section 2, Qd)




Figure 12: "Do you agree or disagree with the following statements about using public funds for conservation?" (Section 2, Qe)




Figure 13: "How much additional annual property tax do you think is fair and acceptable in order to protect land in Wakefield from development? PLEASE NOTE – these are actual tax dollars, not per thousand. (Section 2, Qf)




Figure 14: "Do you feel that an increase in our population will INCREASE or DECREASE our property taxes?" (Section 2, Qg)




Figure 15: "Do you believe placing land in conservation is an effective way to control property taxes?" (Section 2, Qh)





Figure 16: "Would you consider moving to another community if Wakefield continues to grow and develop?" (Section 2, Qi)

•Why we protect

- •Ridge-lines: control soil erosion.
- •Un-fragmented land: increase and maintain wildlife habitats.
- •Wildlife and rare species: important in the eco-chain.
- •Forests: filter water, air purification, control flooding, provide for forest industry.
- •Farmland: only 2% of Wakefield land is ideal for crop production
- •Uplands: filter pollutants out of water going into our wetlands
- •Wetlands: further purify pollutants, control flooding, provide habitat for plants and animals, fishing and hunting
- •Floodplains: first line of defense when rivers and streams overflow
- •Shore land: prevents soil erosion and water pollution
- Aquifers: our underground water resource
- •Source waters: drain into our town and private wells
- •Undeveloped land: preserves hunting, fishing, recreation such as hunting, fishing, cross country, snowshoeing, snowmobiling.
