DESPITE ECONOMY AND BUDGET, LYNCH REMAINS POPULAR IN NEW HAMPSHIRE

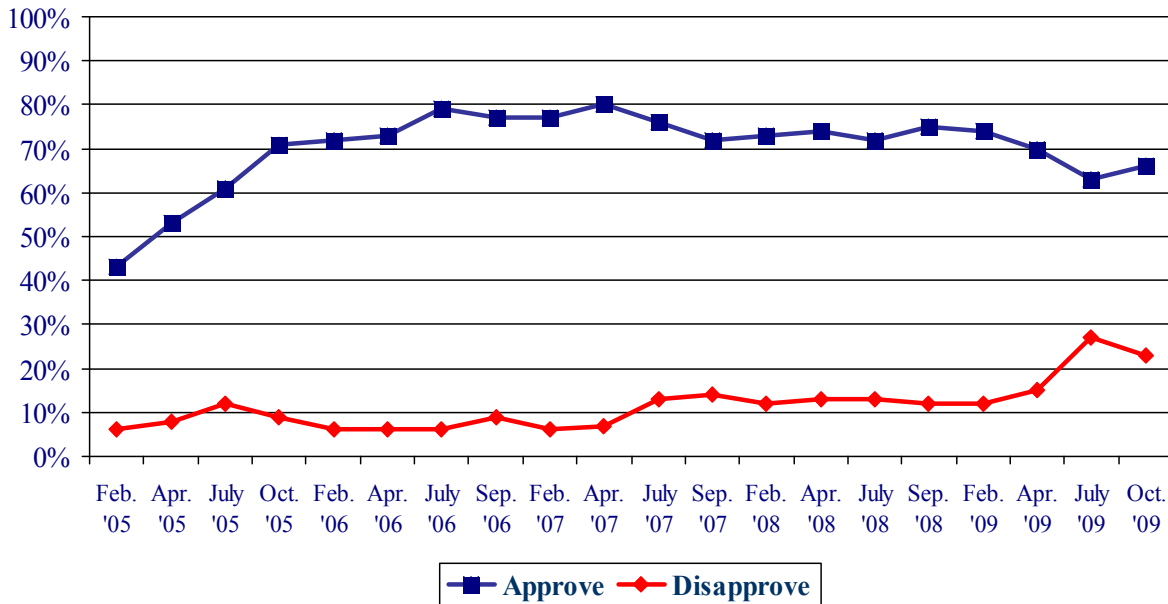
DURHAM, NH – Governor John Lynch continues to get high marks from Granite Staters despite dealing with twin problems of a difficult economy and balancing the state’s budget.

These findings are based on the latest **WMUR Granite State Poll**,* conducted by the University of New Hampshire Survey Center. Five hundred and three (503) randomly selected New Hampshire adults were interviewed by telephone between September 25 and October 2, 2009. The margin of sampling error for the survey is +/-4.4 percent.

Gubernatorial Approval

After declining for two straight quarters, Governor John Lynch has gotten a slight uptick in his job approval rating. In the most recent Granite State Poll, 66% of NH adults say they approve of the way he is handling his job as governor, 23% disapprove, and 11% are neutral or don’t know. Lynch’s job approval ratings had been declining in recent polls as he has been faced with increasing unemployment and lower economic growth in the state which has hurt the state’s budget. A sign of Lynch’s popularity is that 50% of Republicans approve of the job he has done as governor.

NH Gubernatorial Approval – John Lynch

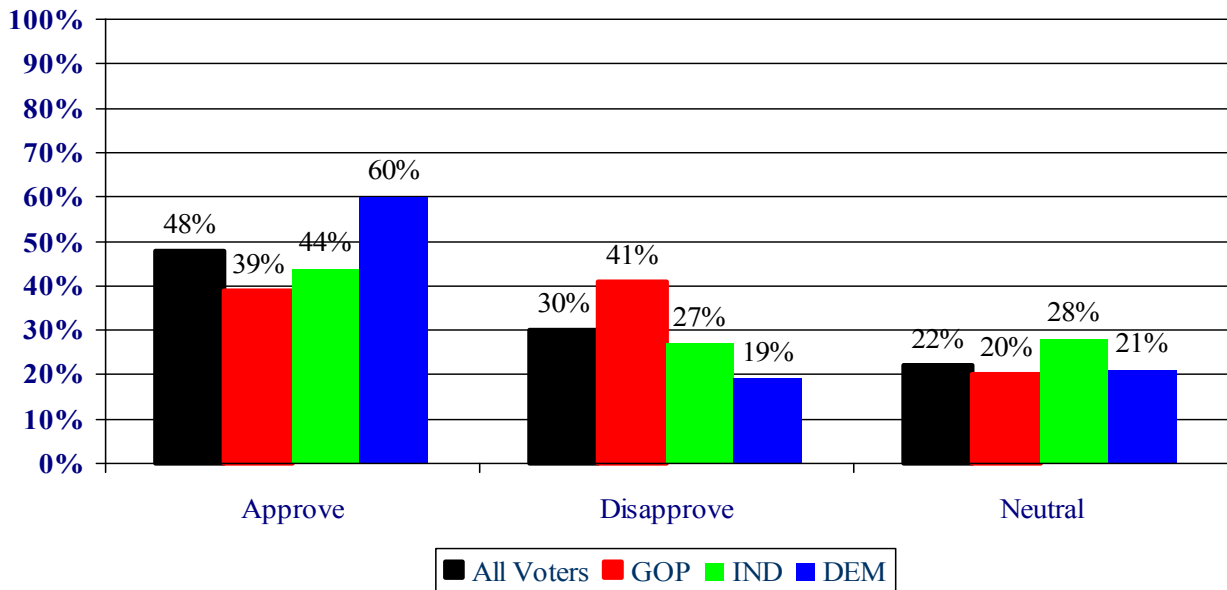

Gubernatorial Approval – Handling the Budget

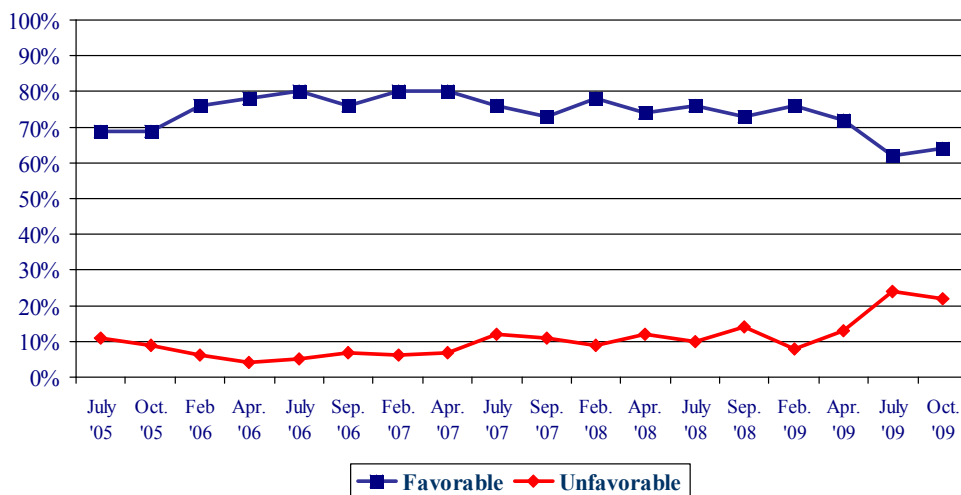
Lynch also gets fairly high marks for his handling of the state budget crisis. Currently, 48% of Granite Staters approve Governor Lynch’s handling of the state budget, 30% disapprove, and 22% are neutral. Governor Lynch receives approval from a majority of Democrats and a plurality of Independents – 60% and 44%, respectively – while Republicans are split, with 39% approving and 41% disapproving.

Gubernatorial Approval – Handling the Budget



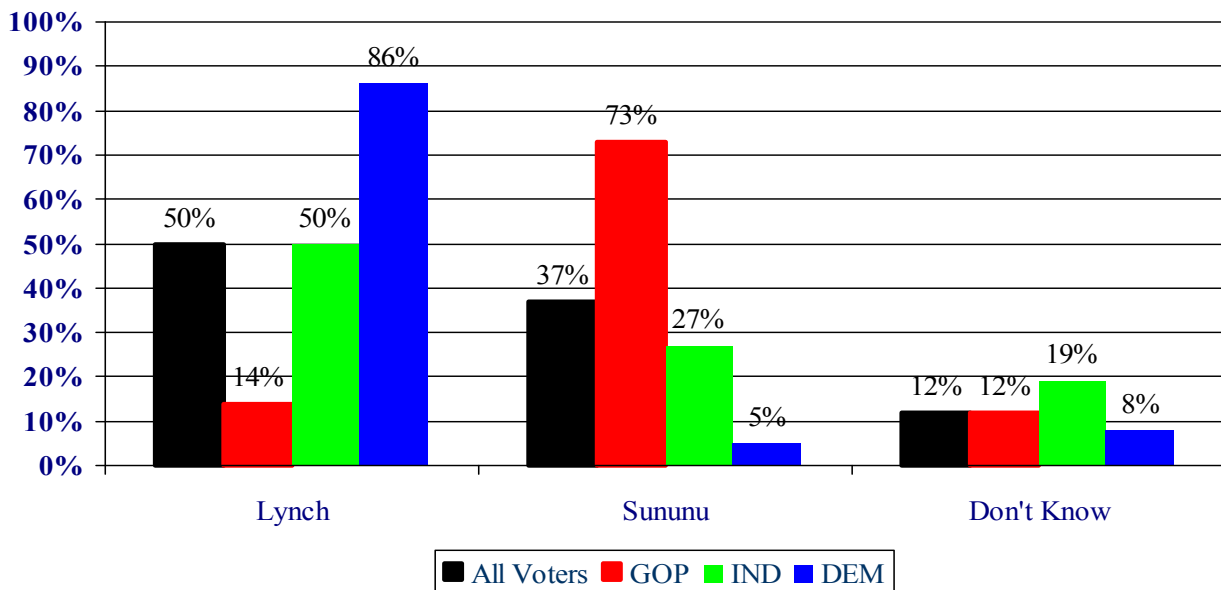
Lynch’s personal favorability rating has stabilized after dropping since this past spring. In the latest Granite State Poll, 64% of New Hampshire adults say they have a favorable opinion of Lynch, 22% have an unfavorable opinion, 8% are neutral, and 5% say they don’t know enough about him to say. Lynch’s net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, has risen to +42%, up from +38% in June.

2010 NH Gubernatorial Race – John H. Sununu vs. John Lynch – Likely Voters

In recent elections, Lynch has faced little known and poorly funded Republican opponents. Republicans, and their party leader, former Governor John H. Sununu, are hoping to field a much stronger gubernatorial candidate. In a hypothetical matchup between John Lynch and former governor Sununu, 50% of likely 2010 voters say would vote Lynch, 37% would vote for Sununu, 1% would choose some other candidate, and 12% are undecided. However, only 7% say they have definitely decided who they would vote for, 4% are leaning towards someone but may still change their mind, and 89% are still trying to decide.



Former Governor John H. Sununu is much better known than recent Republican challengers. In the most recent Granite State Poll, 43% of New Hampshire adults have a favorable opinion of him, 32% have an unfavorable opinion of him, 9% are neutral, and 16% don't know enough about him to say. Sununu's net favorability stands at +9%.

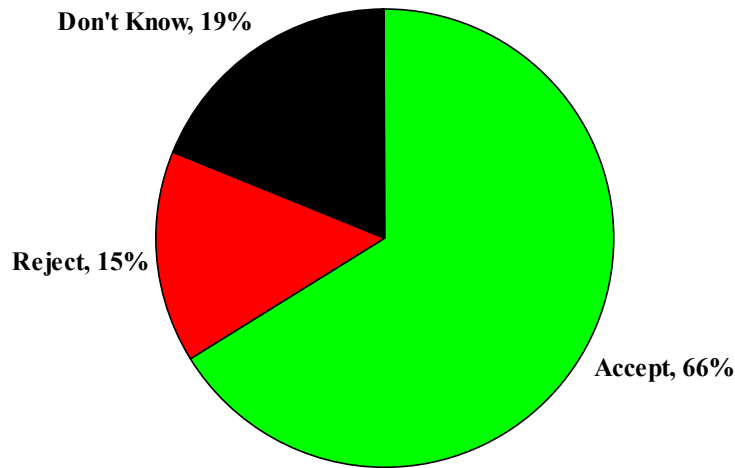
SEA Contract

Recently, Governor Lynch and the State Employee Association (SEA), a union representing more than 10,000 state workers, agreed to a new contract. Governor Lynch has called for state employees to accept taking 19 unpaid furlough days as part of their new contract in an effort to address the state's budget deficit. If the state employees reject this contract, the Governor has said that as many as 750 state employees will be laid off. The SEA has urged its members to reject the contract.

When asked how familiar they are with the SEA contract, only 11% of New Hampshire adults said they were very familiar, 39% said they were somewhat familiar, 27% said they were not very familiar, and 22% were not at all familiar.

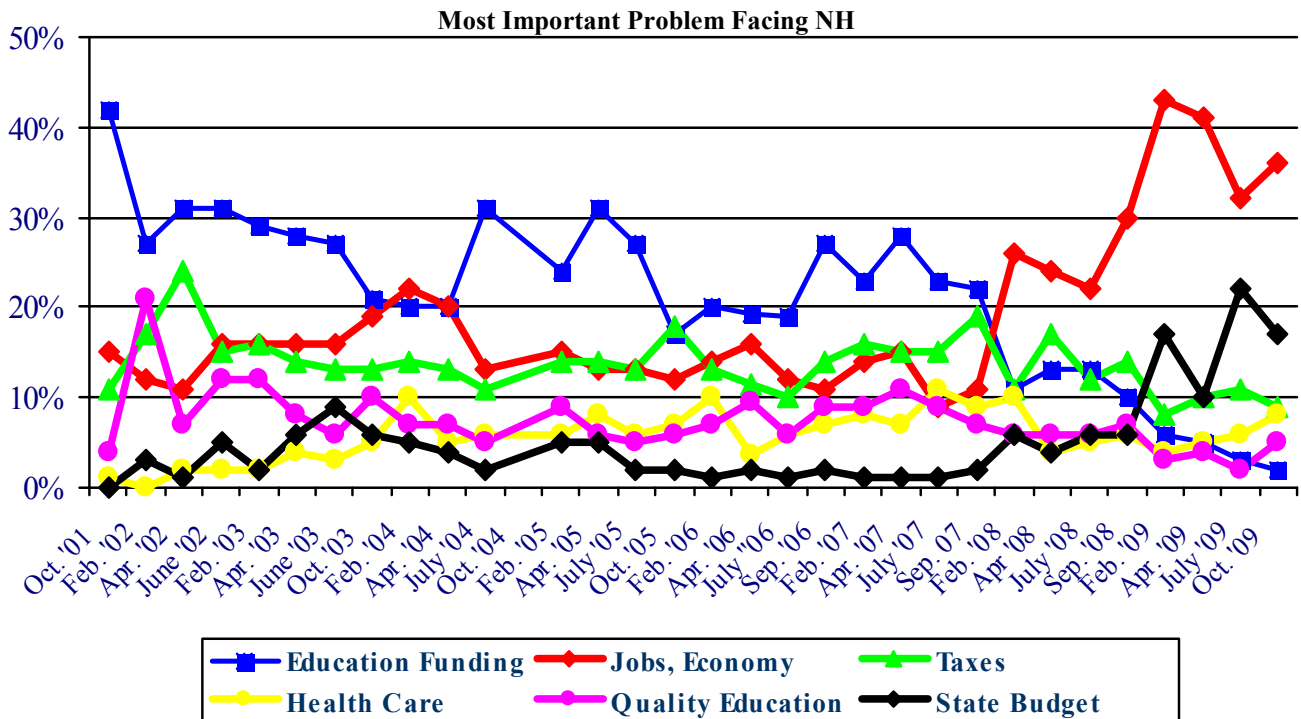
Among those who said they were at least "not very familiar" with the issue, 66% believed the union should accept the contract, 15% believed it should be rejected, and 19% said they did not know enough to form an opinion.

Most Important Problem Facing New Hampshire

New Hampshire residents continue to be worried about the condition of the state’s economy. In the latest Granite State Poll, 36% of New Hampshire adults view the economy and jobs as the most important issue facing the state, followed by the state budget (17%), high taxes (9%), health care (8%), and the quality of public education (5%). The percentage who name the economy as the most important problem facing the state has dropped considerably in recent months from a high of 43% in the Winter 2009 Granite State Poll, however, concerns about the state budget have increased as the Legislature and the Governor have wrapped up work on the budget.

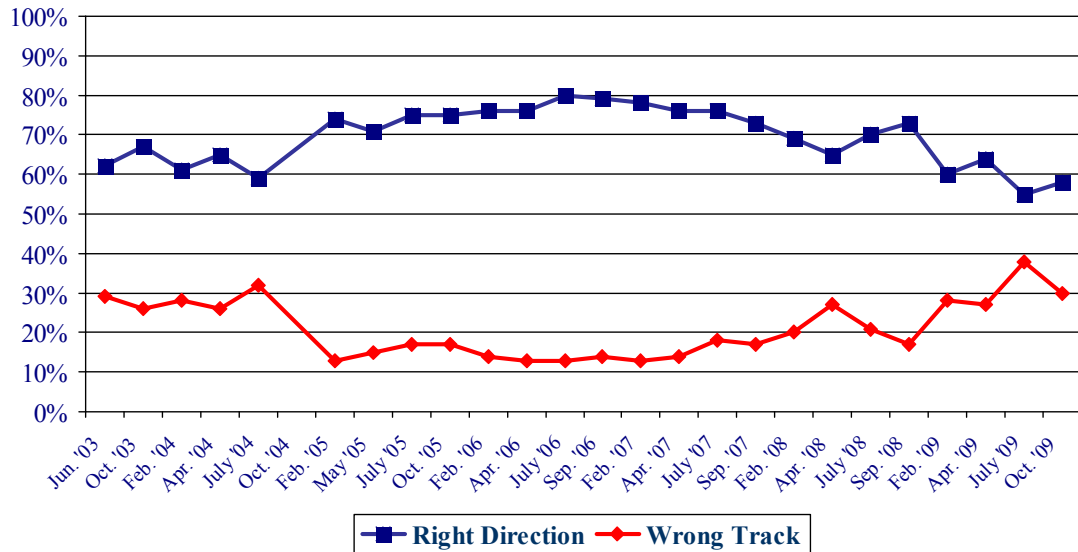


Right Direction or Wrong Track?

Despite the continuing recession and the budget crisis remaining an issue, New Hampshire residents are slightly more positive about the direction the state is heading. Currently, 58% of New Hampshire adults feel the state is heading in the right direction, 30% think the state is seriously off on the wrong track, and 12% don't know.

Democrats, liberals, and residents of the New Hampshire seacoast are most likely to think New Hampshire is headed in the right direction while Republicans and conservatives are most likely to say things are off on the wrong track.

Granite State Poll Methodology

These findings are based on the latest WMUR Granite State Poll, conducted by the University of New Hampshire Survey Center. Five hundred and three (503) randomly selected New Hampshire adults were interviewed by telephone between September 25 and October 2, 2009. The margin of sampling error for the survey is +/-4.4 percent.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
