ECONOMY TOP NH CONCERN, LYNCH APPROVAL STAYS HIGH

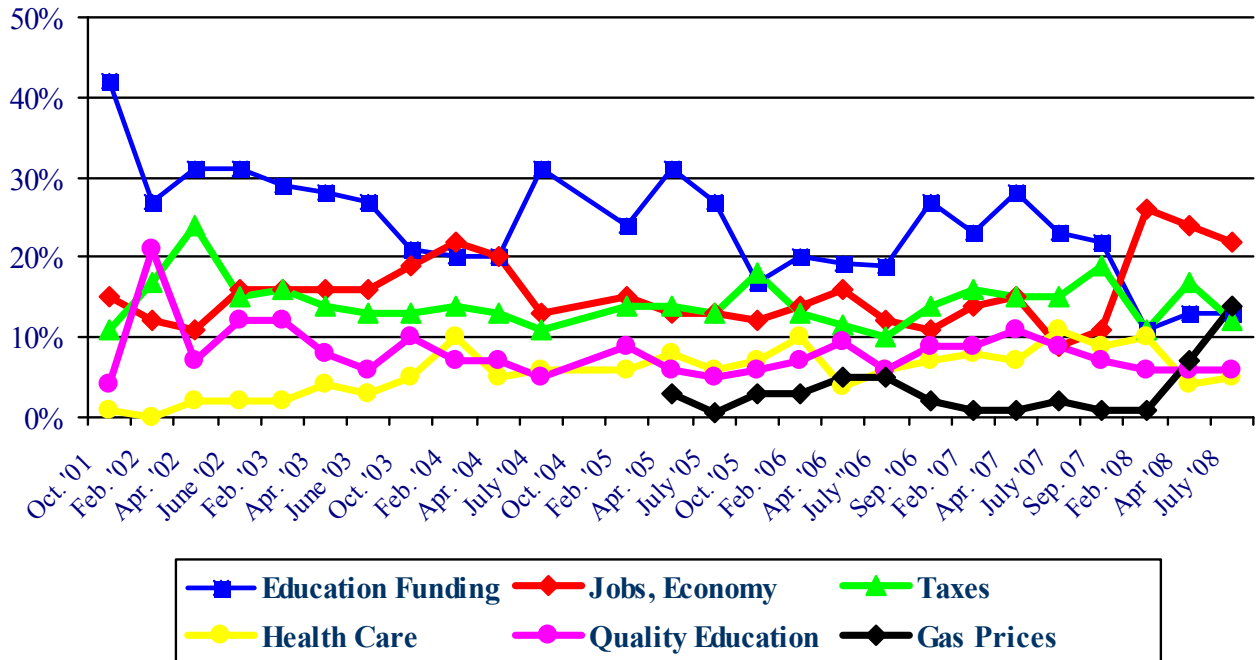
DURHAM, NH – The state of New Hampshire’s economy continues to be seen as the most important problem facing the state and people are increasingly concerned about energy prices. Governor John Lynch still has high job approval and holds a wide lead in his reelection race.

These findings are based on the latest **Granite State Poll**,* conducted by the University of New Hampshire Survey Center. Five hundred (519) randomly selected New Hampshire adults were interviewed by telephone between July 11 and July 20, 2008. The margin of sampling error for the survey is +/-4.3 percent. Included was a subsample of 475 likely November voters (margin of sampling error, +/- 4.5%).

Most Important Problem Facing New Hampshire

With the U.S. and New Hampshire economies facing difficulties due to high energy costs and financial market jitters, New Hampshire residents see the economy and jobs as their biggest concern for the state. In the latest Granite State Poll, 22% of New Hampshire adults said that jobs and the economy are the most important problem facing the state, followed gas and oil prices (14%), how to fund primary and secondary education (13%), high taxes and desires to change the tax system (12%), the quality of education (6%), the state budget (6%), and health care issues (5%).

Most Important Problem Facing NH

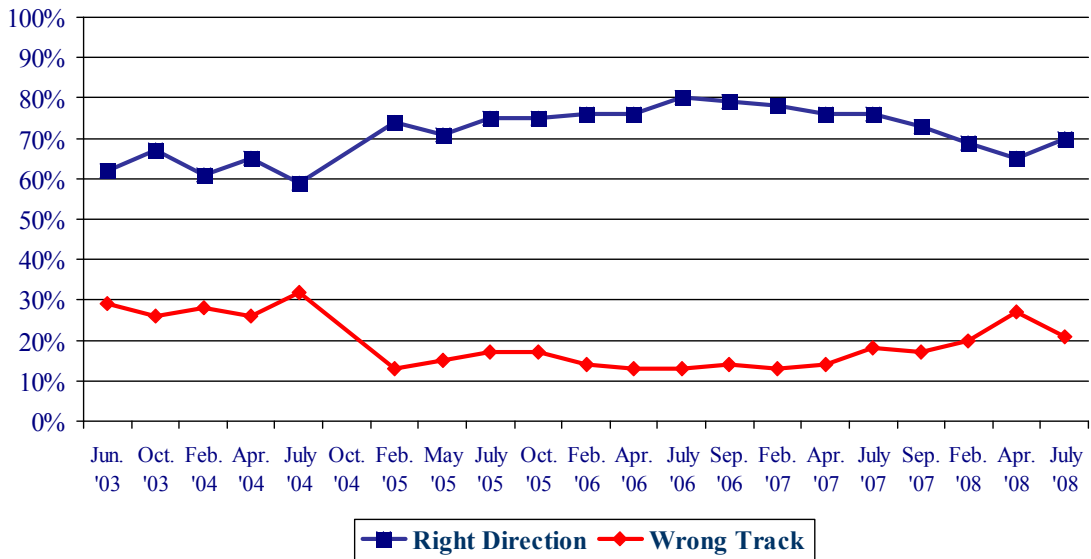

Right Direction or Wrong Track?

In spite of the bad economic news, Granite Staters remain very optimistic about the future of New Hampshire. Seventy percent think things in New Hampshire are generally going in the right direction, 21% think things are seriously off on the wrong track, and 9% say they don't know.

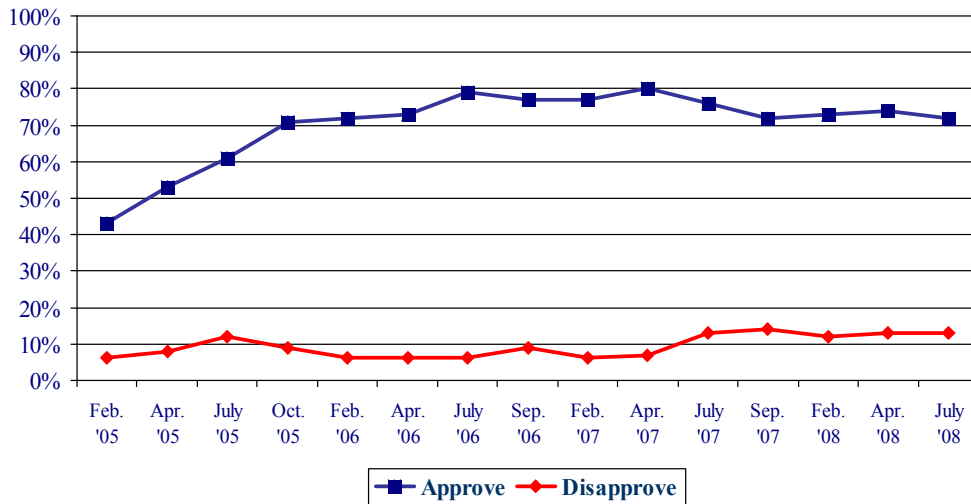
NH Heading in Right Direction or On Wrong Track?



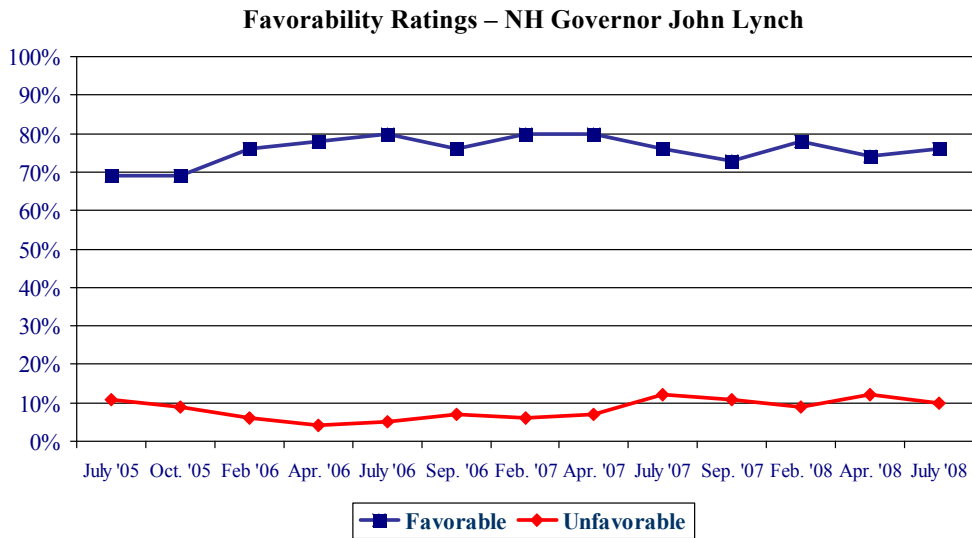
Gubernatorial Approval

Governor John Lynch continues to enjoy very high approval ratings as he approaches reelection in November -- 72% of New Hampshire adults say they approve of the job Lynch has done as governor, only 13% disapprove, and 15% are neutral. Sixty-three percent of Republicans and 72% of independents approve of the job Lynch is doing as governor making his chances for reelection look quite good.

NH Gubernatorial Approval – John Lynch



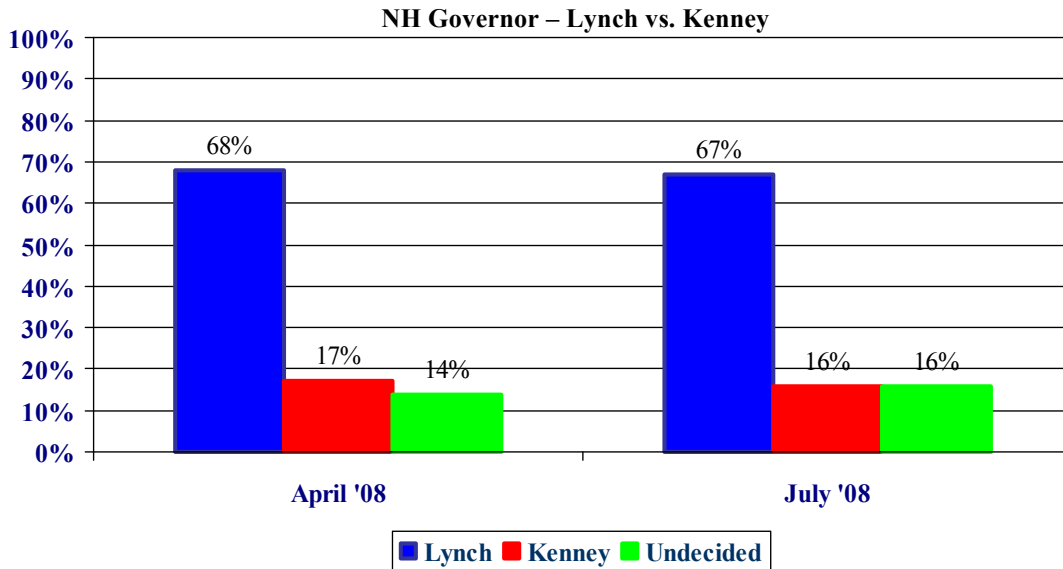
Lynch's personal favorability rating also remains high. In the latest Granite State Poll, 76% of New Hampshire residents say they have a favorable opinion of Lynch, only 10% have an unfavorable opinion, 8% are neutral, and 6% say they don't know enough about him to say. Lynch's net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, is an incredibly high +66 percent.



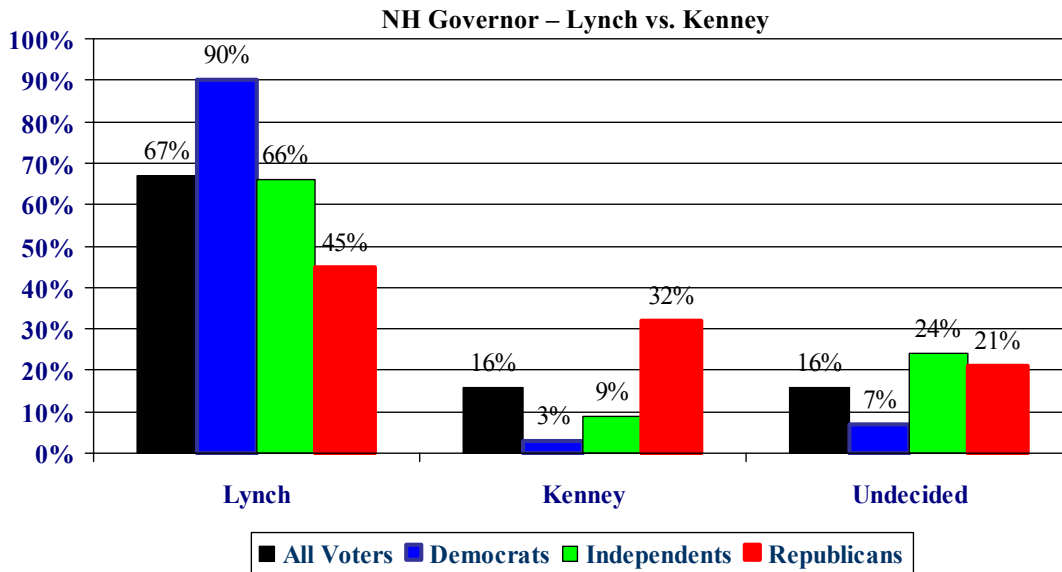
2008 Gubernatorial Election

Lynch is being challenged by State Senator Joe Kenney of Wakefield. Kenney has his work cut out for him in unseating Lynch as most Granite Staters know little about him. Only 14% of New Hampshire adults say they have a favorable opinion of Kenney, 5% have an unfavorable opinion of him, 11% are neutral, and 69% don't know enough about him to say.

In a matchup between Lynch and Kenney, Lynch continues holds a commanding lead among likely voters. Two thirds (67%) of likely voters say they would vote for Lynch, 16% say they would vote for Kenney, 1% prefer some other candidate and 16% are undecided.



Lynch leads Kenney among all groups of voters, including Republicans and conservatives.



Granite State Poll Methodology

Five hundred (519) randomly selected New Hampshire adults were interviewed by telephone between July 11 and July 20, 2008. The sample was selected at random from all household in New Hampshire with a land-line telephone and a respondent was selected at random within each household. The margin of sampling error for the survey is +/-4.3 percent. Included was a subsample of 475 likely November voters (margin of sampling error, +/- 4.5%).

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
