### BUSH APPROVAL IN NH UP TO 39%

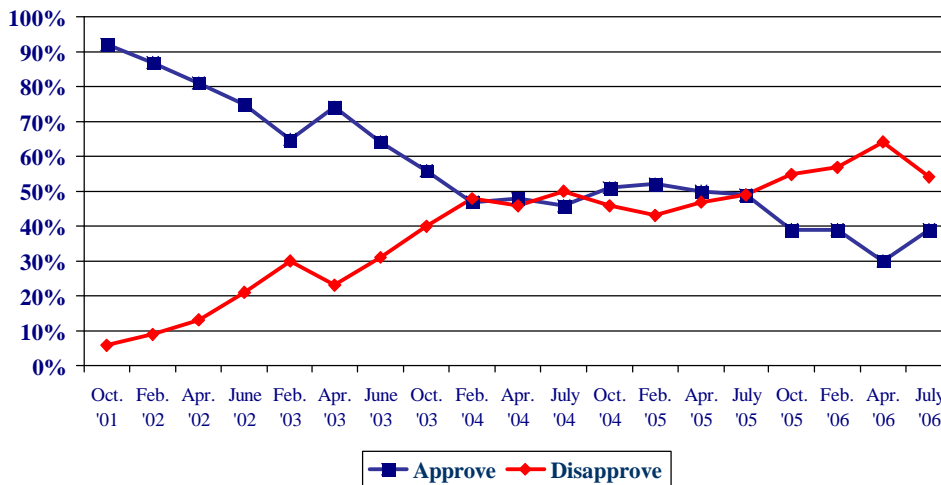
DURHAM, NH – President Bush’s job approval ratings in New Hampshire have improved to 39 percent after dropping to 30 percent in April. The conflict in Iraq continues to hold down Bush’s overall ratings as well as views about his handling of the economy.

These findings are based on the latest **Granite State Poll**,<sup>?</sup> conducted by the University of New Hampshire Survey Center. The Granite State Poll is sponsored by the University of New Hampshire. Five hundred ten (510) randomly selected New Hampshire adults were interviewed by telephone between July 21 and July 31, 2006. The margin of sampling error for the survey is +/-4.3 percent.

#### Presidential Approval

After reaching an all time low of 30% in April, President George W. Bush’s job approval ratings in New Hampshire have rebounded somewhat. In the most recent Granite State Poll, 39 percent of New Hampshire adults say they approve of the job Bush is doing as president, 54 percent disapprove, and 7 percent are neutral. The improvement in Bush’s approval ratings mirror national polls which now show 40 percent approve of the job Bush is doing as President. “Bush’s rebound has happened, in large part, because conservatives are back on board.,” said Andrew Smith, Director of the UNH Survey Center. “In April, only 46 percent of conservatives said they approved of the job Bush was doing. Now, 69 percent of conservatives approve.” Similarly, 73 percent of Republicans now approve of Bush’s performance as President, up from 63 percent in April.

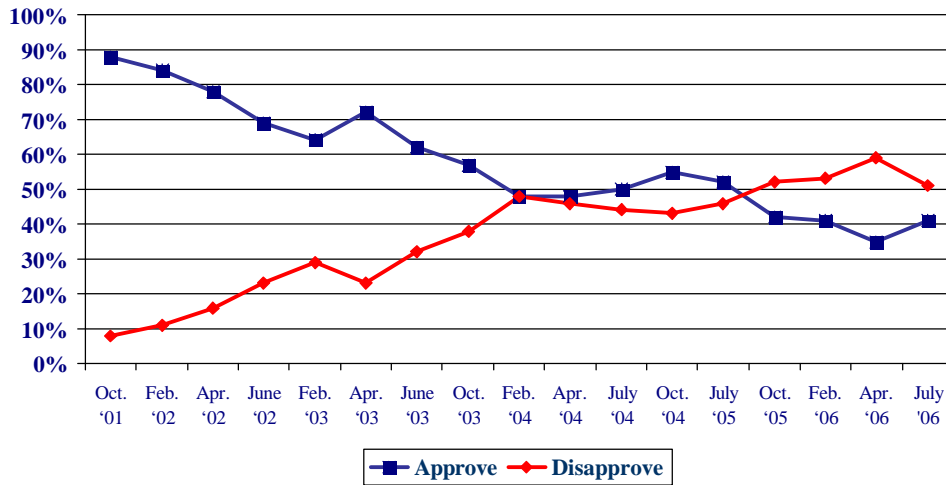
Presidential Approval – G.W. Bush

Bush's personal favorability rating have also rebounded somewhat. Currently, 41 percent of New Hampshire adults have a favorable opinion of Bush, 51 percent have an unfavorable opinion of him, and 7 percent are neutral. Bush's net favorability rating, the percentage having a favorable opinion minus the percentage having an unfavorable opinion, is still very low -10 percent, but is up from -24 percent in April.

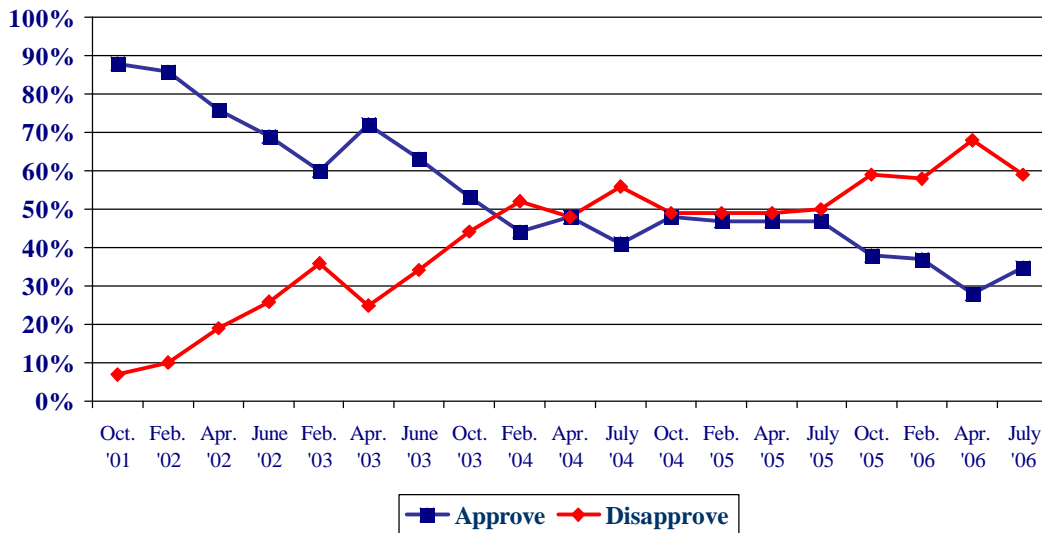
**Favorability Ratings – G.W. Bush**



**Foreign Affairs**

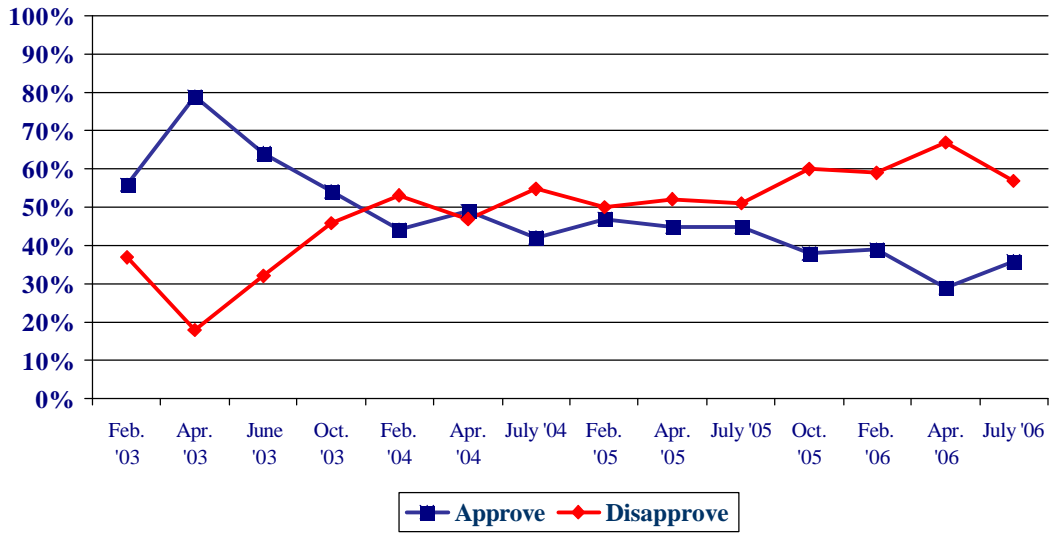
Bush continues to be dragged down by continuing problems in Iraq and perceptions that his administration is not successfully handling the situation there. When asked about how the president is handling foreign affairs, only 35 percent of New Hampshire adults say they approve, 59 percent disapprove, and 6 percent are neutral.

**Bush Approval: Foreign Affairs**



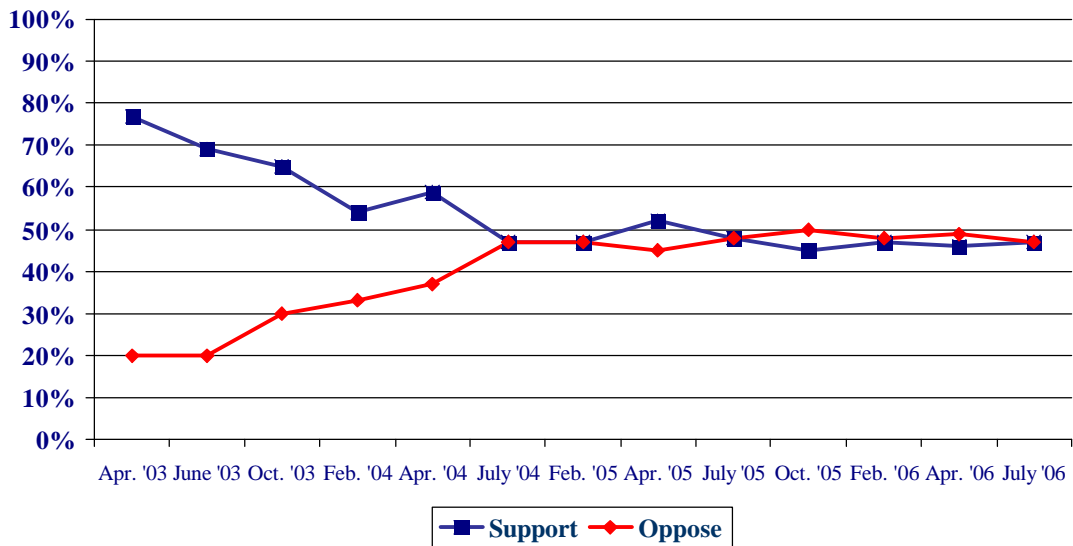
Looking specifically to Iraq, only 36 percent of Granite State adults approve of the way Bush has handled the situation there, 57 percent disapprove, and 6 percent are neutral. The percentage who approve of the Bush Administrations handling of Iraq increased by 7 percentage points between February and April.

**Bush Approval: Handling Situation In Iraq**

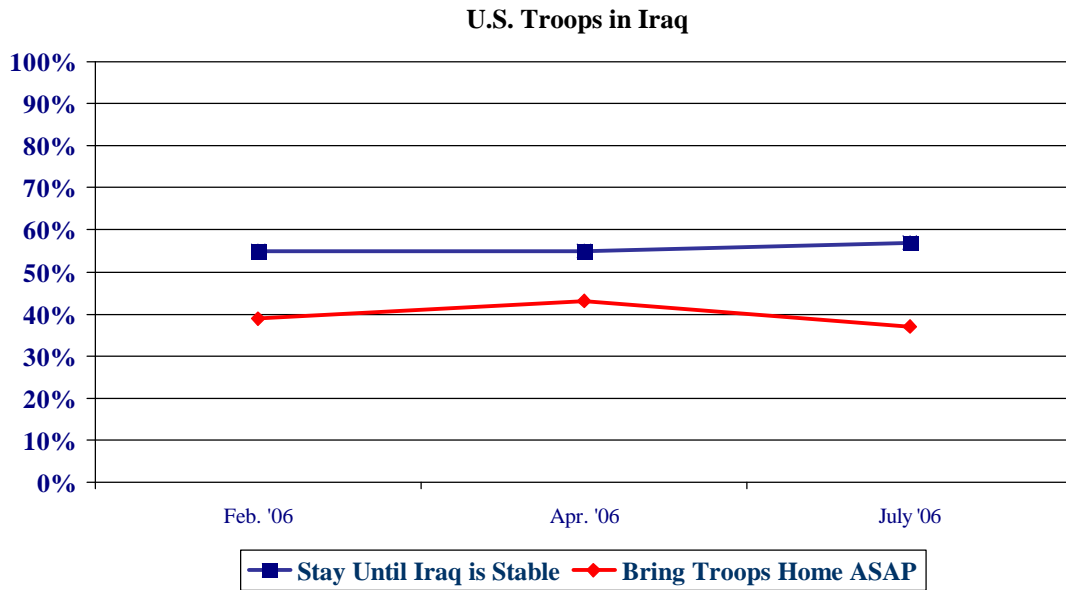


While a majority in New Hampshire disapprove of how the Bush administration has handled the situation in Iraq, support for the U.S. having gone to war with Iraq has remained stable. Currently, 47 percent support the U.S. having gone to war in Iraq, 47 percent oppose the U.S. having gone to war, and 6 percent are neutral. Support for the U.S. having gone to war with Iraq has remained essentially unchanged since July, 2004.

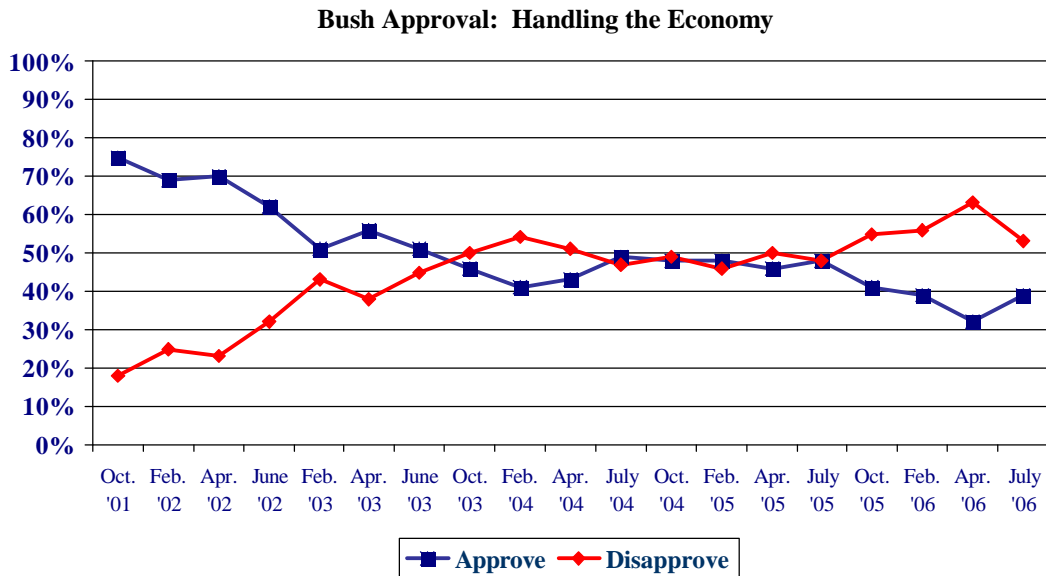
**Support for War In Iraq**



When asked what U.S. troops should do in Iraq, 57 percent think they should stay until the situation has stabilized, 37 percent think the troops should be brought home as soon as possible, and 6 percent don't know. This has remained unchanged since the Winter 2006 Granite State Poll.



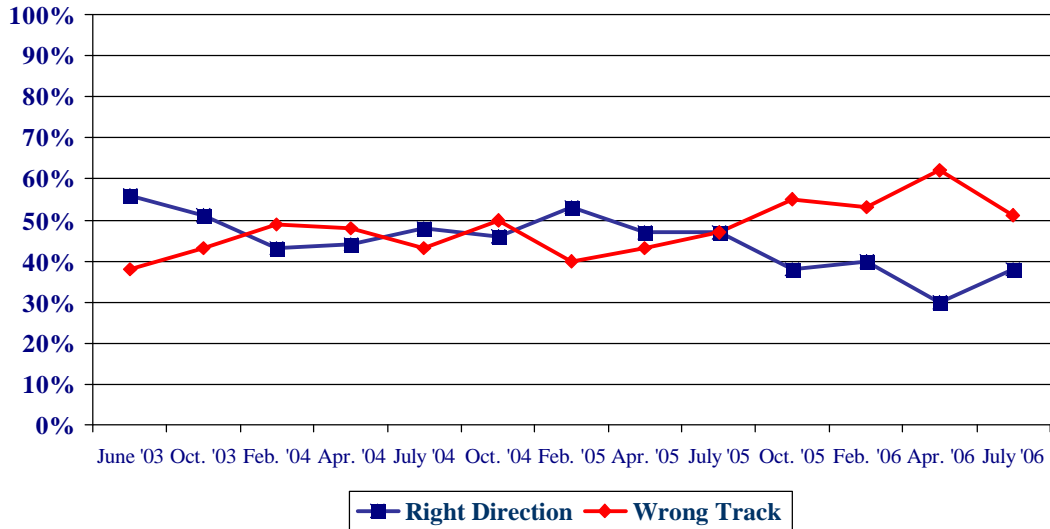
**Economic Approval Rating**  
 Even though the U.S. and New Hampshire economies are growing at a brisk pace, only 39 percent of New Hampshire residents say they approve of the job President Bush is doing handling the economy, 53 percent disapprove, and 5 percent are neutral. The percentage who approve of Bush's handling of the economy has also moved up, but remains quite low.



### Right Track – Wrong Track

New Hampshire residents are still quite concerned about the direction the U.S. is headed. Only 38 percent of New Hampshire residents think that things in this country are generally going in the right direction, 51 percent think things are seriously off on the wrong track, and 11 percent don't know. Democrats, liberal, and low income residents are most likely to say the country is off on the wrong track.

### Granite State Poll Methodology

These findings are based on the most recent Granite State Poll conducted by the University of New Hampshire Survey Center from July 21 and July 31, 2006. A random sample of 510 New Hampshire adults was interviewed by telephone. In 95 of 100 cases, the statewide estimates will be accurate to plus or minus 4.3 percent. Results reported for other subgroups have potential for somewhat larger variation than those for the entire population.

The data have been weighted to adjust for numbers of adults and telephone lines within households, respondent sex, and region of the state. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response.
