## SUNUNU'S JOB APPROVAL FALLS FROM ALL-TIME HIGH; BIPARTISAN OPTIMISM ABOUT NH OVERALL

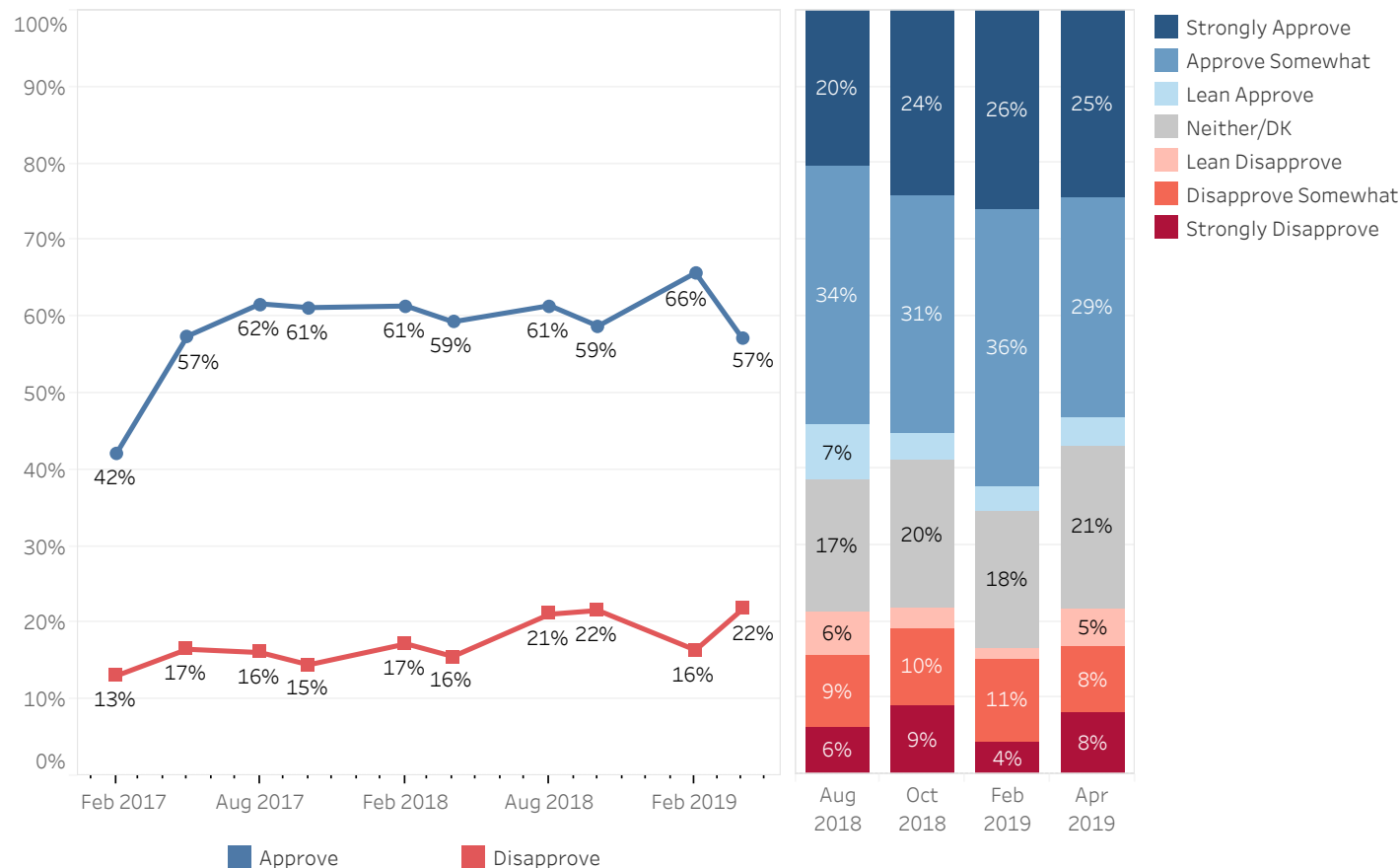
DURHAM, NH – Governor Chris Sununu's job approval has declined from an all-time high in February, but his approval mirrors that of his predecessor Maggie Hassan at the same point in her governorship. Only four in ten Democrats approve of Sununu's performance as Governor, but they are just as likely as Republicans to say the state is headed in the right direction. The percentage of Granite Staters who cite the drug crisis as the most important problem facing the state has fallen by nearly 20% over the past year.

These findings are based on the latest **Granite State Poll\***, conducted by the University of New Hampshire Survey Center. Five hundred forty-nine (549) randomly selected New Hampshire adults were interviewed in English by landline and cellular telephone between April 10 and April 18, 2019. The margin of sampling error for the survey is +/- 4.2 percent.

### Gubernatorial Approval

Fifty-seven percent of Granite Staters approve of Chris Sununu's performance as Governor, 22% disapprove, and 21% neither approve nor disapprove or don't know. Approval of Sununu (57%) has declined since February (66%) when it was at its highest point in Sununu's governorship.

#### Gubernatorial Approval - Chris Sununu

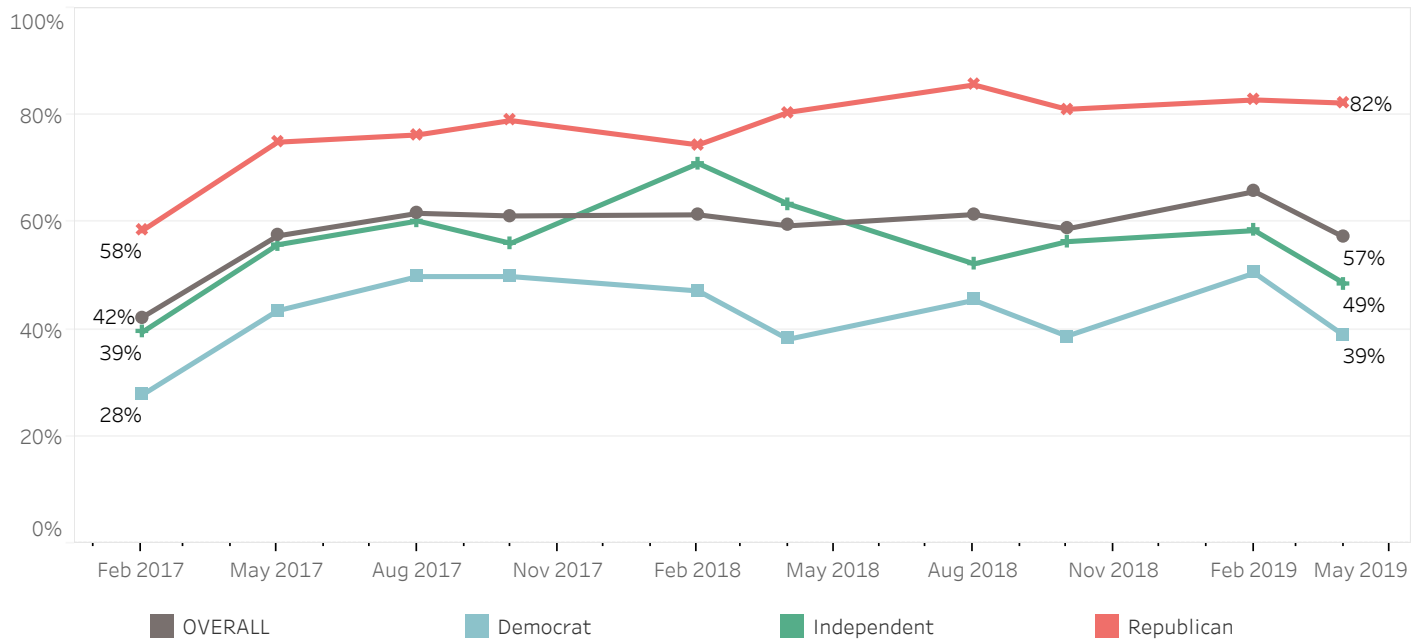

Eighty-two percent of New Hampshire Republicans approve of the job Sununu is doing while just under half (49%) of Independents and 39% of Democrats approve.

Conservative radio listeners, self-described conservatives, those who voted for Donald Trump in 2016, and those who attend religious services once a week or more often are most likely to approve of Sununu's job performance. Self-described liberals, those who voted for Hillary Clinton in 2016, and those aged 18 to 34 are least likely to approve. Approval of Sununu has fallen significantly since February among North Country and Central/Lakes Region residents, Clinton voters, those aged 65 and older, and college graduates.

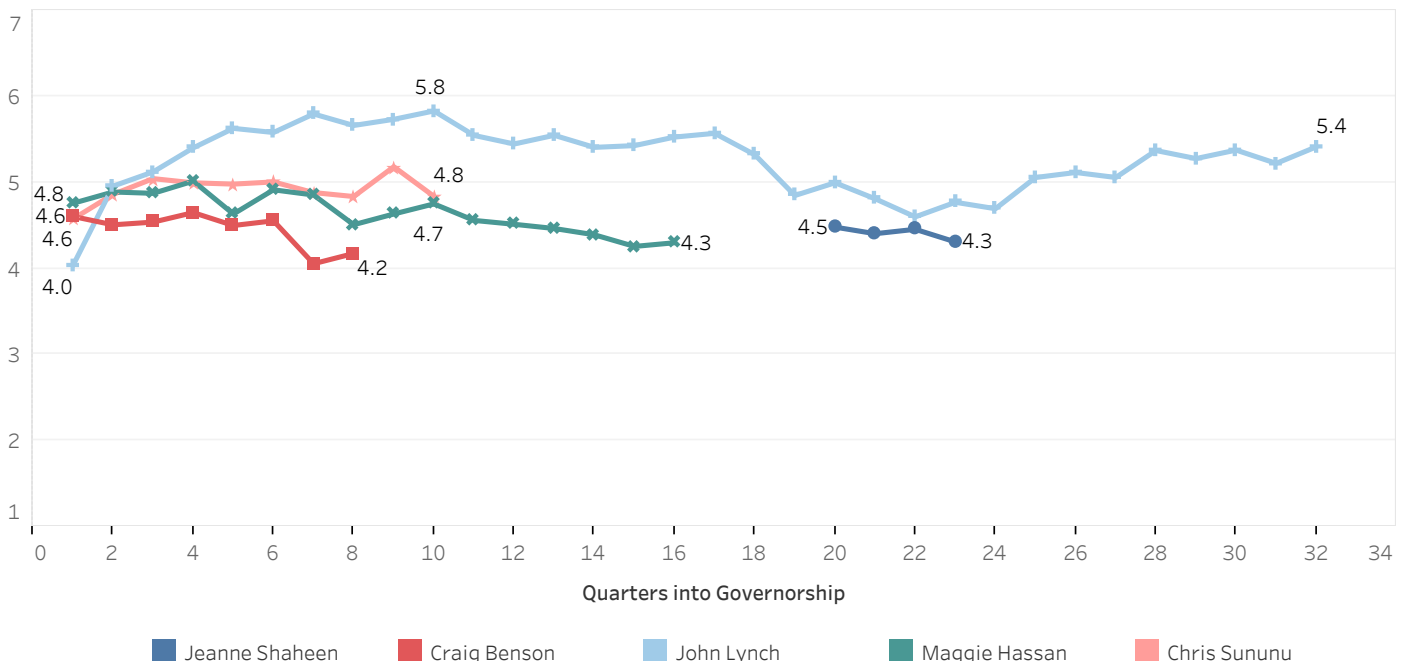
**Job Approval - Governor Chris Sununu - By Party Identification**



On a scale where "strongly approve" equals 7 and "strongly disapprove" equals 1, Sununu's average approval score (4.8) dipped since February (5.2) but matches Maggie Hassan (4.7) at the same point in her governorship. Sununu's score remains a good deal lower than John Lynch's level of support at the same point in his governorship (5.8).

(7=Strongly Approve, 1= Strongly Disapprove)

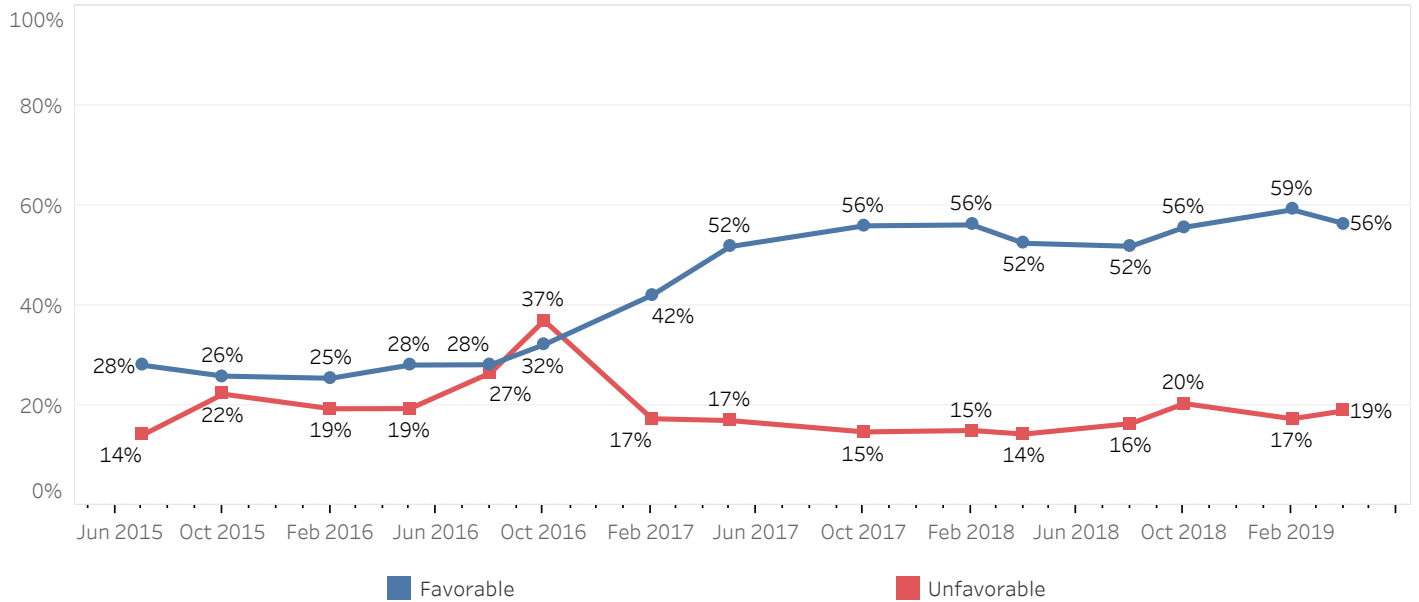


### Favorability Ratings - Governor Chris Sununu

While Sununu's job approval has dropped slightly, his personal favorability is unchanged; 56% say they have a favorable opinion of him, 19% have an unfavorable opinion, 15% are neutral, and 10% don't know or are unsure.

Conservative radio listeners, self-described conservatives, those who voted for Donald Trump in the 2016 election, those who attend religious services once a week or more often, those aged 65 and older, and those who watch WMUR are most likely to have a favorable opinion of Sununu. Self-described liberals and those who voted for Hillary Clinton in 2016 are least likely to have a favorable opinion of Sununu.

#### Favorability - Chris Sununu

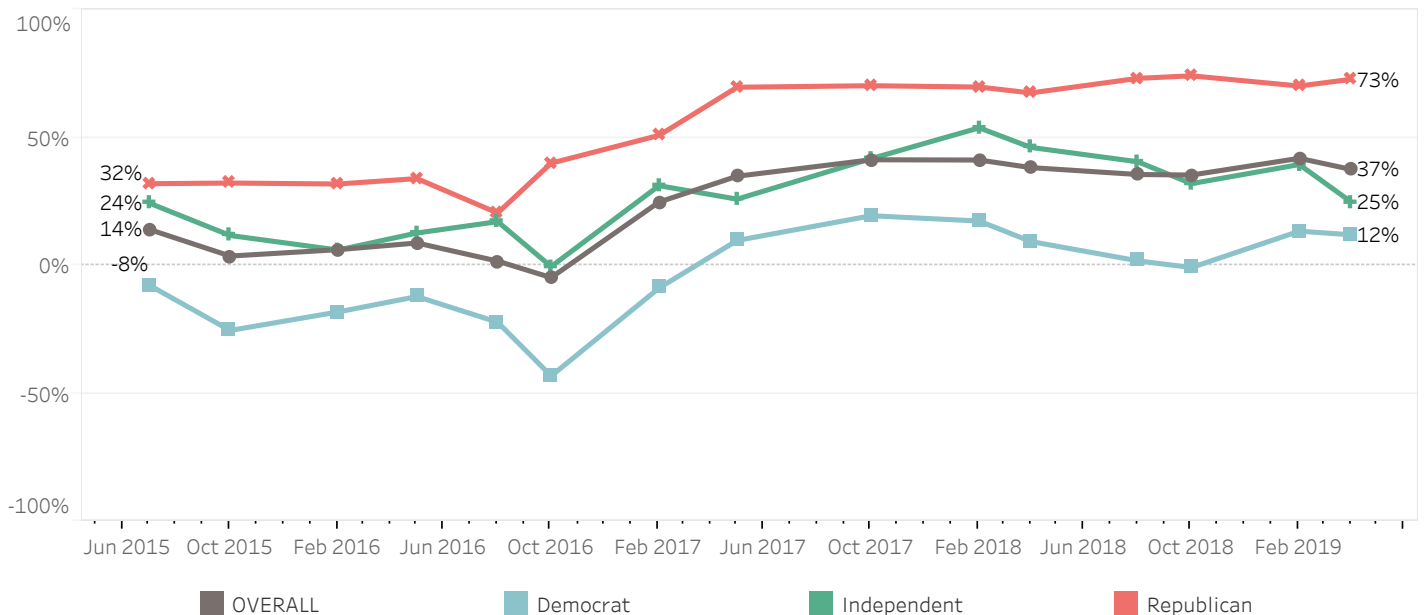


#### Net Favorability Rating - Governor Chris Sununu

Sununu's net favorability rating, the percentage of people who have a favorable opinion minus the percentage who have an unfavorable opinion, is +37%. His net favorability rating is +73% among Republicans, +25% among Independents, and +12% among Democrats.

Net Favorability = (% Favorable - % Unfavorable)

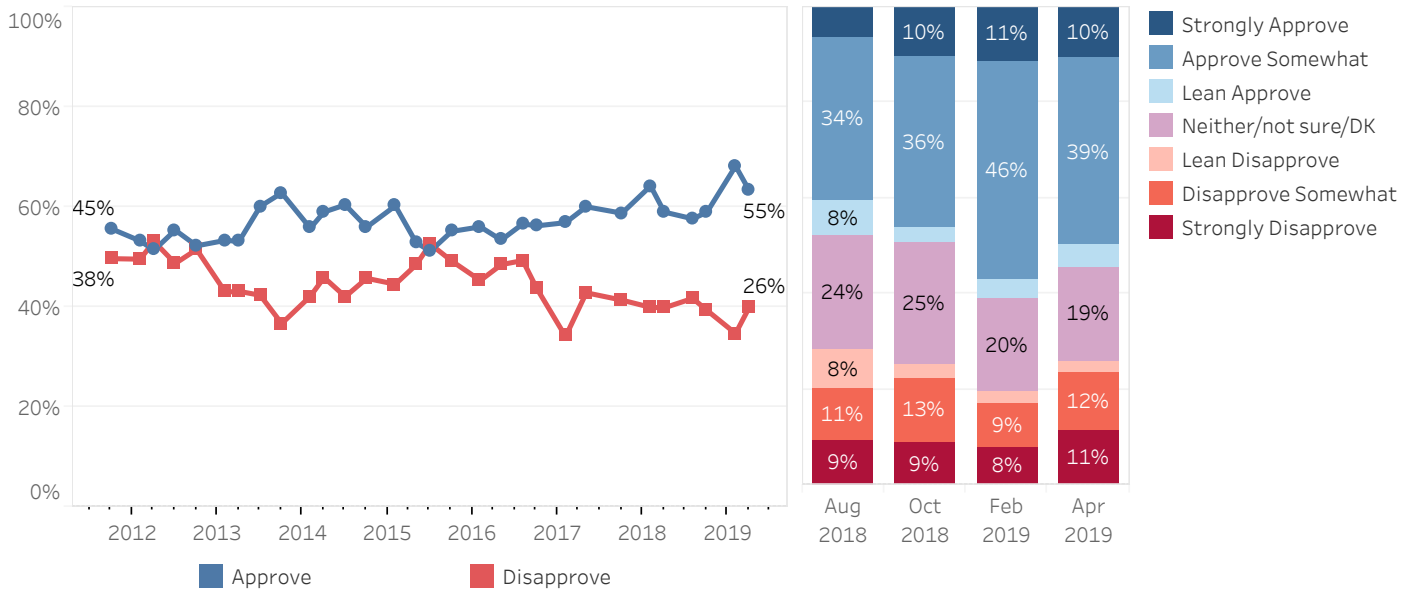


## NH Legislature

Just over half (55%) of Granite Staters approve of how the Democratic-controlled State Legislature is doing its job, a quarter (26%) disapprove, and 19% neither approve nor disapprove or are unsure.

Nearly two-thirds (65%) of Democrats approve of the job the legislature is doing, while half (50%) of Republicans and 41% of Independents agree.

### Legislature Approval

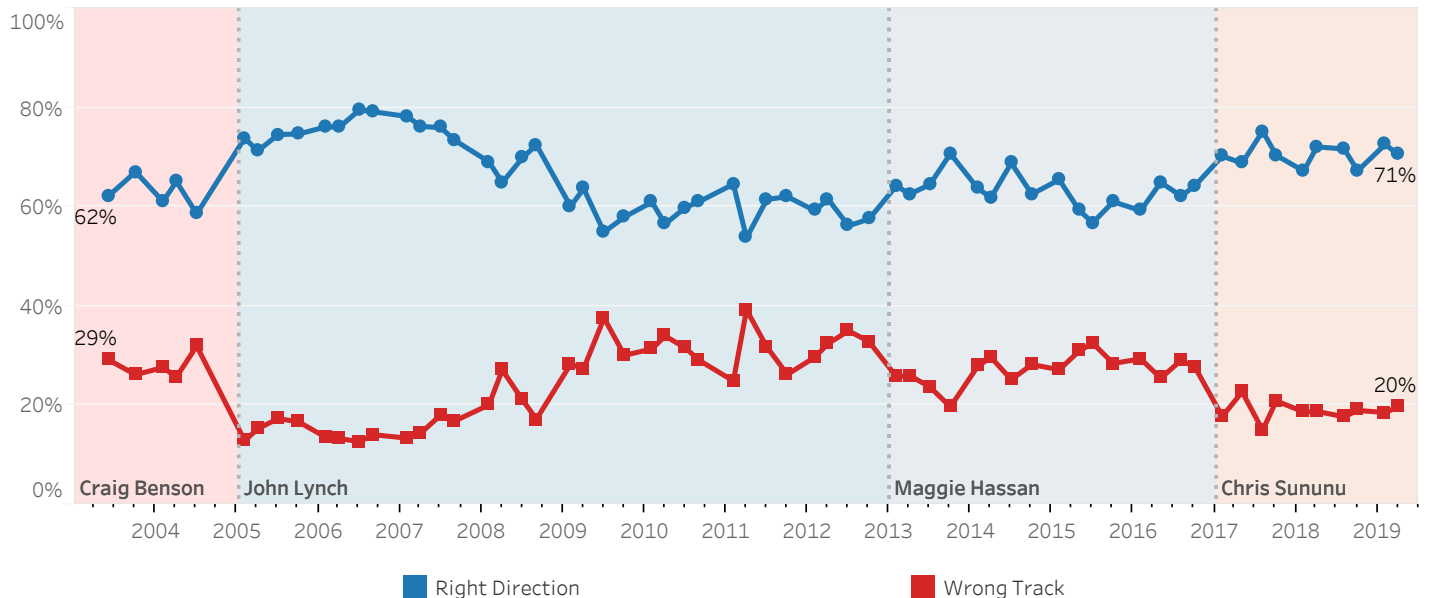


### NH Heading in Right Direction or On Wrong Track

Granite Staters continue to believe the state is headed in the right direction. Seventy-one percent of Granite Staters say things in NH are generally going in the right direction, while 20% say things are seriously off on the wrong track and 10% don't know or are unsure.

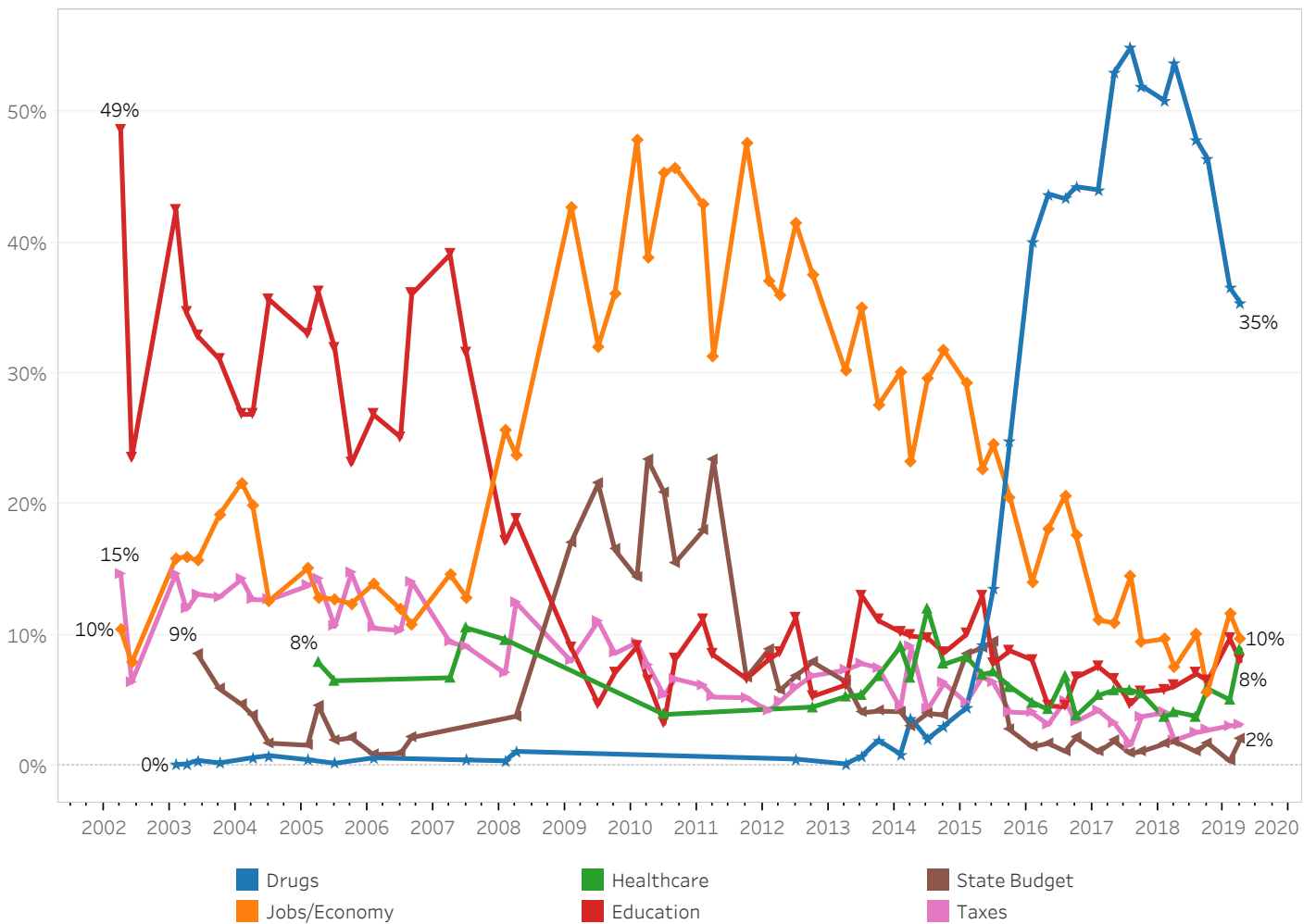
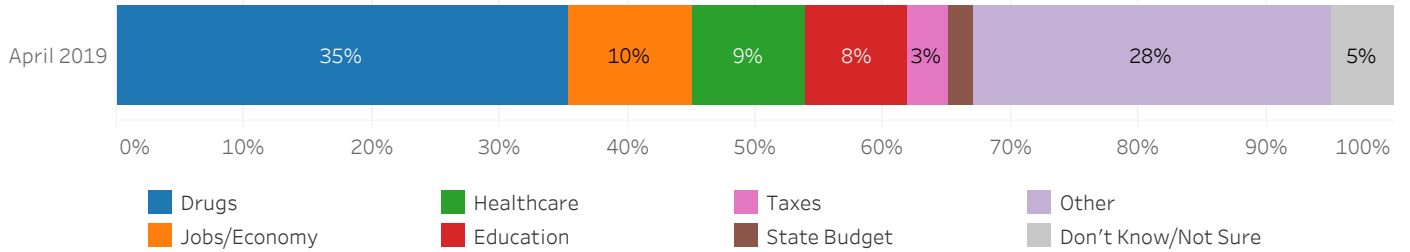
Optimism about the state's future is bipartisan: 73% of Democrats, 72% of Republicans, and 60% of Independents feel the state is headed in the right direction. Optimism among Democrats (73%) remains a good deal higher than in October 2018 (58%) and is nearly as high as it was during Maggie Hassan's governorship.

### Most Important Problem Facing New Hampshire

Concern over the drug crisis in New Hampshire continues to decline. Thirty-five percent of Granite Staters believe the drug crisis is the most important problem facing New Hampshire, largely unchanged since February (37%) but still considerably lower than a year ago (54%). Ten percent say that jobs or the economy is the most important problem facing the state, 9% mention healthcare, 8% cite education, 3% mention taxes, and 2% cite the state budget. Just over a quarter of respondents (28%) mention another problem while 5% don't know or are unsure.



### Granite State Poll Methodology

These findings are based on the latest Granite State Poll, conducted by the University of New Hampshire Survey Center. Five hundred forty-nine (549) randomly selected New Hampshire adults were interviewed in English by landline and cellular telephone between April 10 and April 18, 2019. The margin of sampling error for the survey is +/- 4.2 percent. These MSE's have not been adjusted for design effect. The design effect for the survey is 1.2%.

The random sample used in the Granite State Poll was purchased from Scientific Telephone Samples (STS), Rancho Santo Margarita, CA. STS screens each selected telephone number to eliminate non-working numbers, disconnected numbers, and business numbers to improve the efficiency of the sample, reducing the amount of time interviewers spend calling non-usable numbers. When a landline number is reached, the interviewer randomly selects a member of the household by asking to speak with the adult currently living in the household who has had the most recent birthday. This selection process ensures that every adult (18 years of age or older) in the household has an equal chance of being included in the survey.

The data have been weighted to adjust for numbers of adults and telephone lines within households. Additionally, data were weighted by respondent sex, age, education, and region of the state to targets from the most recent American Community Survey (ACS) conducted by the U.S. Census Bureau. In addition to potential sampling error, all surveys have other potential sources of non-sampling error including question order effects, question wording effects, and non-response. Due to rounding, percentages may not sum to 100%. The number of respondents in each demographic below may not equal the number reported in cross-tabulation tables as some respondents choose not to answer some questions.
