MORE THAN THREE-QUARTERS IN VERMONT THINK TRUMP HAS COMMITTED A CRIME BUT FEW PREDICT PRISON TIME


DURHAM, NH - Most Vermont residents believe that former President Donald Trump committed a crime in at least one of the cases currently against him and six in ten think he is likely to be convicted in at least one case. However, less than one-quarter foresee him spending time in prison. Pluralities of Vermonters believe that Hunter Biden has done something illegal and that he is receiving favorable treatment because he is Joe Biden's son.

Trump Investigations

Former President Donald Trump was recently indicted in a case concerning interference with the 2020 presidential election in Georgia. Over the past four months he has also been indicted in three other cases. Seventy-five percent think that Trump definitely (62%) or probably (12%) committed a crime in a case over the mishandling of classified documents, 24% believe he probably (4%) of definitely (20%) did not commit a crime in this case, and 1% are unsure. Just under three-quarters believe that Trump definitely or probably committed a crime in the cases alleging Trump tried to overturn the results of the 2020 election and aided the January 6th riot in Washington D.C. (73%), and illegally interfered with the 2020 presidential election in Georgia (73%). Seventy-one percent believe he made illegal "hush money" payments to adult movie actress Stormy Daniels late in his 2016 presidential campaign.

Overall, 76% of Vermonters believe that Trump committed a crime in at least one of the four cases, unchanged since April (74%). Almost all respondents say they have heard a lot or some about each of these cases.


Believe Trump Committed a Crime in Following Cases


Nearly all Democrats and majorities of Independents believe that Trump definitely or probably committed a crime in each of these cases, while less than one-third of Republicans believe Trump definitely or probably committed a crime in each of these cases. More than 99% of Democrats, 58% of Independents, and 34% of Republicans believe Trump committed a crime in at least one of these cases. The percentage of Republicans who believe Trump has committed at least one crime (34%) has increased since April (22%).

Believe Trump Definitely or Probably Committed a Crime in Following Cases - By Party ID - August 2023




Fifty-six percent of Vermonters believe that Trump is very (28%) or somewhat (28%) likely to be convicted in the case alleging interference in the 2020 election in Georgia, 38% think he is not very likely (18%) or not likely at all (20%) to be convicted in this case, and 6% are unsure. Majorities also believe that Trump will be convicted in the cases alleging Trump interfered in the 2020 election and aid to the January 6th riot (54%) and the case alleging he mishandled classified documents (52%), while less than half (43%) think he will be convicted in the case involving "hush money" payments. Vermont residents are less likely than in April (-15 percentage points) to think Trump is likely to be convicted in the case involving "hush money" payments in the 2016 election campaign but are slightly more likely than in April to believe Trump will be convicted in the case alleging he mishandling classified documents (+8).

Likelihood Trump Will Be Convicted in Following Cases




Overall, 61% of Vermonters believe that Trump will be convicted in at least one of these cases, down slightly since April (67%). More than three-quarters of Democrats (77%) believe that Trump will be convicted of at least one crime as a result of these cases but only 49% of Independents and 33% of Republicans agree. Democrats (-11 percentage points) are less likely than in April to think that Trump will be convicted in at least one case.

Believe Trump Will Be Convicted in at Least One Current Case - Change from April 2023 to August 2023 - by Selected Demographics




Overall, 57% of Vermont residents believe Trump committed at least one crime in these cases and will be convicted in at least one of these cases. Nineteen percent believe Trump committed a crime in at least one case, but will not be convicted in any of them, 4% believe he did not commit a crime in any of these cases but will be wrongfully convicted in at least one of them, and 19% think Trump did not commit a crime in any of these cases and will not be convicted in any of them. Most Democrats (77%) think Trump committed at least one crime and will be convicted as a result of at least one case, while a majority (52%) of Republicans think Trump did not commit a crime in any of the cases and will not be convicted as a result of any of them.

Combined Opinion on Trump Indictments




Only 22% of Vermont residents believe that Trump is very (6%) or somewhat (17%) likely to spend time in prison as a result of the current cases against him. Seventy-one percent think it is not very likely (33%) or not at all likely (38%) that this will happen while 7% are unsure. Among those who think Trump will be convicted of at least one crime (N=287), only 30% think it is very (7%) or somewhat (23%) likely that he will spend at least one day in jail.

More than three-quarters (76%) of Vermonters believe that Joe Biden won the 2020 presidential election, 20% think that Donald Trump won the 2020 election, and 4% are unsure. Nearly all (97%) of those who voted for Biden believe that he won the election. Sixty-five percent of those who voted for Trump claim that he won the election while only 29% think Biden won and 6% are unsure. Most (78%) who voted for another candidate or did not vote in 2020 believe that Biden won the election.

Who Believe Won 2020 Presidential Election - By 2020 Vote




Hunter Biden Investigation

The House Oversight and Accountability Committee has been conducting an investigation into Hunter Biden's former business dealings. Only 40% of Vermonters say they have heard a lot about this investigation, 41% have heard some about it, 12% say they have not heard very much, and 7% have heard nothing at all about it.


Based on what they have heard about the investigation, 48% of Vermonters believe that Hunter Biden has done something illegal, 36% believe he has done something unethical but not illegal, 3% think he has done nothing wrong, and 13% are unsure. Only 23% of Democrats think that Hunter Biden has done something illegal while a majority of Independents (54%) and the vast majority of Republicans (92%) think he has done something illegal.

Forty-six percent of Vermonters think that Hunter Biden is definitely (31%) or probably (15%) receiving favorable treatment from U.S. prosecutors because he is Joe Biden's son. Thirty-eight percent think that Hunter Biden is probably not (22%) or definitely not (15%) receiving favorable treatment while 16% are unsure. More than nine in ten Republicans (92%) and a majority of Independents (52%) believe that Hunter Biden is receiving favorable treatment but only 21% of Democrats agree.

Green Mountain State Poll Methodology

These findings are based on the latest Green Mountain State Poll, conducted by the University of New Hampshire Survey Center. Four hundred seventy-one (471) Green Mountain State Panel members completed the survey online between August 17 and August 21, 2023. The margin of sampling error for the survey is +/- 4.5 percent. These MSE's have not been adjusted for design effect. The response rate for the August 2023 Green Mountain State Poll is 17%. The design effect for the survey is 2.3%.

Data were weighted by respondent sex, age, education, and region of the state to targets from the most recent American Community Survey (ACS) conducted by the U.S. Census Bureau, as well as to 2020 election results in Vermont.

The Green Mountain State Panel is part of an effort by the University of New Hampshire Survey Center to investigate new ways of gathering and understanding the opinion of Vermont residents. Approximately 3,000 Vermont adults have been recruited from randomly-selected landline and cell phone numbers to participate in the panel. Panelists are then asked to participate in online surveys sponsored by the UNH Survey Center.

The number of respondents in each demographic below may not equal the number reported in cross-tabulation tables as some respondents choose not to answer some questions. Due to rounding, percentages may not sum to 100%.
