



## 4-H and Youth Animal Show Entry Information for the 2022 Hopkinton State Fair (For youth ages 8-18)

### **Current 4-H member animal show entry instructions:**

1. **Register for the animal show with Fair Entry** (<https://hsfairexhibitors.fairentry.com/Fair/SignIn/17434>) log-in with your 4-HOnline credentials - email & password for your 4HOnline account.

### **Non 4-H member animal show entry instructions:** Follow these steps to become a 4-Her for the fair.

1. **Create an account with 4-HOnline** (<https://v2.4honline.com/#/user/sign-up>) **and enroll youth (ages 8-18).** See instructions below!
  - *4-H & Youth Show Exhibitors do not need to be affiliated with a 4-H club to participate, and there is no commitment beyond the 2022 Hopkinton State Fair.*
2. **Register for the animal show with Fair Entry** (<https://hsfairexhibitors.fairentry.com/Fair/SignIn/17434>) log-in with your 4-HOnline credentials you created (email & password you just used to create your 4HOnline account).

### **Why do you need to enroll with 4-H?**

By enrolling with 4-H, you are covered under the University System of New Hampshire's liability **insurance policy**. This insurance fulfills the Hopkinton State Fair exhibitor insurance criteria for 4-H shows and exhibitions. This is required by both the HSF and NH 4-H Program for youth who want to partake in 4-H and Youth Animal Shows.

### **4HOnline Enrollment Instruction for New Families:**

1. Select State: "New Hampshire".
2. Select an Institution: "New Hampshire Youth Development Program".
3. Select County: "Merrimack".
4. Create your Account: email, last name, phone, and create a password for your account.
5. Select County: "Merrimack".
6. Enter your mailing address.
7. Add member – select "4-H" and click "next".
8. Enter Youth "Profile" Information: First Name, Last Name & Birth Date – click "next" when completed.
9. Enter Youth "About You" Information: Gender, School Grade, Demographics, & Emergency Contact Information– click "next" when completed.
10. Select "Participation" – "I want to join 4-H as a New or Returning 4-H Club Member." then click "finish". **\*This does not commit you to joining 4-H outside of the Hopkinton State Fair.\***
11. Click blue "Select Clubs" button. Add "Merrimack County Independent Members". Click the blue "next" button.

12. Click the blue “Select Projects” button. Select the species of animal you will be showing at the fair. Repeat this step if you would like to add more than one species to your project list. Click the blue “next” button when done.
13. Click the blue “Show Questions” button. Review previously entered information. Fill in the missing required information. Click the blue “Next” button at the bottom of the page once completed.
14. Click the blue “Show Health Form” button. Fill out the health form to the best of your knowledge and select the agree button and sign the form. Click the blue “next” button when complete.
15. Click the blue “Show Consents” button. Read and sign the consents. Click the blue “next” button when complete.
16. Confirm your enrollment. Click the green “Submit”. You are now registered with 4HOnline and will be covered through the 4-H insurance to exhibit an animal at the 2022 Hopkinton State Fair.
17. **NEXT go to the Hopkinton State Fair Website (<https://www.hsfairexhibitors.org/>) and select the show you want to participate in and click the green “Submit Entry” button. Use your newly created 4HOnline credentials and register for the animal show.**
